Executive Summary

This handbook serves as a guide to the applications, technologies, business models, and regulations that should be considered when evaluating the feasibility of a microgrid system to enhance power supply quality and connectivity. This handbook is meant to be a go-to guide for several key aspects of understanding microgrids—particularly on-grid microgrids for urban and industrial applications in the context of current technological pathways and power system structures in the Asian Development Bank (ADB) developing member countries (DMCs) and developed countries. Prevailing business models and emerging trends that can shape the future of this sector were also taken into consideration.

Microgrids refer to grid-connected setups of varying scale that can be islanded at will, established primarily for local reliability, resilience, and operational economics. A microgrid is a localized group of interconnected loads and distributed energy resources within clearly defined electrical boundaries (e.g., cities, communities, campuses) that act as a single controllable entity with respect to the main regional or national electric grid (macrogrid). A related setup called minigrid uses similar technology and components. Minigrids have been referred to interchangeably with microgrids partly because of their proliferation, but they are actually a distinct subset of microgrids. Minigrids are isolated, small-scale distribution networks. They are essentially a microgrid disconnected from larger electric grids, which provide power to a localized group of customers and produce electricity from small generators, often coupled with energy storage systems. Currently, majority of the world's microgrids are in the North America and the Asia and Pacific region, with most of the capacity in the Asia and Pacific region being in the People's Republic of China and Japan.

In the context of grid-connected microgrids, there are traditionally three core value propositions to the end user, although the exact combination of value drivers varies from case to case—access to electricity (social), fuel and cost savings (economic), and emission reductions (environmental). Additionally, fuel independence and uninterrupted supply and/or reliability (operational) are important value propositions too. The total value of a microgrid, hence, encompasses its power generation savings, grid services, reliability and resilience, and environmental benefits and value to the distribution grid.

Nevertheless, grid-connected microgrids have not yet achieved significant scale, mainly due to the following barriers: (i) limited number of scalable prototypes, and lack of translatable performance metrics; (ii) limited experience in scalable microgrid financing models; (iii) regulatory bottlenecks arising out of restrictions on utility franchise rights and retail market access; (iv) cybersecurity concerns and limited technical standards and interconnection protocols; and (v) technical and operational challenges such as power quality, control architecture, grid synchronization and stability, and energy management.

Microgrid projects in developing countries (including ADB DMCs) can provide gains and benefits beyond solely the energy access benefit that remote off-grid minigrids provide. A key benefit that is often overlooked by policy makers is the collateral benefit of reliability and resilience of electricity supply that grid-connected microgrids, especially

commercial and industrial microgrids, can provide. This is especially important as a disaster resilience strategy in several ADB DMCs, particularly in the context of increased risk of natural disasters due to climate change.

The selection of the combination of microgrid equipment is based on the key attribute that microgrids must have the ability to maintain a balance between available supply and desirable load demand through careful marriage of supply and demand combined with intelligent control. Thus, the main components of a microgrid are (i) local generation, (ii) end-use loads and demand-side energy management, (iii) energy storage, (iv) microgrid monitoring and control system, (v) utility interconnection, and (vi) other components like power electronics and protection.

In terms of design architecture, microgrids can be classified in two ways—by their control approach, and by their power technology. Under the control approach, there can be centralized and decentralized management systems based on number of entities responsible for decision-making processes and single point of failure. Under power technology, the microgrid systems can be alternating current, direct current or hybrid systems.

From a project management perspective, the conceptualization, evaluation, design, construction, and commissioning of a microgrid follows the same broad stages as other infrastructure projects with similar stakeholders. In the case of an existing facility or brownfield microgrid, the pre-project evaluation begins with the assessment of current situation, followed by high-level assessment for both brownfield and greenfield projects. The subsequent project feasibility study should typically consider applicable policy and regulatory framework, renewable energy resource assessment, assessment of site conditions and site selection, technical viability, financial viability, and financing structure.

The business models employed for grid-connected microgrids (including technology, financing, stakeholders) to meet relevant pricing options and financing implications can be: (i) customer-owned (up-front capital investment), (ii) renewable energy service company (RESCO)-owned, (iii) utility-owned, (iv) cooperative-owned, (v) community-owned, (vi) pay-as-you-go (typically rural remote minigrids), and (vii) remote (off-grid).

The choice of business model, through which the microgrid asset is built, operated, and maintained, is an important pre-development consideration irrespective of technology choice. Business model choices are typically between up-front capital investment model and RESCO model. Within the RESCO model, variations exist, such as build-own-operate, build-own-operate-transfer, lease-to-own, and power purchase agreement models.

A financial and economic analysis of microgrids requires a study of their benefits and costs to the microgrid owner or operator, the utility or distribution network operator, and/or the end user. Microgrid value is typically shared among utilities, end users, third parties, or co-owners depending on the ownership and operating model. Financial analysis of different kinds of business models are conducted using a combination of these various methodologies—net present value, financial internal rate of return, and sensitivity analysis.

Some of the key policy and regulatory enablers for urban and/or industrial microgrids in ADB DMCs would potentially include:

- (i) specific urban and/or industrial microgrid policies at national and/or provincial levels,
- (ii) net metering or gross metering policies,
- (iii) technical standards and specifications for grid interconnection,
- (iv) open access or contestable consumer policies, and
- (v) financial risk-sharing mechanisms for debt financing.

The following four case studies of grid-connected microgrids have been featured in this handbook, primarily from a business model and economics standpoint:

- (i) Case study 1: Weymouth Water Treatment Plant in La Verne, California, United States
- (ii) Case study 2: 750 kilowatt (kW) ABB Microgrid Longmeadow Park in Johannesburg, South Africa
- (iii) Case study 3: Dawanshan Island Microgrid in the People's Republic of China
- (iv) Case study 4: 500 kW Microgrid at Nagoya Landfill, Japan.

Microgrids are poised to play a big role in the electricity ecosystem of the future with decarbonization, digitalization, decentralization (3D), and non-wires solutions being its key attributes. They could help address today's energy challenges, including an optimized way to access reliable, resilient, clean energy that can defer or replace the need for specific equipment upgrades, such as new transmission lines or transformers, by reducing the load at substation or circuit level. While there is also a case for continued addition of transmission line capacity, particularly in the context of high-level penetration of renewable energy (which are almost always intermittent) to be the backbone of our electricity system, we also need to consider that (i) good solar wind resource are often at different locations, (ii) generating electricity from renewables requires a lot of land and such land availability tends to be further away from population and load centers, and (iii) electrification of transport sector would likely require additional transmission capacity. However, as a holistic strategy, if the intent is to increase the level of renewable energy penetration in the grid, then adding transmission capacity needs to be considered in the context of, and as a complement to, grid edge investments in distribution networks and microgrids.

Microgrids also hold key relevance to the transportation sector, which as a whole consumes over 30% of primary energy. Electrifying only a small percentage of this in the coming years would translate to significant capacity. A decentralized infrastructure will allow the many actors in the electric vehicle (EV) ecosystem to capitalize on the flexibility of EVs—one promising way to do this being “vehicle-to-grid” (V2G), wherein EVs can sell demand-response (DR) services to the power grid.

Microgrids are quite relevant to the current power system situation in ADB DMCs. In general, power consuming end users in developing countries typically do not have access to high-quality reliable power and must contend with frequent power outages, in contrast to their counterparts in developed countries. Developing countries also often have weak grid infrastructure due to under-investment and poor management, leading to high power losses and theft, thereby hindering the success of business and industry. This is the value proposition of grid-connected microgrids in developing countries. Furthermore, grid-connected microgrids are the building blocks of smart grids and smart supergrids, which have the potential to help developing countries leapfrog.

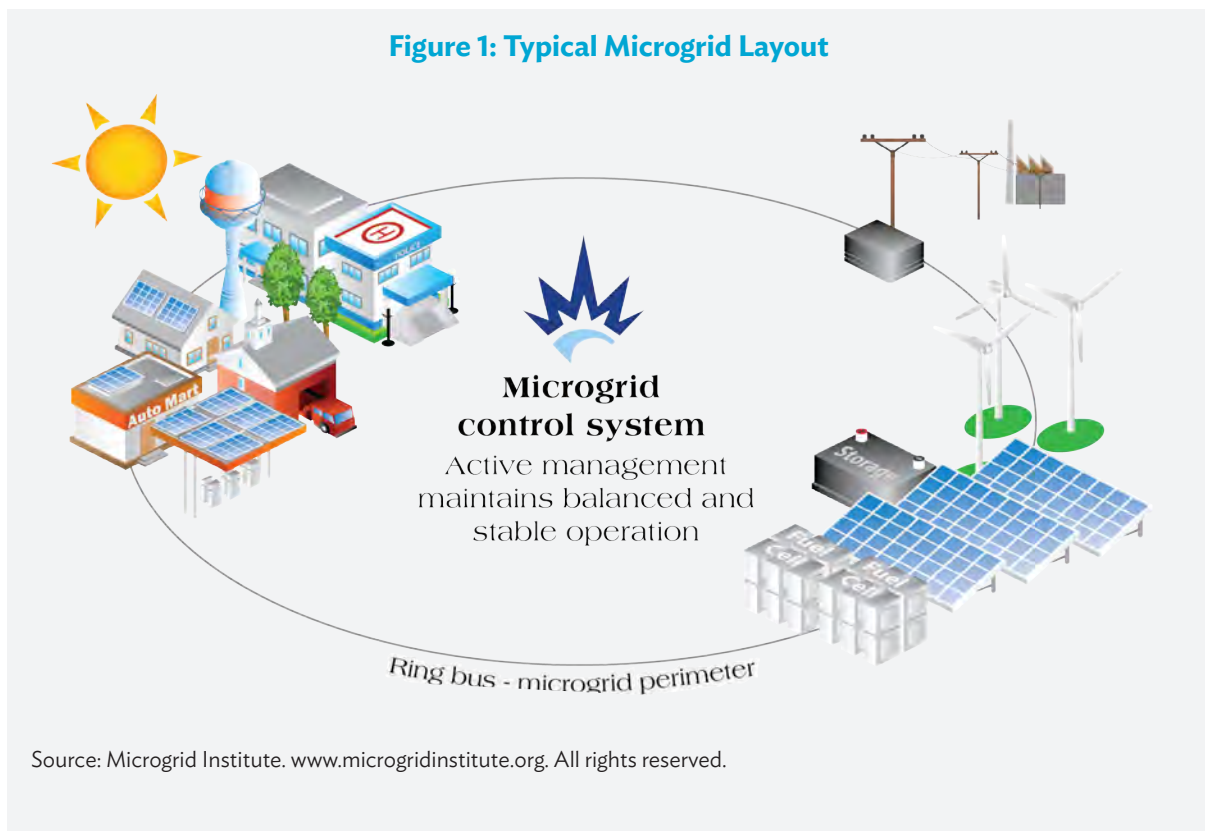
The handbook briefly explores current power systems and potential drivers of microgrid deployment in these ADB DMCs: Bangladesh, India, Myanmar, Nepal, the Philippines, and Thailand. South Asia, in particular, suffers from the dual problems of second largest off-grid population in the world (next to only Sub-Saharan Africa) and relatively low quality of power supply. Approaches to promote grid-connected microgrids and replication guidance are also provided. From a policy and regulatory standpoint, governments and policy makers in ADB DMCs should aim to include microgrids (both on-grid and off-grid) in their power system planning and design. Specific policies and regulations to clarify microgrid as a distinct power asset class and their technical standards in terms of grid interconnection would go a long way in incentivizing microgrid investments. Clarity on tariffs, licensing, and permitting for microgrids would also be beneficial, while targeted concessional lines of credit and financial risk-sharing facilities from development finance institutions such as ADB would help increase access to finance for microgrids in ADB DMCs.

Smart grids are evolving because of the increased proliferation of distributed energy resources, demand-side management, energy storage, and decentralized networks such as microgrids. There is significant potential for cost, efficiency, and resource utilization improvements by enabling market-based transactions between energy producers and consumers. Some of these transactive energy arrangements can be based on peer-to-peer energy trading and blockchain technologies. Smart grid is an important application of Internet of Things, which, along with data analytics and artificial intelligence, may have benefits for microgrid capabilities and techno-commercial viability.

1 Microgrid Technologies

1.1 Overview

A microgrid is a localized group of interconnected loads¹ and distributed energy resources (DERs) within clearly defined electrical boundaries (e.g., cities, communities, campuses that act as a single controllable entity with respect to the main regional or national electric grid [macrogrid]). A microgrid can connect or disconnect from the main grid as physical and/or economic conditions dictate. It can operate on both grid-connected mode (synchronous with the grid), or on island mode (functioning autonomously and disconnected from the main electric grid).² A typical microgrid layout is shown in Figure 1.

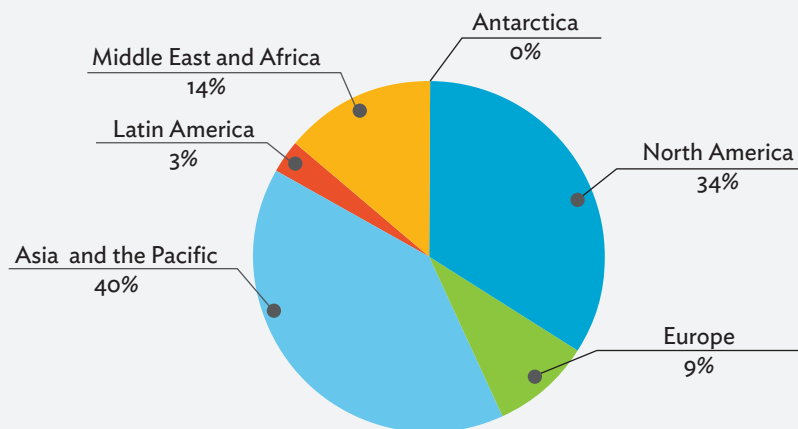
Microgrids have been described as a “novel distribution network architecture within the broader smart grids³ concept, which is capable of more fully exploiting the full range of benefits accruing from the integration of large numbers of small-scale DERs into relatively low-voltage electricity distribution systems.” (Lawrence Berkeley National Laboratory [LBNL] 2019).

A related setup called minigrid uses similar technology and components, and has often been used interchangeably with microgrids. Minigrids are isolated, small-scale distribution networks—essentially a microgrid disconnected from larger electric grids. Minigrids typically operate below 11 kilovolts (kV), have a power rating below 15 megawatts (MW), provide power to a localized group of customers, and produce electricity from small generators, often coupled with energy storage systems.⁴ A larger number of such minigrids that is a distinct subset—in application and business model—of the broader microgrids often cause the two terminologies to be interchanged. Minigrids are frequently set up as a cost-effective way to electrify rural communities with low population densities, or for remote facilities where laying transmission lines to connect to the grid is difficult and expensive due to topography or distance.

Microgrids, in a more specific sense of the term, refer to grid-connected setups of varying scale that can be “islanded” at will, and established primarily for local reliability, resilience, and operational economics. Islanding is a condition in which distributed generators (DG) continue to provide power in a location even without the continued presence of electrical grid power. This handbook focuses on these islandable microgrids.

Currently, majority of the world’s microgrids are in the North America and the Asia and Pacific region (Figure 2), with most of the capacity in the Asia and Pacific region coming from the People’s Republic of China (PRC). While there is no central registry, a semiannual tracker⁵ estimates 1,869 microgrids with total capacity of 20.7 gigawatts

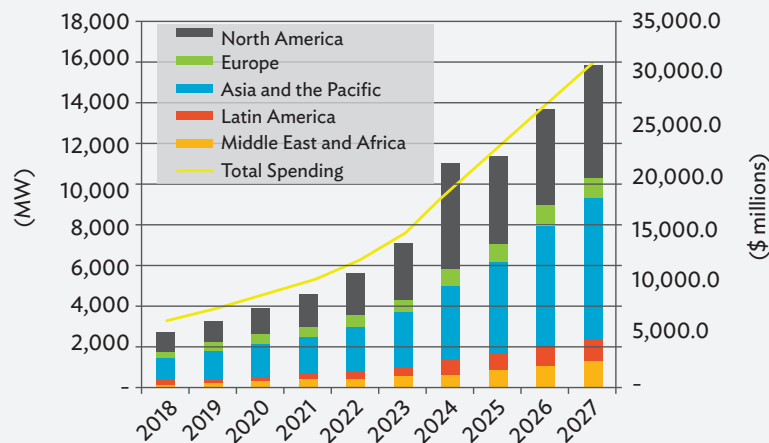

(GW) as of the fourth quarter of 2017. In the coming years, microgrids are expected to see a significant growth worldwide, particularly in the Asia and Pacific region and North America, with annual capacity installation and spending expected to increase approximately five times from 2018 to 2027 (Figure 3). This will require increased financing from various sources and instruments including from private and government sources.

Figure 3: Annual Microgrid Capacity and Spending, Base Scenario 2018–2027



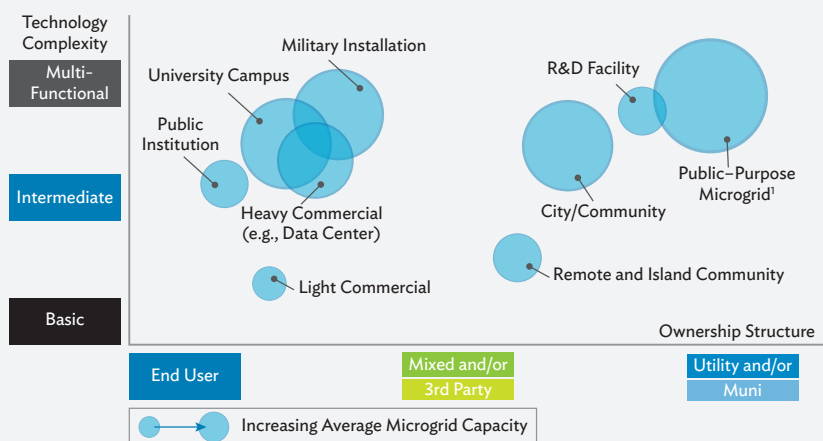

1.2 Applications and Configurations

Microgrid configurations depend on their application, and have varying degrees of technological complexity and ownership structure.

Figure 4: Microgrids Classified by Technology Complexity and Ownership Structure



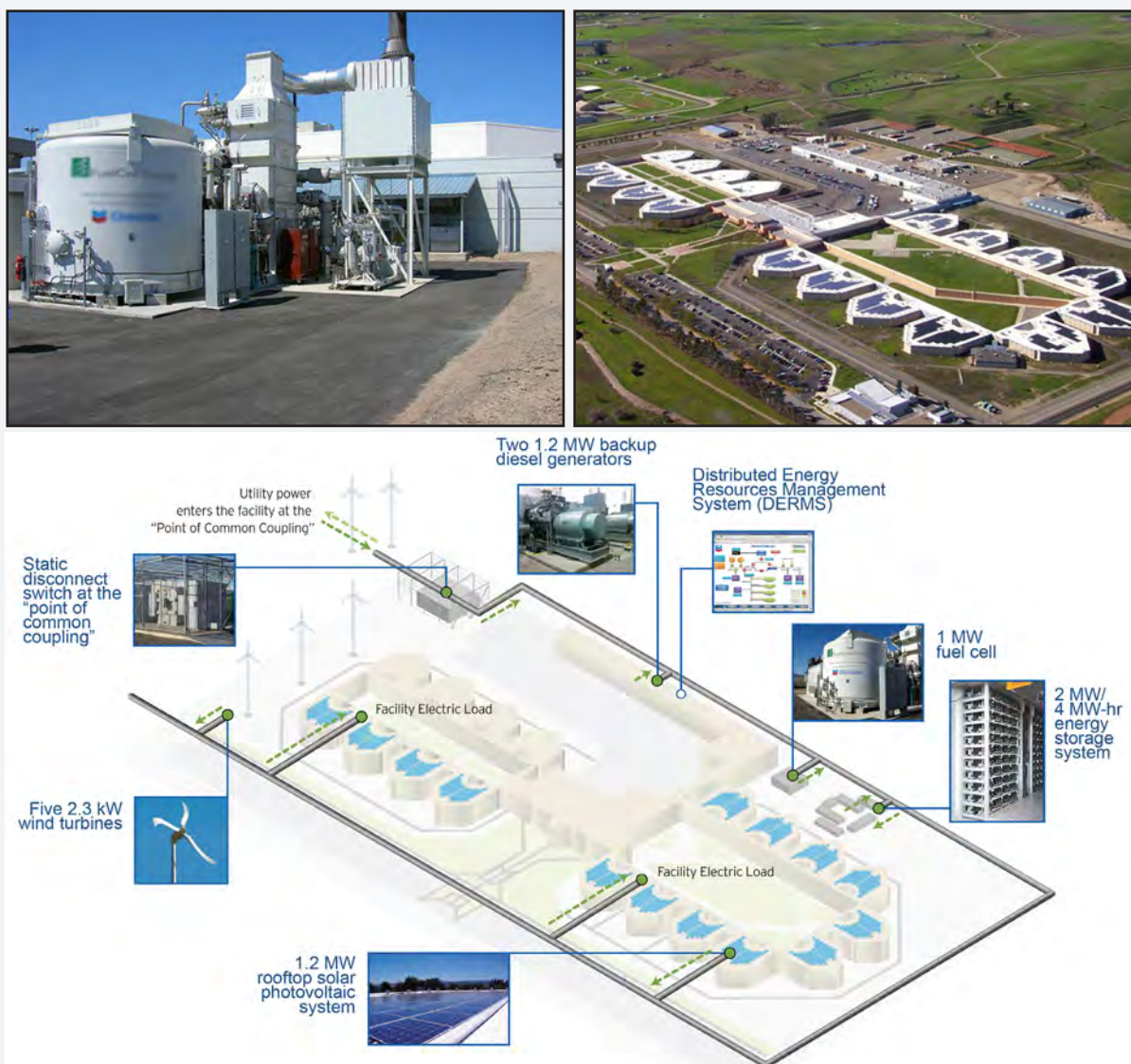
R&D = research and development.

The key categories in Figure 4 can be classified under five headings, which include:

- (1) **Commercial and Industrial Microgrids.** These are either commercial centers or manufacturing zones with critical loads. These microgrids are often multi-owner, driven primarily by security and affordability, and are expected to grow substantially in the coming years. They are built with the goal of reducing demand and costs during normal operation. The operation of critical functions during outages is also important, especially for 24/7 high availability, high-reliability applications. One such example is the Santa Rita Jail, which houses 4,500 inmates on a 0.5 square kilometer (km²) site. Microgrid elements were gradually added from 2004 onwards to bring it to its configuration as of 2012, driven mainly out of energy security and affordability considerations.

Figure 5: Santa Rita Jail Microgrid

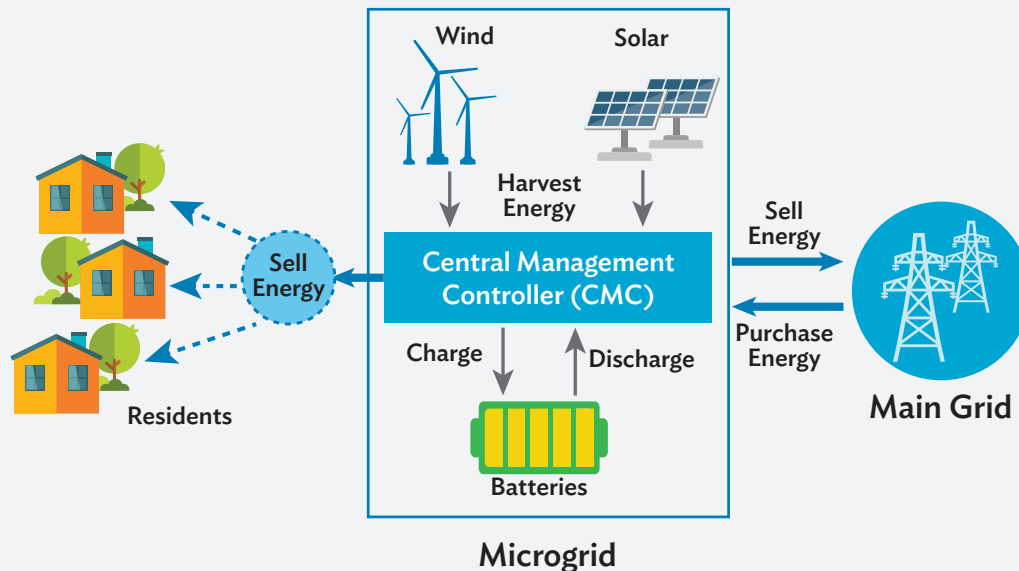

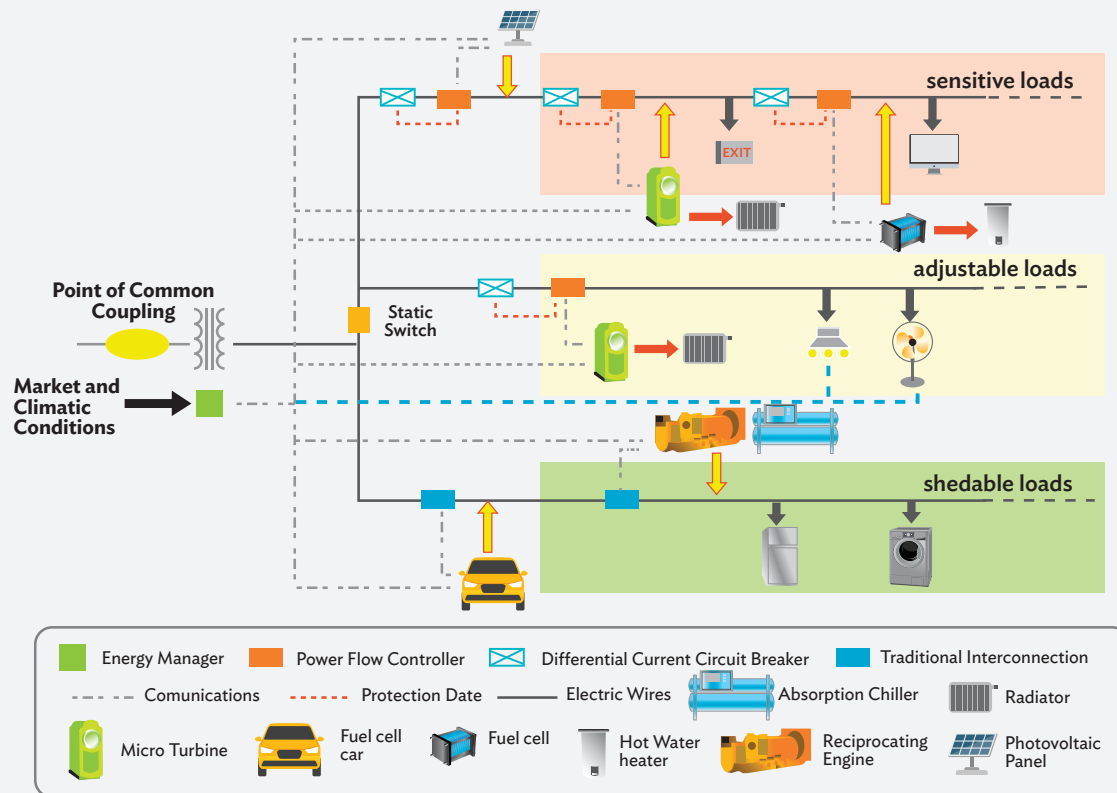
Figure 6: Overview of Operations of a Typical Utility Microgrid

- (2) **Community, City, Utility Microgrids.** These are aimed toward improving the reliability for critical infrastructure, deferred asset investment, achievement of emissions and clean energy targets, and to foster community engagement. It comprises primarily residential customers and is driven mainly by the needs of affordability and security (Figure 6). However, there are impediments to their attaining widespread commercial traction until additional standards are in place and certain regulatory barriers removed.

- (3) **Campus and Public Institutional Microgrids.** These have the advantage of a common ownership structure, offer good near-term development opportunity, and is a segment with the potential to develop sophisticated advanced microgrids. For instance, these microgrids accounted for 40% of the United States' pipeline of microgrids, adding 940 MW of new capacity valued at \$2.76 billion by 2015 (Devi and Babu 2017). Broadly, these could target either:

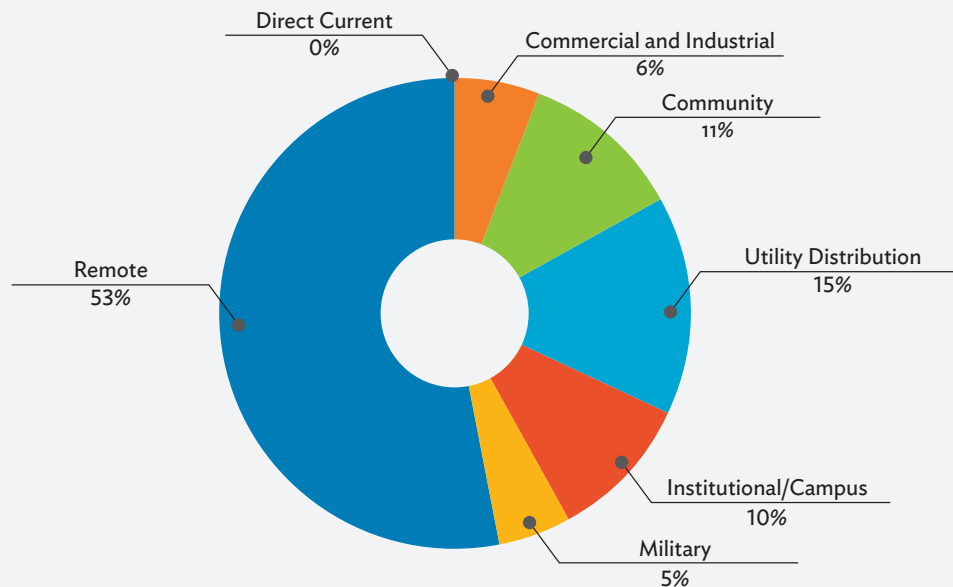
Figure 7: Layout of a Typical Campus Microgrid

- (i) Research laboratories and campus housing, which comprise large heating and cooling demands with good cost reduction opportunity and potential to reduce emissions. They are usually large areas and may also double up to function as emergency shelters during extreme events such as cyclones, forest fires, and earthquakes. Combined heat and power (CHP)-based district energy solutions are often attractive in these cases because of the location's requirement of uninterrupted electrical as well as thermal service. Many campuses already have distributed generation resources and controllable loads, so microgrid technology can be overlaid to link them together to harness the additional benefit of the ability to sell excess power back to the grid (Figure 7).
 - (ii) Public health and safety facilities such as hospitals, police stations, fire stations, wastewater treatment plants, schools, and public transit systems, to improve reliability and lower energy consumption and cost.

- (4) **Mission-Critical Microgrids.** These are currently the smallest market segment, but are starting to pick up. These are typically seen in mission-critical applications like data centers, hospitals, laboratories, and military bases where energy security (reliability and resiliency) is the principal driver. Military microgrids focus on high reliability for mission-critical loads, strong cybersecurity and physical security requirement, “non-operationally ready” energy cost reduction, and greenhouse gas emission reduction goals at the operating bases. They make a strong case for integrating distributed renewable energy generation, so they can secure power supply without depending on the grid or any supplied fuel.
- (5) **Rural and Remote Microgrids.** This is one of the most common types of setups today. This segment accounts for the largest number of microgrids operating currently (Figure 8), but has the smallest average size. Remote microgrid communities are typically connected to the rural distribution system in weak grid areas where it is prohibitive to bring in new transmission lines for backup due to distance, cost, or physical barriers, such as in mountainous or remote communities. The main benefits of these microgrids include reliable energy supply and integration of low carbon renewable energy, such as biomass, solar photovoltaic (PV), and wind power to minimize fuel dependency. Thus, pollution and energy costs are minimized. Many have existing diesel generation, and it is expected to continue to be a market segment driven by solar PV deployment, with small wind and mini and micro-hydro also projected to play a growing role. As they become larger, these remote microgrids start to experience operational constraints that can be alleviated by microgrid management and optimization techniques. Minigrids, which typically serve off-grid areas (as opposed to “weak grid” areas referred to in this category) are a subset of this.

1.3 Benefits and Barriers

1.3.1 General Benefits

As mentioned in the previous section, most of the microgrids in the world today are actually minigrids for remote service, and serve consumers and loads in nonutility or non-grid connected areas, such as remote islands and communities. In these applications, the microgrid needs to provide a scaled-down version of services that the traditional electric utility would typically do. However, in terms of the fast-expanding, grid-connected segment, which is the focus of this handbook, there are traditionally three core value propositions for the end user. The exact combination of value drivers varies from case to case, but are usually a combination of the following.

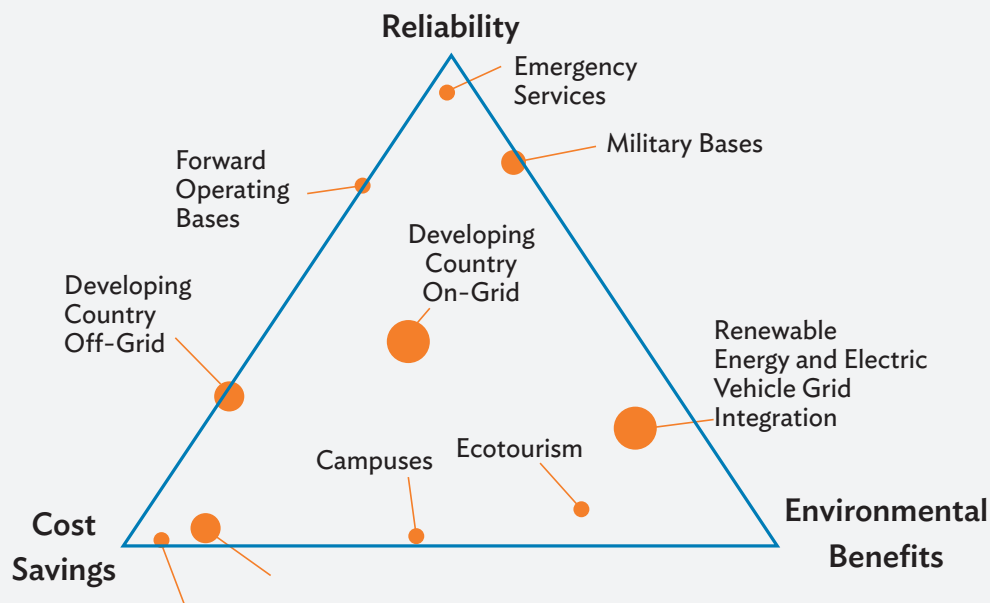
Reliability. The most common objective of a microgrid, especially in the commercial and industrial (C&I) and mission-critical sectors, is to be more reliable and resilient than the utility so that the energy end user continues to have uninterrupted service even during extreme circumstances (e.g., earthquakes, storms, or power grid outages from faults on the utility grid). These “high 9” applications (referring to the level of availability ranging from 99.9% to 99.999%) are usually in hospitals, data centers, military bases, laboratories, etc. In these applications that require a high 9 level of reliability, the microgrid’s cost is viewed as secondary to the purpose, i.e., maintaining energy supply to the facility even under extreme conditions. In situations like these, the value of electricity is often several multiples of its actual cost.

Cost savings. Another objective for microgrids is to supply cheaper power than that from the utility. In this case, the microgrid produces and manages an energy supply with its internal generation and storage resources, to provide electricity at lesser (or at least competitive) cost compared to that which would be charged by the utility for similar service levels. A simple instance of this might be a customer-owned net metered solar PV system. However, these are usually more sophisticated, especially if installed for providing cheaper electricity than the

local utility. This is because achieving lower electricity needs cost-effective generation sources, demand-side management,⁶ and if possible, the trading of electricity as a “prosumer” at the microgrid point of common coupling (PCC) to the utility. A prosumer is someone who consumes and produces a product, in this case electricity. When trading electricity, the microgrid may also have other types of generation like natural gas (NG) turbines or microturbines, as well as storage, to leverage time-of-use (ToU) arbitrage opportunities that might be available with the grid.

Environmental benefits. Renewable energy is the fastest growing power source for environmental, and, increasingly, cost considerations (Lilienthal 2018). However, while this has been successful to an extent in reducing the amount of fossil fuels used, the intermittence and variability of key renewable energy sources like solar and wind limit the amount that can go into a system unless energy storage is deployed. Hence, many microgrids are now utilizing energy storage to integrate high penetrations of clean renewable power. Advanced distributed energy storage management, as well as demand-side management, potentially allows for not just the integration of higher amounts of renewable energy, but also better reliability benefit than can be achieved via centralized storage.

Of these three core value propositions, it is the level of reliability required that usually drives the sophistication of the microgrid’s design, and thereby the cost of the electricity it delivers (HDBaker 2016).

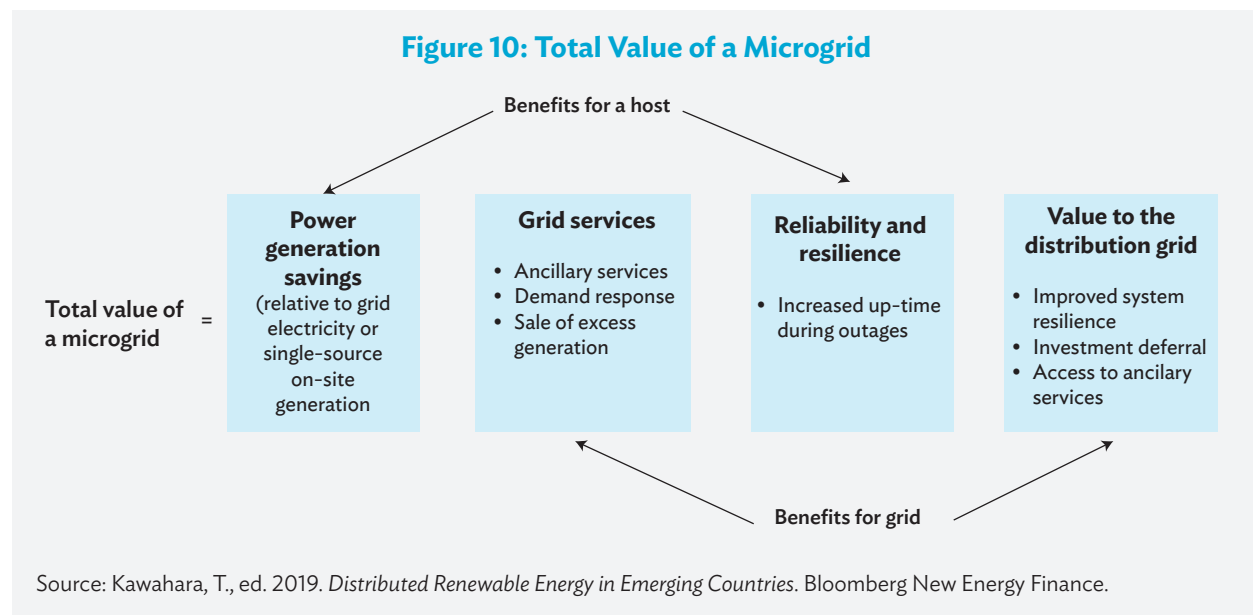

These three core value propositions translate into numerous potentials, can be directly and indirectly monetized, and with end-user benefits from microgrids. They

- (i) incorporate efficient, cost-competitive sources of clean energy such as CHP, solar, wind, mini-hydro, and thermal and electric storage;
- (ii) leverage thermal, kinetic, and battery storage devices to integrate variable intermittent renewable generation sources such as solar PV;
- (iii) provide the enabling infrastructure to enhance the techno-commercial viability of demand-side management (DSM) and building management systems;
- (iv) enhance resilience and reliability of electric service to end users and facilities;
- (v) function as emergency shelters in case of extreme weather, earthquakes, or fire;
- (vi) employ decentralization to reduce the concentration of risk in a few critical assets;
- (vii) develop local expertise and provide jobs;
- (viii) reduce peak loads and thereby grid congestion;
- (ix) improve regional grid stability and operation;
- (x) increase the competitiveness of regional electric markets; and
- (xi) help serve the regional grid's energy, capacity, and ancillary services markets.

A well-designed regional electric grid combining large centralized power plants with distributed generation via microgrids can be built at less cost. It requires less installed generation capacity, and can operate at higher capacity factor while delivering higher reliability and resilience (Microgrid Resources Coalition [MRC] 2017).

The last few points listed above open up an evolved perspective with which microgrid users and regulators should view microgrids—not just in terms of benefits to the microgrid users, but also to the distribution grid as a whole (Figure 10).



1.3.2 Drivers by Application Type

The primary motivation for implementing a microgrid, while broadly defined by the microgrid benefits triangle depicted above, varies by application. The drivers for the key types are summarized in Table 1.

1.3.3 Barriers

There are currently several potential barriers to the implementation of microgrids, for which solutions are still evolving. These include:

- (i) Limited number of scalable prototype installations and all-in-one deployments
 - (a) Most deployments are customized and incrementally installed with organic increase in need. Consequently, the conceptualization and design can be time-consuming. This is compounded by the general lack of utility leadership in encouraging microgrids.
 - (b) Many microgrids are brownfield⁷ to the extent that existing generation and load assets need to be integrated. While this can help reduce up-front capital costs, it may place limitations on optimal design.
- (ii) Lack of translatable microgrid performance metrics
 - (a) While installation-specific microgrid performance metrics are often documented, these may not be identical to the metrics at another installation due to customization and the uniqueness of each microgrid architecture and layout. Thus, they are not easily translatable across installations and every microgrid business case has to, in a way, reinvent the wheel, build a first principles business case (rather than rely on proven outcomes at other installations), and navigate the same early-adopter risks.

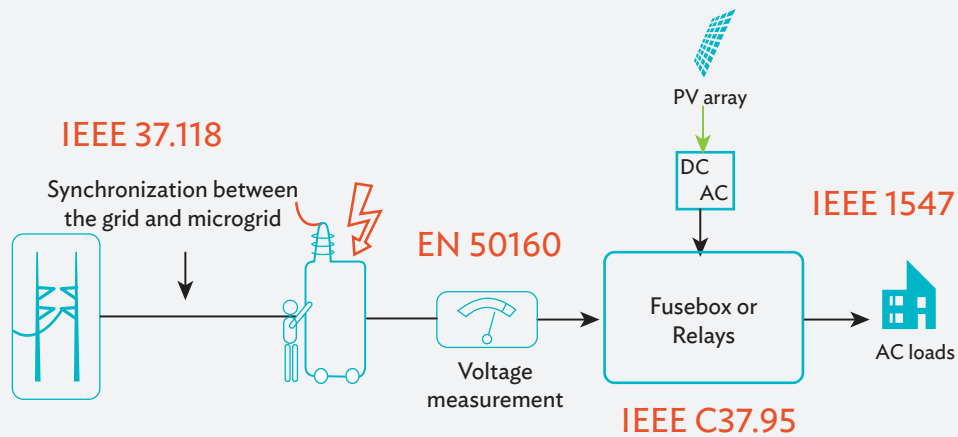

- (b) Consequently, the building of effective business cases, which relies on streamlined documentation of quantitative and qualitative microgrid benefits, is hampered.
- (iii) Limited microgrid financing models
 - (a) Most of the current projects are end user or utility financed, with limited access to a third party, especially private capital, mainly because microgrid projects are often not bankable from a financier's perspective. This is due to the lack of translatable performance metrics—and since fully capturing the myriad of microgrid value streams and risks—brings in additional uncertainty.
 - (b) To address this, stakeholders will have to develop a programmatic approach toward microgrid financing, with clearly defined benchmarks and standards that will allow potential investors to compare the relative bankability of candidate projects. Ideally, microgrids will then develop into a distinct asset class from investor perspective, and the financiers in this arena will develop standardized processes to evaluate potential investments. (Strahl, Paris, and Vogel 2015)
- (iv) Restrictions from utility franchise rights and limited retail market access
 - (a) There is lack of regulatory familiarity as well as utility experience with microgrids. Therefore, understanding how to justify them as a grid asset can be challenging. Business case examples that clearly demonstrate value to both participants and nonparticipants from a regulatory perspective are limited. For example, there are limited instances of ability to quantify and value resilience.
 - (b) While in an increasing number of cases, microgrids today are producers and consumers of electricity (prosumers), in many cases they are still not fully integrated with utility generation, and sale of power to third parties utilizing the utilities' transmission and distribution (T&D) infrastructure infringes the latter's franchise rights. Regulations that allow this will enhance the financial viability of microgrids.
- (v) Cybersecurity concerns

Security-sensitive applications in grid-connected operation are vulnerable in the absence of cyber secure standards, architectures, and devices. Common points of vulnerability are wired and wireless communications networks used to control, monitor, repair, and reboot processes of the system or equipment within it. For example, the communications ports in smart home controllers, common in microgrids, are a weak link. While utility scale grid management systems routinely scan for malicious elements trying to hack into the macrogrid, microgrid control systems need to achieve a similar standard of security on smaller budget with fewer equipment, sensors, and less analytics.
- (vi) Limited standards and interconnection protocols

Given the large variety of processes in a microgrid, several standards are applicable to microgrids for different purposes (Figure 11 presents a pictorial overview, and additional detail is listed in Appendix 4). However, many microgrid function specifics are still not comprehensively covered in these and enhancements continue to be made.
- (vii) Technical and operational challenges
 - (a) These include power quality (e.g., harmonics management, voltage and/or frequency control); grid synchronization; control strategies; control architecture; energy management; energy optimization; stability; protection protocols (e.g., during grid synchronization, transitions from islanded to grid-connected operation modes); initial design process of the microgrid; and the additional skill sets required of the operators.
 - (b) Table 2 includes a list of the key microgrid technical and operational challenges, and ways to address them.

1.3.4 Relevance of Grid-Connected Microgrids to Developing Countries

Microgrid projects in developing countries (including the DMCs of ADB) can, contrary to what is included in the typical conceptualization rubric, provide gains and benefits beyond the energy access advantage that remote off-grid minigrid capability provides alone. A key benefit that is often overlooked by policy makers is the collateral benefit of reliability and resilience of electricity supply that grid-connected microgrids, especially C&I microgrids, can provide. This oversight by policy makers is mainly because of the huge low-hanging opportunity for remote minigrids to expand energy access and improve social conditions. However, a reliable and stable power supply is an accompanying benefit that can also be valuable for C&I customers in the weak grid areas that are commonly encountered in developing countries. For instance, power outages are estimated to cost African countries 1%–2% of their gross domestic product (GDP), with Tanzania at a whopping 15% of its GDP. In Latin America, India, and several countries of the Association of Southeast Asian Nations (ASEAN), weak unreliable grids affect C&I companies. This results in excessive rental premiums on enclaves with reliable backup, usually provided via diesel generators. The 2015 worldwide sales of these diesel generators was 25 MW, and for which there is large opportunity to be replaced with renewable energy microgrids (World Business Council for Sustainable Development [WBCSD] 2017). Figure 12 shows two cases that illustrate this.

Given the importance of this segment that sometimes gets neglected in microgrid projects in developing countries, two additional examples below underscore the importance of the reliability provided by even basic grid-connected C&I setups in both rural and urban areas of developing countries (WBCSD 2017):

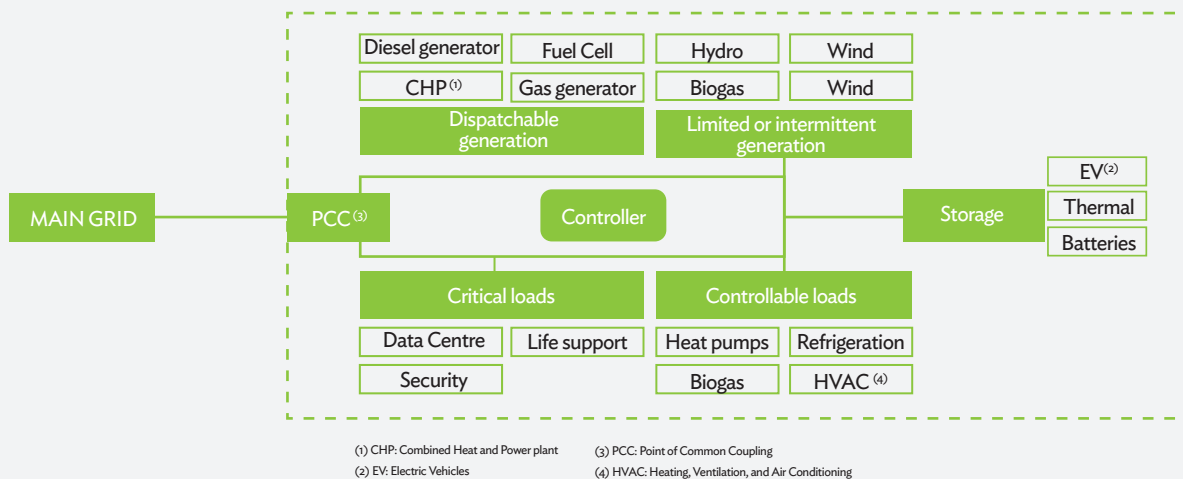
- (i) In Saint Damien Hospital, a hospital in Haiti, 650 kilowatts (kW) of rooftop solar and a 650 kW diesel generator with 500 kW Li-ion battery are capable of providing the entire energy requirement (the diesel generator being relatively large due to roof top size limitation).
- (ii) At SNIM iron ore mine in Mauritania, 4.4 MW of wind and 16 MW of diesel generation supplement the often-inadequate grid supply to avoid costly equipment stoppages.

This criticality of this aspect is further justified with specific reference to ADB DMCs in Section 3.

1.4 Components of a Microgrid

Five broad categories of components are needed to build a functioning grid-connected microgrid: local generation, energy storage, end-use loads, utility interconnection, and a microgrid control system (Figure 13).

The selection of the combination of microgrid equipment is based on the key attribute that microgrids must carefully manage supply and demand with intelligent control of any imbalance. The considerations, as seen in Section 1.3, are reliability, sustainability, and affordability, along with the local grid characteristics and availability.

1.4.1 Local Generation

A microgrid must be able to supply energy to its connected loads independent of the utility, so generation sources must exist within the microgrid. These sources could range from readily controlled to intermittent, to not controllable. This could be renewable (e.g., solar PV, wind, biomass; or less frequently used such as solar thermal, hydro, micro-hydro, tidal) or nonrenewable (e.g., diesel, NG, combustion turbines, reciprocating engines, cogeneration, CHP, turbines, microturbines).

The selection of energy source needs to be adjusted to the demands on the microgrid, such as the desired generating capacity, required firmness level,⁸ ramp rate, renewable energy targets, and availability of fuel (and fuel storage requirements). Brownfield microgrid setups often start with some form of existing generation already onsite, such as existing diesel generators, solar panels, or cogeneration facilities. The existing generation resources influence the additional distributed generation capacity required to be added for supporting the microgrid. Recent decreases in the price solar PV modules and other forms of renewable energy such as wind and biomass, along with energy storage, have enhanced the economic feasibility and attractiveness of renewable energy-based microgrids.

Economies of scale apply across almost all the generating technologies, implying that smaller generators have a higher unit cost of installation cost compared to larger ones, and consequently a higher repetition of cost of energy for generation. For example, a 5 kW residential rooftop solar PV system might cost about \$4 per watt to install, whereas a 50 MW utility scale solar PV farm could cost \$2 per watt installed (HDBaker, 2016). Additionally, costs decline with increase in technology maturity. For example, solar PV panel costs are steadily declining. Furthermore, there are technology-specific considerations. Solar-based remote microgrids have some inherent challenges such as maintenance of the modules, since performances decrease significantly when temperature rises or it gets coated with dust or is exposed to high moisture, as well as the energy storage requirements for intermittent generation sources such as solar or wind. Intermittence is a particularly relevant aspect in economic considerations, since energy storage systems often comprise a significant fraction of the total microgrid cost, and larger intermittent capacity necessitates more storage capacity. This is one of the reasons microgrids often include quick ramping yet relatively cheap natural gas as part of a power source. Common microgrid generation sources are listed in Table 3. Additional details of renewable and nonrenewable distributed generation sources are in Appendixes 1 and 2.

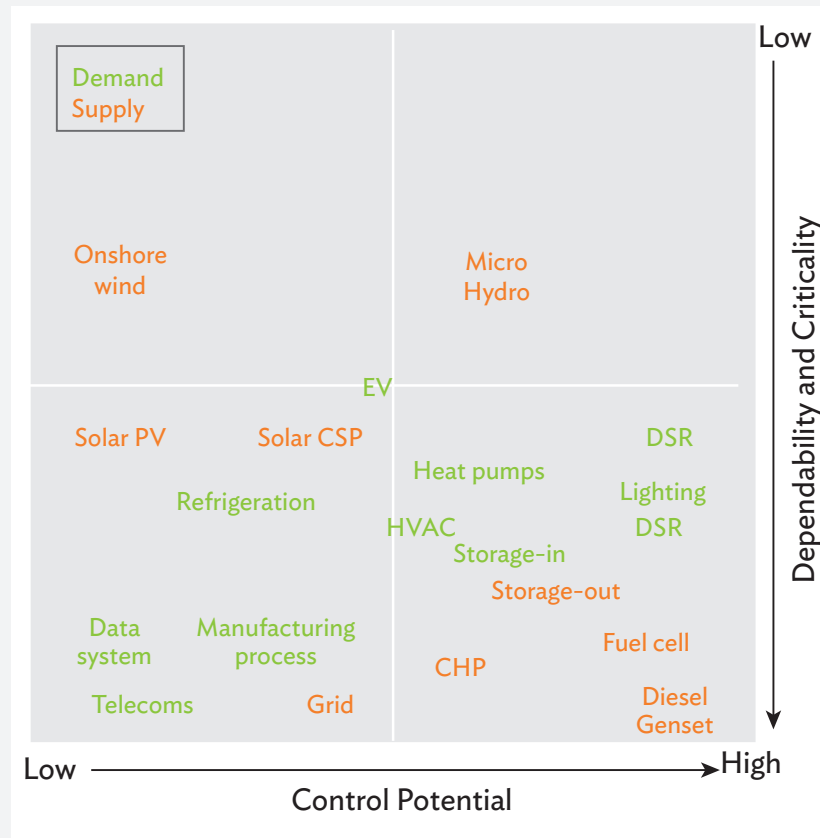
1.4.2 End-Use Loads and Demand-Side Energy Management

The type of end-use devices determines the electrical loads that the microgrid has to be capable of handling, which in turn influences the power-generating capacity and storage requirements. For instance, cellphone charging imposes minimal capacity requirement on the system, but connecting an air conditioner to a solar PV-based microgrid can cause challenges in managing electric loads because of its large continuous power consumption. In reality, a microgrid does not consist solely of one of these extremes, but will have a range of end uses to be served.

Microgrid energy loads range in controllability characteristics from critical loads like data centers or hospital life support equipment at one end of the spectrum, to adjustable controllable loads like air conditioning, lighting, or grid dispatch at the other end. This latter category of loads can be temporarily curtailed or adjusted in line with flexible user requirements, and most modern microgrids will have the capability to control these end uses to optimize the utilization of generation and storage resources.

Each type of supply (local generation), demand (end-use loads) and storage can be categorized on the basis of their controllability, dependability, and criticality (Figure 14).

Figure 14: Characteristics of End-Use Loads and Generation

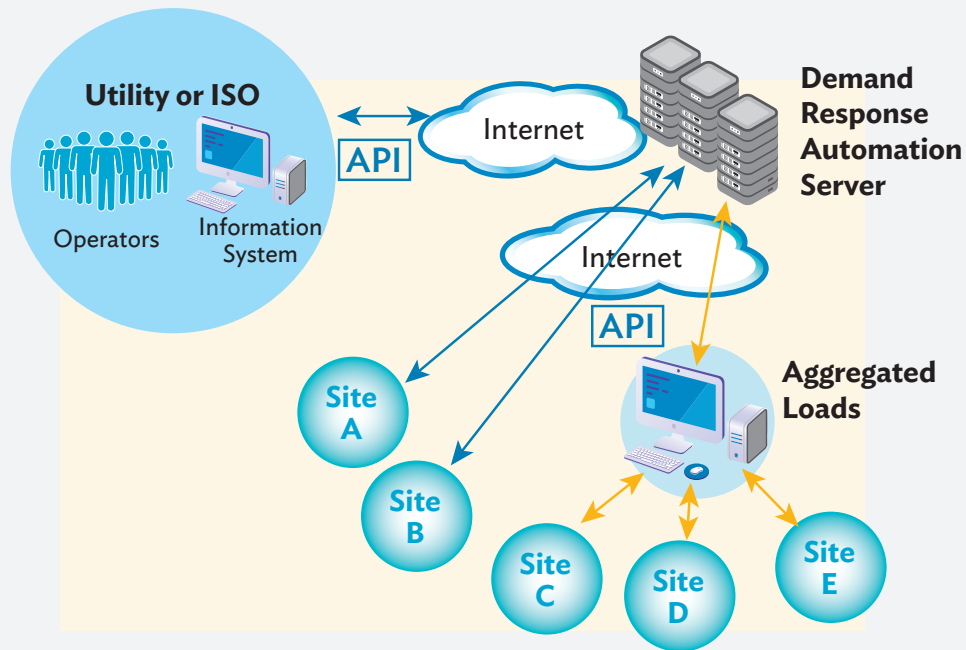

Demand-response (DR) is defined by Federal Energy Regulatory Commission as “changes in electric usage by end-use customers from their normal consumption patterns in response to changes in the price of electricity over time, or incentive payments designed to induce lower electricity use at times of high wholesale market prices or when system reliability is jeopardized.” DR is a subset of DSM, which includes immediate real-time measures as well as long-term and permanent energy efficiency measures. OpenADR is a standard that supports a range of automated demand-response signals from the utility’s demand-response automation server (DRAS) to automatically control connected equipment in the end-user premises (Figure 15).

Figure 15: System Architecture of a Typical Automated Demand-Response Implementation



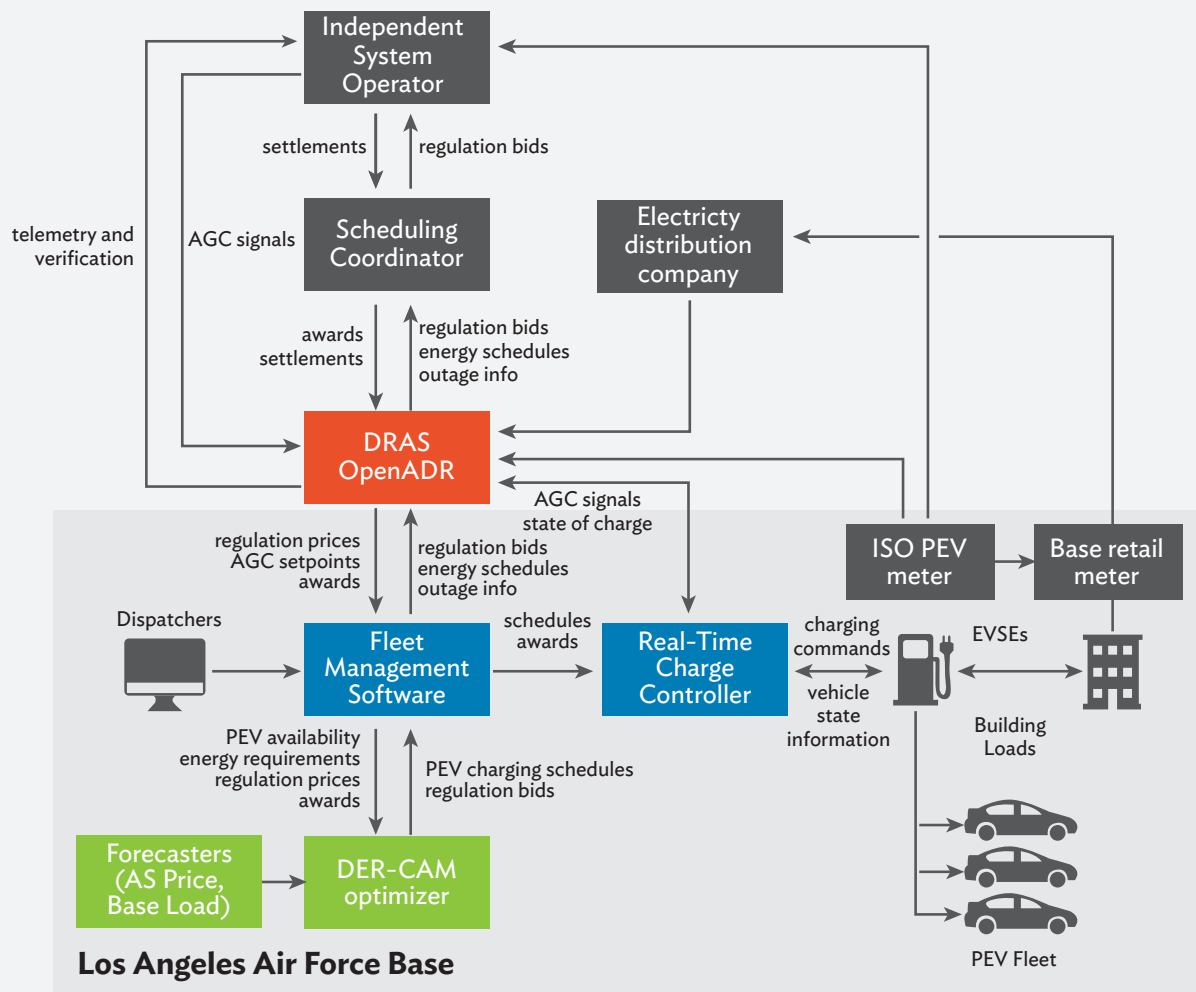
API = application programming interface, ISO = independent system operator.

Microgrids open new possibilities in the realm of DR as the control actions need not be limited to controllable flexible loads, but can extend to dispatchable onsite generators and storage, all of which can be harnessed in an integrated manner by the microgrid monitoring and control system (MMCS). This would allow for noncritical loads to be shut off or turned down, dispatchable generation to be activated, and storage to be harnessed, all concurrently, which would in turn allow for enhanced participation in DR programs or arbitrage opportunities that may exist in regional power markets or service jurisdictions where ToU rates are available. Thus, microgrids potentially present conducive conditions for advanced, price incentivized, unified responses to be leveraged across a wider range of assets, by way of DSM and DR schemes. (Samad, Koch, and Petr, 2016). Figure 16 shows one such implementation at Los Angeles Air Force Base. Although there are no distributed energy resources (DER) in this case, they seek to use the charge capacity in the batteries of plug-in electric vehicles while connected to the EV supply equipment, for providing ancillary services such as frequency regulation, to the grid, with DER-CAM optimizer software to determine the optimal charging schedule functioning as the de facto energy management system (EMS).

From another perspective, DR can also be used internally within the microgrid to incentivize “rational” flexible end-use equipment to preferentially consume when cheaper sources of internal generation are available, thus minimizing import of electricity from the utility grid. In a microgrid, demand-response can potentially be executed at a more granular level than the typical regional grid or independent system operator (ISO) level, via the MMCS, with the MMCS then doubling up as the DRAS to control the facilities in the microgrid via an EMS, BMS, or individually controlled end-use devices. This scenario has the added advantage that microgrids (especially C&I or campus microgrids) contain these controllable production, storage, and consumption sources within a “walled” environment, implying simpler control and fewer cybersecurity concerns.

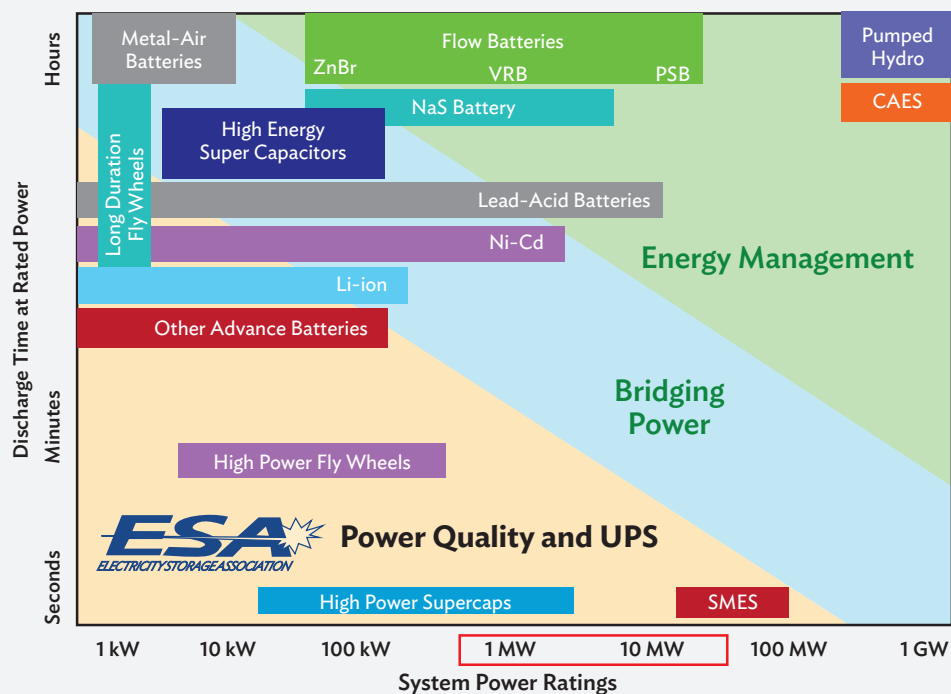
1.4.3 Storage

Microgrids must have some form energy storage as a means to time-shift own generation to match load demands, as well as a critical fallback supply in islanded mode operation. With energy storage, the microgrid can absorb and store the energy generated at times when supply exceeds demand, and to subsequently return it at times when demand exceeds supply (e.g., evening peaks once solar PV generation is not available). While there are some inefficiencies from storage and line losses, these are minimal compared to the value that storage can deliver. Energy storage can also be leveraged for arbitrage in wholesale power markets or with time-based rates such as real-time, peak, and ToU pricing.

The energy storage technology is chosen based on the size of the microgrid and reaction time required. For instance, for remote microgrids or smaller grid-connected microgrids, batteries are the most commonly used storage technology because the storage capacity required by the microgrid does not justify the higher costs associated with other storage technologies. Batteries can also be used to provide the ancillary services required within a microgrid. Large-scale storage technologies, such as hydro-based storage or thermal storage, while cheaper for time shifting operations, have high initial costs that make their implementation in smaller and microgrids challenging.

Figure 17 provides a summary of various storage technologies in relation to their role in microgrids. It includes a comparison of energy storage sources in the range of 1–10 MW, which are typically found in microgrids. More details on the various energy storage technologies can be found in ADB's 2018 handbook on the topic of energy storage.⁹

1.4.4 Microgrid Monitoring and Control System

Microgrid monitoring and control systems (MMCS) tie all of the microgrid components together and maintain the real-time balance of generation and load. This control system can follow a centralized or decentralized scheme (Section 1.5). In the most basic of microgrid configurations, the control system might just be a governor controlling a diesel generator. In more complex microgrids, the MMCS comprises sensors, metering, sophisticated software platforms, and communication paths designed to allow for real-time optimization and control of the generators, energy storage, loads, and utility interface. During grid-connected operation, the MMCS needs to manage the utility interconnection and communicate with the system operations center of the utility (or independent system operator), including any DR management systems in near real time.

1.4.5 Utility Interconnection

A distinctive feature of microgrids is the interconnection with the utility's power grid, sometimes referred to as the PCC. This is what allows microgrids to operate in grid-connected or islanded modes, and transition is relatively seamlessly between both. If there is an existing utility interconnection, it lays the foundation for what additional hardware may be needed for the microgrid. This includes elements ranging from existing relays and meters in the substation and distribution equipment, to switchgears and power converters in the microgrid (Planas et al. 2015).

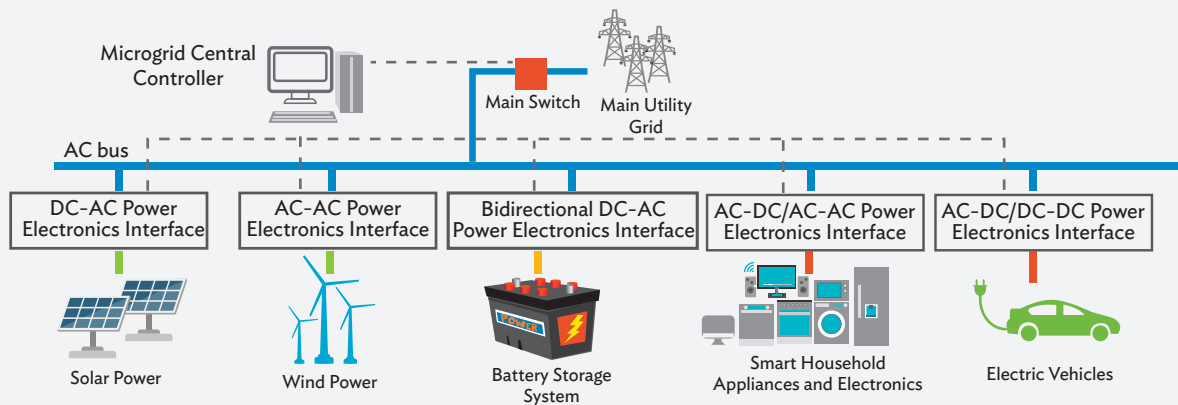
During grid-connected operation, the microgrid-utility interconnection at the PCC must be designed to allow for safe and reliable parallel and concurrent operation of the microgrid and the utility macrogrid. The existing utility equipment may need to be upgraded to handle the various changes that occur when islanding a microgrid. For reliability and resilience, focused microgrids where relatively frequent islanded mode operation is anticipated; the PCC must also incorporate equipment to allow for seamless disconnection and reconnection of the microgrid to the power grid. This re-synchronization of the two systems is a complex process and failure to adequately design for this function can result in instability of both the microgrid and the main power grid. Accordingly, islanding of microgrids must be addressed at both technical and policy levels (safety concerns, potential end user equipment damage, reclosing scenarios, inverter prioritization).

1.4.6 Other Components

Power Electronics

Power electronics interfaces are used to connect and manage the various components within a microgrid, e.g., generators to loads to storage. Different conversion steps such as direct current (DC)–alternating current (AC), AC–DC or DC–DC may be needed to match the input and output voltages of a single component to a microgrid voltage.

Protection

Protection is an important element in the design of microgrids. It is needed for the microgrid as a whole, as well as for cycle-level controls. It must act almost instantly and be carefully programmed to differentiate between grid-connected and islanded operating modes. In a grid-tied mode of operation, the protection is simplified by the potentially large fault currents, whereas these fault currents may have relatively low values in islanded mode due to integrated power electronics interfaces in microgrid. This low current capacity in islanded mode is not sufficient to trip conventional overcurrent protection. Therefore, an adaptive protection system is needed to change relay settings in real time to guarantee that the microgrid is always protected. Another solution could be utilizing digital relays equipped with a communication network to protect the microgrid. An easier way to address the protection issue is to design the microgrid to, in a fault situation, enter islanded mode before any protection action takes place.

Monitoring

There are many parameters in a microgrid such as voltage, frequency, and power quality that must be continuously monitored. Several monitoring schemes have been proposed, and several vendors supply monitoring components and solutions. Monitoring is simpler in DC microgrids than in AC microgrids. Fewer variables need to be monitored and controlled, as frequency and reactive power issues do not exist (Planas et al. 2015).

Power Converters

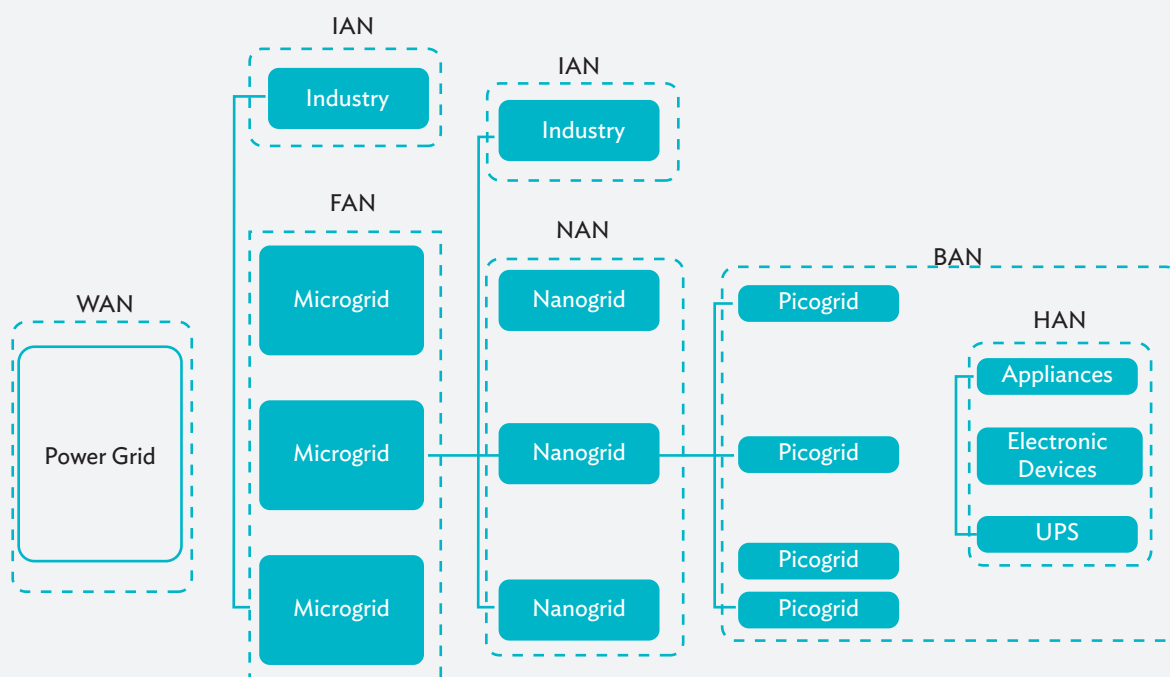
DERs and loads are generally connected to the distribution lines of the microgrid through power converters. They adapt the current and voltage levels of the microgrid to the connected units. Power converters vary by microgrid parameters and type, but in general, power conversion efficiency is higher in DC systems than AC systems, and mainly depends on the technology of the primary source and AC/DC load ratios (Planas et al. 2015).

Communication

Robust communication pathways are essential in microgrid implementation to ensure stable, reliable, and optimal operation, since the presence of distributed generation and loads and interaction between all the nodes within a microgrid substantially increases the complexity of power system operation and control, and thereby, communications. The microgrid communication network needs to guarantee a high level of reliability, with bidirectional and interoperable connectivity among the microgrid resources. In a way a microgrid's communication network can be considered a bridge between its physical infrastructure, and its control and protection processes. This contrasts with the traditional power grid structure, which typically lacks the aforementioned connectivity, as it is meant to function as a centralized unidirectional system. Systems architecture, standards, and tools are involved in designing how a microgrid will communicate internally using one or more languages or protocols, through wired (fiber, copper) or wireless (radio, cellular) communication pathways, some of which may already be existing.

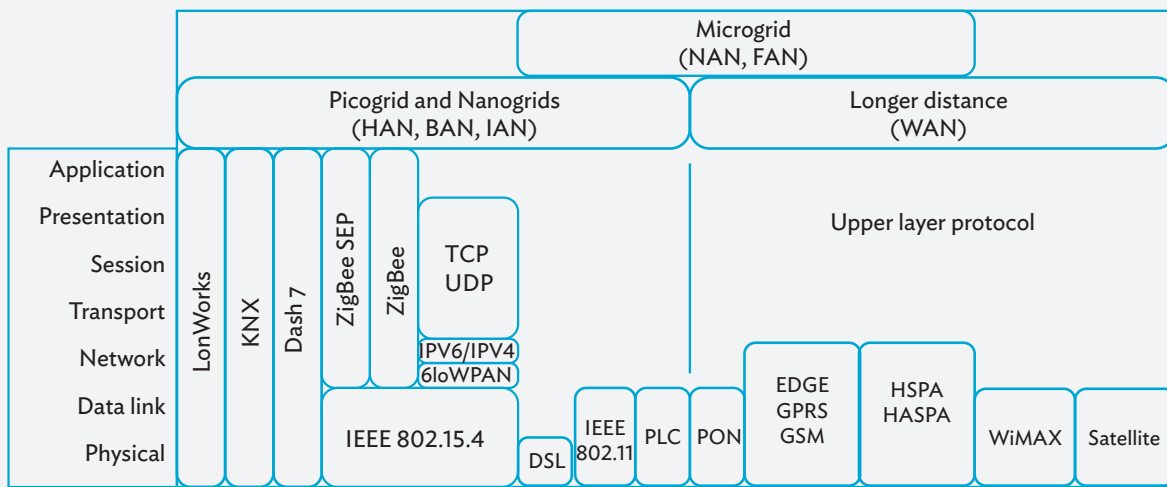
Figure 19: High-Level Topology of Microgrids and their Interacting Networks

Grid-connected microgrids are rarely stand-alone, but interact and communicate with the traditional electric grid on one side and industrial, commercial, institutional, residential, and other end uses on the other, which may contain sub-grids (Figure 19). Microgrids and these networks they interact with are broadly classified as wide area networks, industry area networks, field area networks, neighborhood area networks, body area networks, and home area networks. The communications technologies and standards used in these applications are shown in Figure 20.

Cybersecurity

Finally, some form of cybersecurity is essential. Given the extensive communication and controls, there is vulnerability to cybersecurity threats wherein a single infected computer can spread a virus on to the network, thereby affecting an entire microgrid. Microgrid operators and individual smart home owners usually rely on their equipment providers to design a cybersecure microgrid. A global safety consulting and certification company¹⁰ published in July 2017, the first edition of a cybersecurity standard.¹¹ This was subsequently also published as an American National Standards Institute (ANSI) standard. Adoption of this standard by equipment providers will help improve cybersecurity in microgrids. (CleanTechnica 2018)

Components that are more robust, versatile, and durable incur greater up-front costs. However, higher microgrid capital costs can often be justified if the negative repercussions of a customer outage are large (e.g., financial firm data center outage, air traffic control outage, life support system outage, spoiled batch in a semiconductor fabrication process). Accordingly, while the enhanced reliability and resilience provided by more sophisticated microgrids might cost more, it provides value that is often multiples of the additional cost. Therefore, the customer's objective should drive the microgrid's design.

1.5 Microgrid Types by Design Architecture

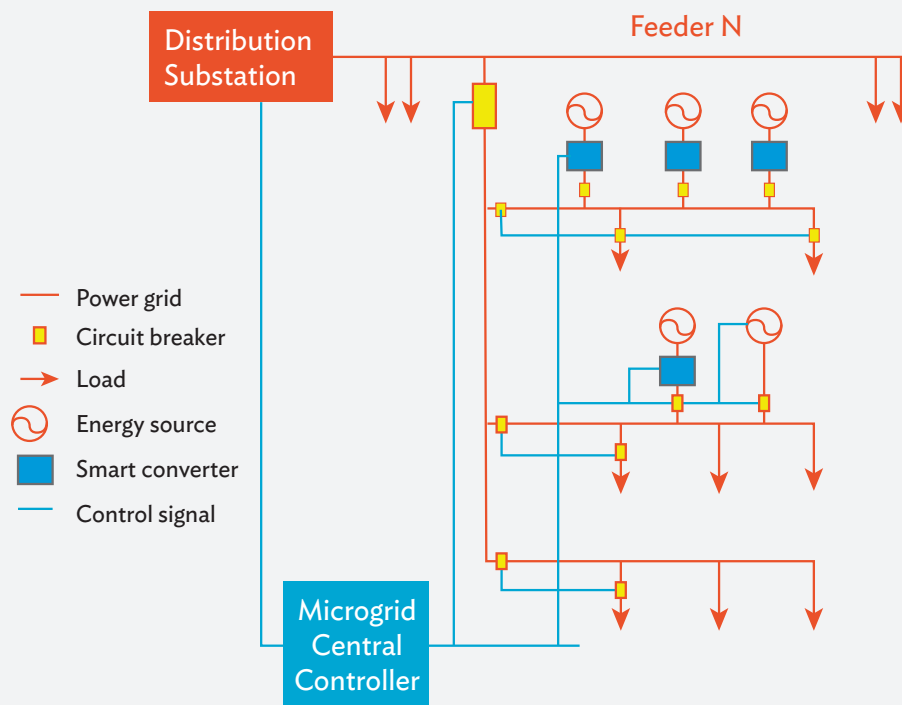
Microgrids' design architecture can be classified in two ways: their by control approach, and by power technology.

1.5.1 Categorized by Type of Microgrid Control Approach – Centralized vs. Decentralized

One approach to classifying microgrids is based on their operational control, which is either centralized or decentralized.

In a centralized microgrid system, a single entity, the microgrid central controller (MCC) is responsible for the decision-making processes—essentially determining the setpoints of the loads, distributed generation resources, and storage units. The MCC communicates with the converters to control the active and reactive power input from the DERs and circuit breakers to control the connection of loads, DERs, and microgrid to the rest of the system (George and Chauhan 2015). Wireless communication technologies are usually used for data transmission. This architecture is a suitable option when all actors in the microgrid have common goals. As an analogy, in the traditional electric grid, centralized control is generally performed by a single entity at the transmission system operator level. Similarly, in the case of a microgrid, when applying centralized control, a single entity carries out the economic dispatch and the unit commitment calculations. The setpoints are provided to the distributed sources by an MCC (as would have been by the distribution system operator in the traditional electric grid). An MCC can be managed by the distribution system operator or by a dedicated microgrid operator, depending on the ownership structure.

Figure 21: Schematic of a Centralized Control System

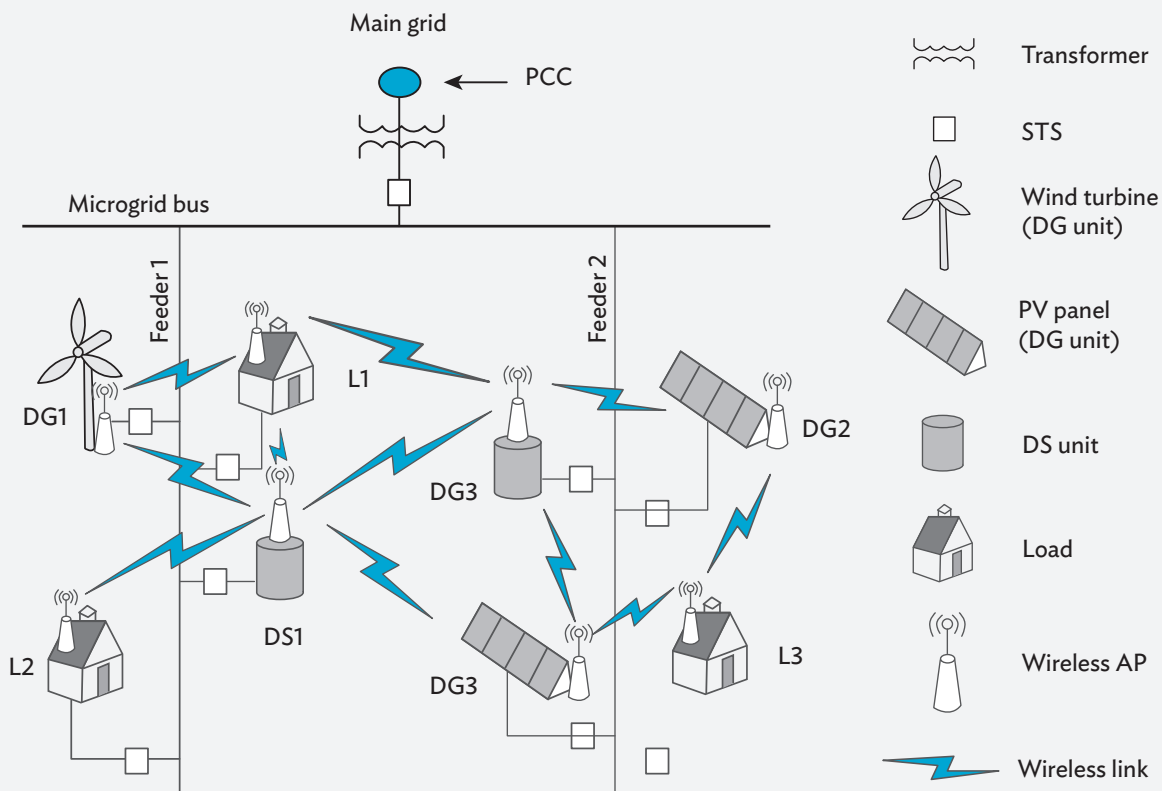

In a decentralized microgrid system, the internal microgrid control takes place at each controllable element in the microgrid—generators, storage, and loads. It does not require a powerful central controller and is resistant to single point of failure. Negotiation among the different actors may take place, especially because in this case, the different actors have different goals, but common aspects and calculations, like load forecasting, state estimation, and security monitoring can still be done in a centralized manner. The performance of the control algorithms depends on four key attributes:

- (i) **The number of nodes.** The DG and controllable loads that make up the microgrid affect the complexity and computational time as the number increases.
- (ii) **The number of messages exchanged.** The DG and loads in microgrids are usually dispersed, and the communication systems at low voltage usually have limited bandwidth. In several cases, the number of messages required to perform a task is of primary importance. A decentralized control approach reduces the number of messages, as only a small part of the information needs to be transferred to the higher levels of the control hierarchy.
- (iii) **The size and structure of the system model.** The structure and complexity of the system needs to be considered. Decisions taken by different actors might not only increase the number of nodes, but also impose extra technical and nontechnical constraints.
- (iv) **The accuracy and optimality of the solution.** The convergence and accuracy of the solutions depends on the type and accuracy of the algorithms used, and the input data.

Advantages of Centralized over Decentralized

Centralized control schemes have the following advantages:

- (i) They provide a high operation knowledge, where the main goals are clearly identified and achieved.
- (ii) They can provide global optimal solutions.
- (iii) They allow an easy synchronization to the main grid, and they can effectively use real-time signals for online operation.
- (iv) Decentralized control schemes have the main disadvantage of being very complex with respect to multi-ownership and competition between the various actors or agents. Each agent seeks to achieve its own objective, such as maximizing its profits.

Advantages of Decentralized over Centralized

Decentralized control schemes have important advantages:

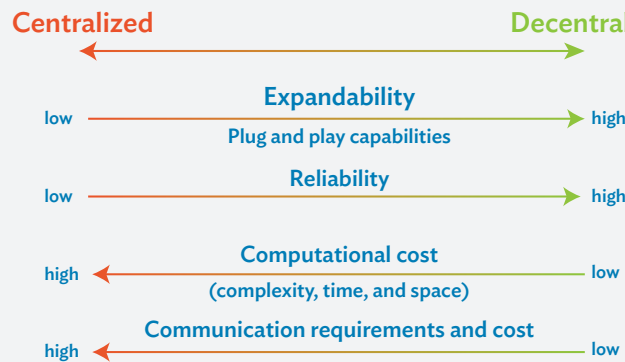
- (i) They are suitable for fast changing infrastructures. They could easily be expanded because of their plug-and-play capabilities.
- (ii) They are reliable.

The main disadvantages of centralized control schemes are that they are computationally expensive and time-consuming. The central controller needs to run an optimization problem that takes into account a large number of distributed generation units, loads, and storage units.

The central controller has high communication requirements leading to additional costs and the risk of single point of failure.

In summary, in centralized control, the microgrid's operation is optimized by a single entity—the MCC—which assigns the setpoints to the loads, distributed generation, and storage units, toward attaining the microgrid's operating strategy and targets. In decentralized control, the decisions are taken locally by the various actors (loads, distributed generation, and storage units) and negotiations may take place, as these actors might have different goals.

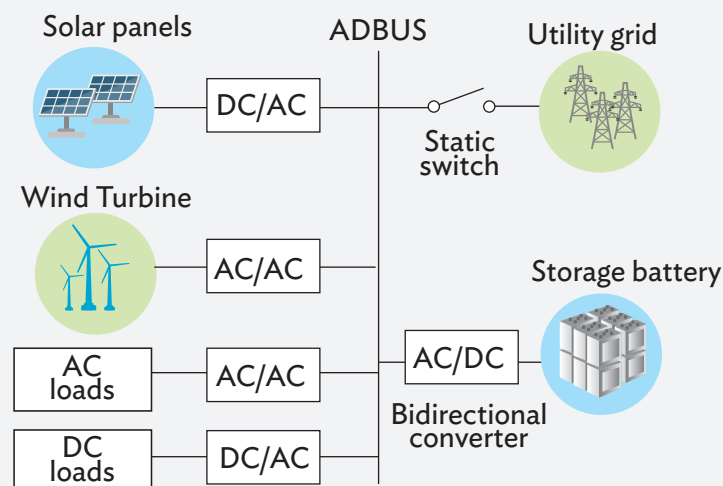

1.5.2 Categorized by Type of Power Technology – Alternating Current vs. Direct Current vs. Hybrid

Microgrids can also be classified based on the type of power distribution technology used, AC, DC, or hybrid. While several considerations go into the eventual selection of a power technology for the microgrid, the most suitable option is likely to be an AC microgrid because it needs minimal modifications on the existing installations. However, DC or hybrid microgrids often have better performance and should be considered for new installation greenfield microgrids. As of existing installations, AC microgrid technologies dominate when it comes to integration of local power generation and consumption for both on-grid and off-grid applications, but as DC microgrid technologies develop further, there is likely to be greater adoption as well combinations of the two approaches, or hybrid configurations.

AC microgrid. In an AC microgrid, all the DER (renewable and nonrenewable), energy storage devices and end-use loads (both AC and DC) are connected to a common AC bus (backbone network). When the microgrid's energy generation exceeds all the loads on it, the microgrid can send out (export) energy to the utility power grid, or charge its energy storage devices, such as batteries, via a bidirectional AC/DC converter. On the other hand, if the loads on the microgrid exceed its internal generation, the microgrid can either take energy from the utility grid or from its own charged energy storage sources. This is the grid-connected (normal) mode of operation. However, when a fault occurs on the utility grid and the load demands are not met, the microgrid disconnects itself from the utility grid at the PCC and begins to function in islanded mode. The merits of AC microgrids include its adaptability that makes it easier to be integrated with the original AC power infrastructure, and the simplicity of its voltage transformation. Also, the AC microgrid equipment costs less compared to DC microgrids. AC microgrids are a feasible option for both cities and rural areas. If disturbances or faults occur, reliable power can be generated in isolated mode. Consequently, as of today, the number of AC microgrids far exceeds that of DC microgrids.

Figure 25: Schematic of an Alternating Current Microgrid Bus with Solar and Wind Generation

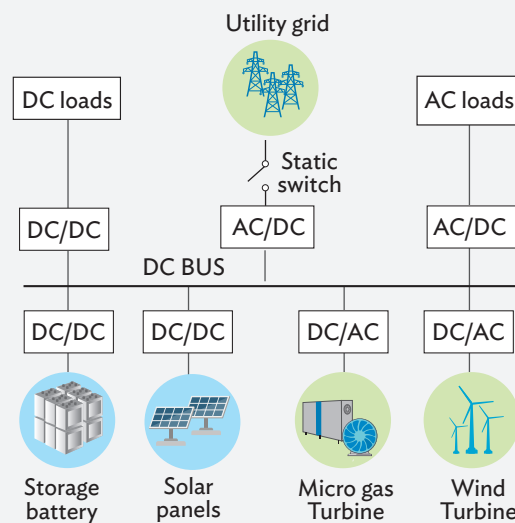

DC microgrid. The operating principle of a DC microgrid is similar to an AC microgrid, but it is connected to a DC bus. Similar to AC microgrids, DC microgrids can also be operated in grid-connected or isolated modes. Although it typically has a higher capital cost, the operating costs and system losses are usually lower due to direct connection to DC loads via single stage power conversion. DC microgrids are likely to see increased popularity in the coming years as it gives several operational advantages over AC microgrids. In DC microgrids, the generation and distribution system comprises mostly PV units, wind turbines, fuel cells, and other renewable energy sources used to meet energy demands. From its storage devices, it utilizes the DC output voltage, and voltage regulation is better. As there is no need for frequency control, additional system synchronization is not required.

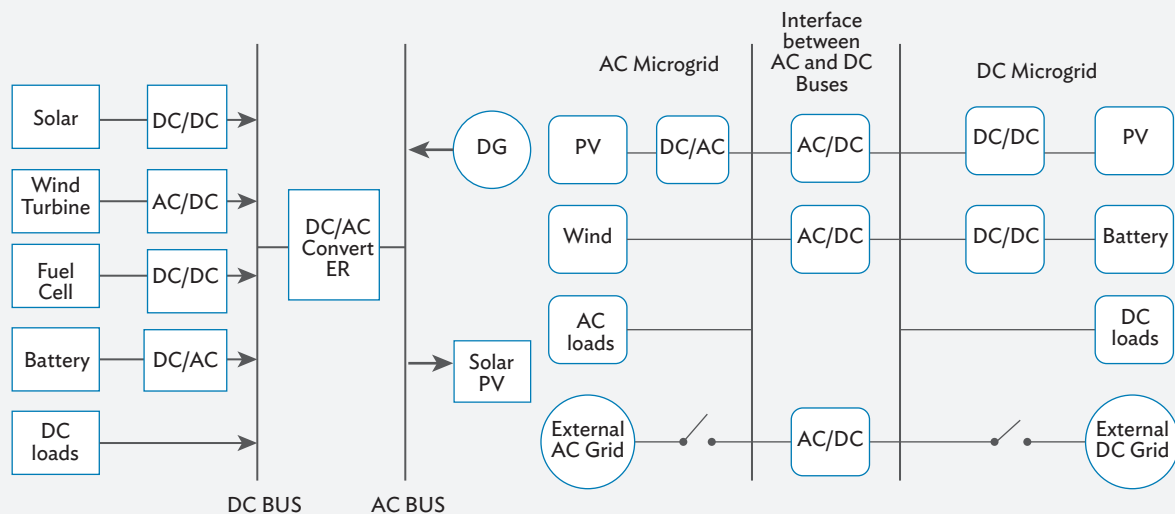
Figure 26: Schematic Diagram of a Direct Current Microgrid using Solar, Wind, and Microgas Turbines

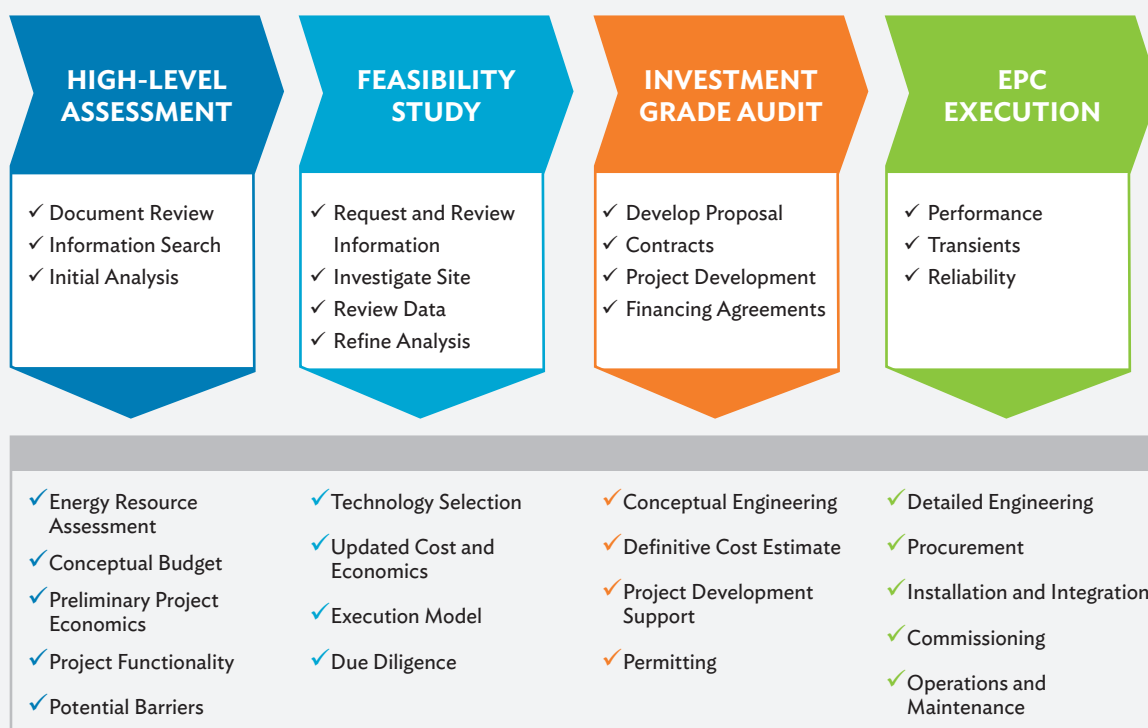

1.6 Design of a Microgrid

1.6.1 Phases in the Implementation of Microgrid Projects

From a project management perspective, the conceptualization, evaluation, design, construction, and commissioning of a microgrid follows the same broad stages as other infrastructure projects with similar stakeholders.

In the case of an existing facility or brownfield microgrid, the pre-project evaluations begin with an assessment of the current situation. Both brownfield and greenfield projects would then undertake a high-level assessment (Figure 28) that includes:

- (i) Technical setup: current and historic levels of power supply reliability, current power generation mix, type of distribution grid, typical load profile, identification of critical loads versus controllable loads, heat and chill loads (if any), available space for a microgrid;
- (ii) Environmental considerations: emission rates, emission targets;

- (iii) Financial considerations: operating costs, fuel costs, electricity prices, fuel price volatility, proportion of electricity costs as a share of total cost of sold goods, opportunity costs of outages caused by historic levels of reliability; and
- (iv) Project objectives: minimize energy bills, reduce outages, reduce emissions, provide spinning reserve, peak demand reduction, etc.

The subsequent project feasibility study includes the following key considerations:

- (i) Applicable policies: planning and permitting regulations, power tariff structure, grid connection charges, grid use of system charges;
- (ii) Renewable resource: wind speeds, solar irradiation, shadow effects;
- (iii) Site information: land availability, thresholds that trigger planning permission, environmental impact assessment, visual impact assessment, timescales for development, supply chain lead times; commercial structures: self-ownership, infrastructure fund, independent power producer (IPP), power purchase agreement (PPA), returns to owners;
- (iv) Financing structure: balance sheet, debt/equity, PPP, etc.; and
- (v) Technical viability: grid integration principles, technology choices and optimum size, site layout, ability to feed power back to grid.

A summary of the social, economic, technical, and legal and regulatory criteria that need to be addressed as part of a microgrid's investment grade project evaluation is in Table 6.

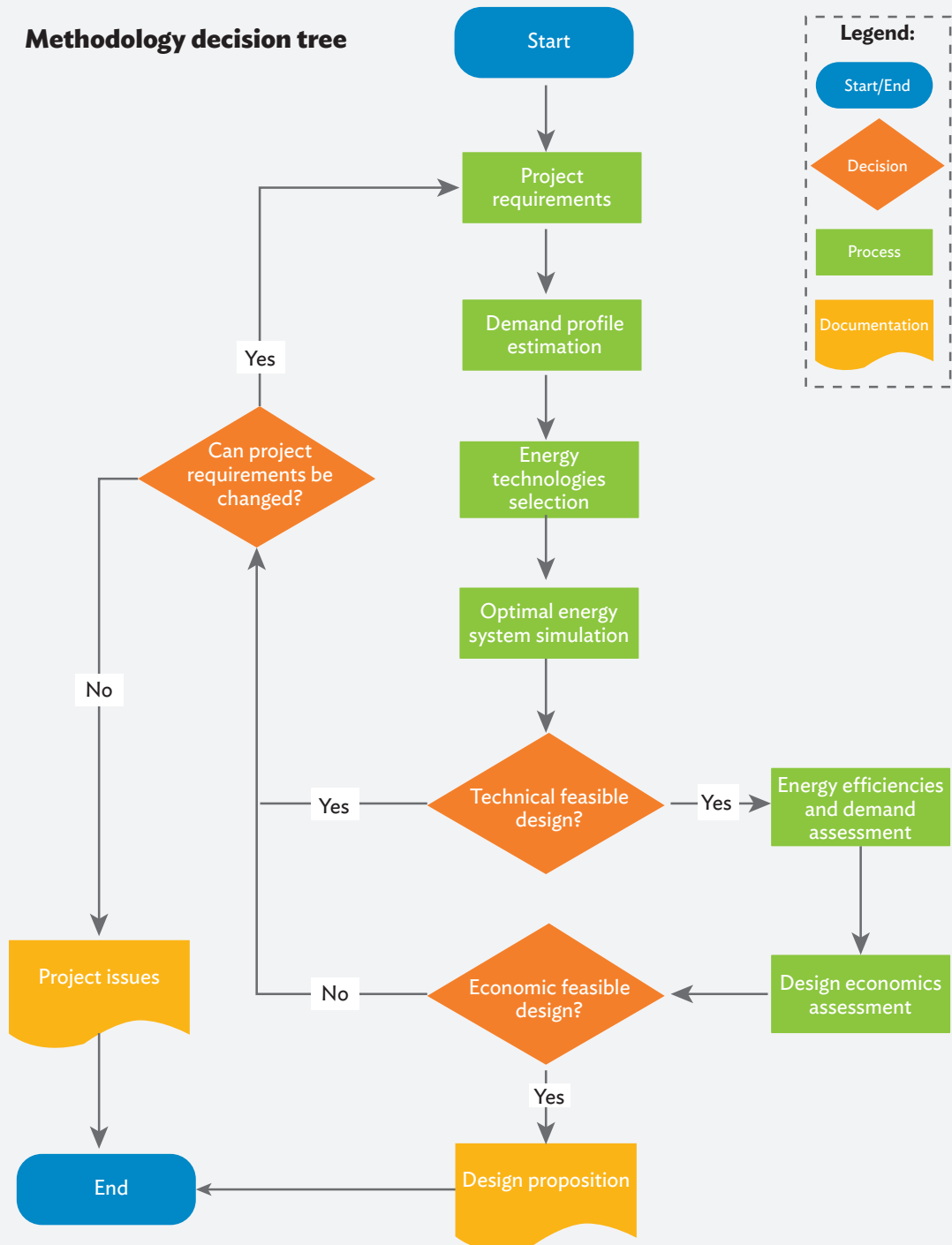
1.6.2 Design Parameters

Once the feasibility study is completed and the project receives a green signal, the aspects to consider in the microgrid system design during subsequent conceptual and detailed engineering stages are listed below and pictured in the flowchart on Figure 29:

1. Demand forecasting
 - (i) Number of customers
 - (ii) Length of circuits
 - (iii) Load analysis (e.g., critical, controllable, high efficiency, etc.)
 - Somewhat challenging in the case of low-income customers with limited technical and financial resources, hence, estimates and extrapolations may need to be used.
2. Generation capacity sizing
 - (i) Generation mix
 - (ii) DER sizing and design
 - Optimal sizing of PV and wind
 - (iii) Nonrenewable generation sizing
3. Energy storage devices selection, combination, and sizing
 - (i) Standby power loss
 - Storage is primarily needed when the microgrid is islanded
 - Standby power loss will reduce the efficiency of the microgrid
 - (ii) Response time
 - For seamless transition, response time must be very fast
 - This is more than just battery response time –communications latency and control functions also play a role
4. Technical design
 - (i) Microgrid controller architecture and design
 - Centralized versus decentralized
 - (ii) Power technology
 - AC versus DC versus hybrid microgrids
 - (iii) Voltage levels
 - (iv) Feeder configuration
 - (v) Desired power quality and reliability levels
 - (vi) Protection methods – Several protection schemes have been developed for AC microgrids, both centralized and decentralized. For DC microgrids, this area is less developed because of the lack of standards and guidelines, along with limited practical experience
 - (vii) Communications technology
 - (viii) Distribution system modeling, simulation, and design
 - Scenarios
 - Model validation
 - Grid impact
 - (ix) Impact studies
 - Steady state
 - Fault analysis
 - Protection
 - Stability studies

One critical consideration is building systems that can grow with the customers' increased socioeconomic improvement. It is important to select vendors with plug-and-play, modular designs that can be expanded, and are interoperable, backward compatible and forward integrable, as well as with open standards to the extent possible.

1.6.3 Design Software

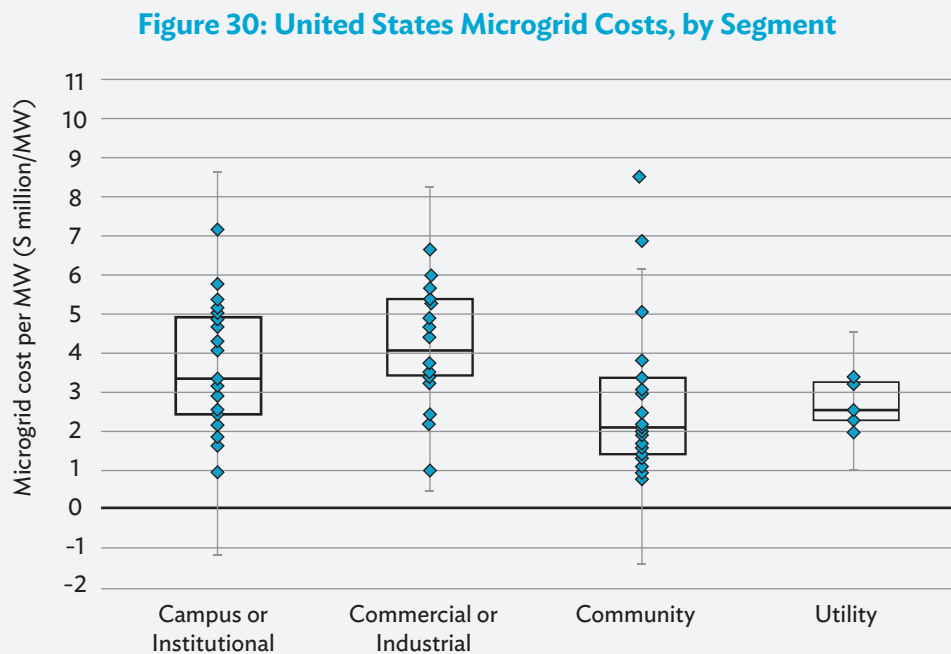
Technical design of microgrids is a complex process taking into account multiple parameters listed in Section 1.6.2. Consequently, various models are required to understand a variety of microgrid operational, control, and integration aspects such as performance, grid interaction, and protection impact in a range of scenarios. Several software are available for this including those listed Appendixes 7 and 8.

1.6.4 Product Selection

Most of the components used in microgrids are commercially available today from several large vendors as well as several niche players. As volumes increase, price declines are likely, and continued improvements in performance and functionality can be expected. Several companies are also involved in the integration space (including the product suppliers themselves as well as engineering companies). Hence, once a microgrid is conceptualized and evaluated, its design, product, and integration services can follow standard procurement processes.

1.6.5 Capital Costs

A microgrid's total capital costs include those arising from its early stage development; feasibility studies; permitting, design; land acquisition; equipment purchase; engineering, procurement, and construction (EPC); and commissioning. These costs are likely to vary widely by application, the level reliability and, in turn, sophistication of the microgrid, and whether it is a greenfield site with no existing equipment or brownfield site with existing assets, as well as, to an extent, by geography. However, by far the largest component appears to be cost of the distributed generation equipment, followed by the microgrid control system. Figure 30 shows the average per-MW installed capital cost of microgrids in the United States based on a 2016 study (Giraldez et al. 2018).

1.7 Microgrid Operations and Maintenance

There are two operating modes for a grid-connected microgrid. The normal operating mode is the grid-connected mode. In this operating mode all the feeders are supplied by the utility or main grid, and the microgrid typically operates this way as long as there is no power quality disturbance on main grid. However, when there is a fault of other power disturbance on the main grid, the microgrid will be disconnected from it (in a planned or unplanned manner). This is referred to as “islanded” or “isolated” mode of operation. Such transitions, along with maintaining of system stability and fault detection are three critical areas for proper microgrid operation.

1.7.1 Transition Between Grid-Connected and Islanded Modes

The ability to transfer between grid-connected and islanded modes without any interruptions to the customers is an important function. If certain load and distribution system conditions are foreseen that need to be managed in advance, such seamless transfers can ideally be initiated by the microgrid operator. If a storm warning has been issued, the microgrid operator may decide to transfer the microgrid from grid-connected to islanded mode operation by simply initiating the sequence via their control system. Once the storm has passed, the microgrid can resume grid-connected operation by seamlessly synchronizing back into the distribution system. In the case of unscheduled events such as distribution system faults however, there might be brief interruptions in supply to the microgrid’s loads depending on the protection system type and setup. In the reverse operation, while reconnecting, the microgrid needs certain information from the grid for synchronization, particularly voltage and frequency setpoints. With the right controls, synchronization can be achieved relatively quickly, typically in a few seconds, thus making islanding (at least in the case of planned transitions) and reconnection operations seamless, and thereby eliminating the brief outages that might otherwise affect critical end-user loads.

1.7.2 Maintaining Microgrid System Stability and Synchronous Operation

The main power grid dictates the overall system dynamics while in grid-connected mode, due to the much smaller size of microgrids. Thus, the stability analysis of a microgrid in grid-connected mode is similar to that of the larger power grid to which it is connected. Conversely, in an islanded microgrid operation, the system dynamics are represented by the DGs, the fluctuating output of which, coupled with varying load, may pose challenges to the successful operation of the microgrid. Three levels of supervisory control are typically employed for the reliable operation of a microgrid in grid-connected mode—the distribution level, microgrid level, and local level. The market operator and distribution network operator (DNO) are involved at distribution level. MCC handles microgrid level control, and the unit level control is done by local controllers (Faisal and Islam 2017). At the distribution level, signals are dispatched by DNO and market operator. MCC handles communications between DNO and local controller to integrate the microgrid with the main grid. Microgrid supervisory control can be decentralized or centralized as described in an earlier section of this handbook. Appendix 5 lists a comparison between AC and DC microgrid control strategies.

When a microgrid is operating in grid-connected mode, the utility provides a convenient, reliable reference for voltage and frequency to maintain microgrid synchronous operation—i.e., the utility is the isochronous¹² generator reference and all DG and storage resources operate in droop¹³ mode. However, when it is islanded from the grid, it needs to rely on its own internal assets to provide this reference to independently support power quality and accommodate any changes to system voltage levels. Currently, many islanded microgrids employ

¹² Isochronous control mode means that the frequency (and voltage) of the electricity generated is held constant, and there is zero generator droop.

¹³ Droop control mode is a strategy commonly applied to generators for voltage and frequency control to allow parallel generator operation for load sharing.

thermal or NG generators that operate as synchronous machines to provide that isochronous reference, as well as supply reactive power and dynamically regulate system voltages, while other generators, PV invertors, and sometimes, battery invertors operate in droop mode. However, an additional challenge exists for islanded microgrids operating with a significant amount of renewable generation. Such systems are typically completely inverter-based and lack any spinning generators. Therefore, they must rely on an intelligent inverter coupled with battery storage, which will operate in voltage and frequency control mode to provide its own reference points, as well as in conjunction with other devices like static compensators (STATCOM) to supply fast-acting continuous voltage regulation. Managing this process is one of the core control functionalities of a fully renewable microgrid (ABB 2016).

1.7.3 Faults

An electric fault in lay terms is an abnormal current on the grid, something that can result from a variety of reasons including short circuits. Traditional utility grid methods of fault detection do not apply to microgrids due to the bi-directionality of power flow, the need to distinguish between grid-connected and islanded operation modes, and that converters interfacing the DERs provide limited fault current compared to some of the equipment and machinery that might be on the microgrid. Fault detection and design of protection systems are extremely critical areas for microgrids, and currently, there is no standard one-size-fits-all solution. The design-and-process is typically customized to the individual microgrid with several methods or combinations used including differential protection, communications systems, and advanced signal processing algorithms.

1.7.4 Operational Costs

Operational costs in a microgrid can vary widely, but typically have fixed and variable components. Considering strictly operational costs, i.e., excluding maintenance costs, the fixed costs usually accrue mainly from staff salaries, and general and administrative expenses; and the variable costs from energy generation—the latter being essentially the total cost of electricity supplied by the microgrid to its end users. The effective total cost of energy in the microgrid is, therefore, the cost of generation by each source in the microgrid (based on LCOE of the constituent generating DERs), plus the energy purchased from the utility, minus any payment received from the utility for exported electricity and grid services provided to it (by the control of dispatchable generation sources and DSM of controllable flexible loads). This implies that the microgrid's operational costs greatly depend on optimal design of the microgrid's generation mix, and leveraging the economic dispatch of each of these functions during operation.

1.7.5 Maintenance

As in the case of any other product or system or infrastructure, regular maintenance and upkeep is essential to ensure reliable performance over the effective service life of a microgrid. Fixed costs (e.g., maintenance staff salaries) and variable costs (e.g., direct variable costs that include replacement component costs, and indirect variable costs that include substitute backup generation during maintenance shutdown periods) will be incurred for this. The maintenance strategy and procedures of a microgrid are typically carried out by O&M personnel, based on established protocols and intervals such as periodic general maintenance, scheduled preventive maintenance, and data analytics-based predictive maintenance. Given that there are several different microgrid applications, with varying service requirements and grid connectivity scenarios, there is no one-size-fits-all prescription, and the maintenance costs need to be compared to the cost of failure disruption, potential for risk reduction, and reliability enhancement, to yield a quantified financial metric, such as percentage or absolute risk reduction per dollar or expense and/or investment.

The maintenance activities and costs in a microgrid are essentially those of its individual components such as renewable or nonrenewable distributed generation sources, batteries, microgrid control system, sensors, communication networks, distribution system, protection equipment, transformers, and electrical components. For instance, the maintenance procedures for solar PV systems are available in detail from relevant sources, with its annual maintenance cost usually being about 2% of its capital cost.

Like most in operational plants, O&M activities could be do-it-yourself, or entrusted to an O&M contractor, or handled by the integrator who built the plant—each has its pros and cons (Figure 31). This aspect often comes up at the financing stage as part of due diligence on the overall capabilities and credibility of the microgrid developer and operator.

Project Sponsor

California has been a leader among US states in adopting and supporting renewable energy and energy efficiency practices. One such adoption has been demonstrated by Southern California's Metropolitan Water District (MWD). The MWD of Southern California is a public institution established in 1928 to provide reliable water supply to the population (~18 million currently) living within a 5,200 square mile service area within six counties. One of the metropolitan's largest treatment plants is the F. E. Weymouth Water Treatment Plant (Weymouth), a 520 million-gallon-per-day (mgd) facility located in the City of La Verne. Weymouth plant consumed over 10 million kWh of electricity in 2013, and this demand for energy at the plant had increased by over 30% to about 14.4 million kWh by 2016.

Key Considerations

- (i) **Protection against fluctuations in retail electricity markets.** The fossil fuels-based retail electricity market is becoming more volatile due to competition for global natural resources available and increased regulations on carbon emissions.
- (ii) **Climate change concerns.** The electricity procured from retail grid utilities in the region is generated from a combination of fossil fuels and hydropower. As climate change increasingly challenges water reliability, the MWD wanted the greater part of its energy consumption to come from the clean energy solutions.
- (iii) **Prior experience with renewables.** The project sponsor had prior experience of successfully building and operating renewable energy assets for water treatment. The project owner has already in execution two renewable energy assets—a 1 MW solar plant at its Robert A. Skinner Water Treatment Plant in Southwest Riverside County and a 10.5 MW facility at Diamond Valley Lake Visitor Center in Hemet.

Project Description

The 3 MW Weymouth Solar Power installation generates 6.5 million kWh of clean electricity annually. This is consumed onsite and supplies nearly 45% of electricity required to treat water at the site. As a result, consumption of electricity from the grid utility, Southern California Edison, has been reduced significantly at Weymouth, saving energy costs, and reducing greenhouse gas emissions associated with the treatment of water at Weymouth. The solar plant has reduced an estimated \$1 million in annual energy costs of the water treatment plant.

The 3 MW solar power generation facility is ground-mounted and includes a single-axis tracking system that allows the installed panels to track the sun's path from east to west on daily basis. Approximately 15 acres of land space is used by the installation.

Business Model and Commercial Details

The 3 MW solar PV installation was built by the project owner on up-front capital investment model—i.e., the project sponsor invested its own capital resources. The energy generated by the solar installation is used to offset the energy consumption from the grid. The project sponsor will generate return on the capital invested through cost savings realized by replacing expensive electricity purchased on the retail market with captive clean energy generation.

In addition to achieving long-term cost savings, the microgrid installation is estimated to reduce 1,900+ tons of carbon dioxide emissions every year.

Project Background

In the Sub-Saharan Africa region, South Africa is the highest consumer of electricity. Within South Africa, 41% of the demand comes from private sector companies. However, the supply of electricity often falls short of demand. As a result, government has introduced peak demand charges to disincentivize consumption of electricity during particular times of the day when utilities are not able to meet high power demand. Along with this, there are also frequent power cuts. Consequently, many companies have turned to diesel generators for reliable back-up power supply. This causes increased energy costs and reliance on polluting fossil fuels.

Key Considerations

- (i) Quality of electricity is a major challenge for a manufacturing setup. With its round-the-clock operational hours, there can major financial implications if there are power cuts or fluctuating power supply. An ABB facility in Longmeadow, Johannesburg faced one power cut every 3 days, ~10 a month.
- (ii) The electricity supplied from grid is generally coal powered in South Africa and diesel gensets are the primary mode of power backup. This has led to over reliance on fossil fuels for ABB, which had four gensets in place prior to the installation of Solar photovoltaic (PV)-based microgrid.
- (iii) Being a global leader in providing energy solutions, ABB was also motivated to showcase a PV-based microgrid solution for its facility in Johannesburg. Having installed about 40 microgrids globally, it was only prudent for them to find a cleaner solution for their own needs.
- (iv) PV microgrid with battery storage also comes with its cost savings benefits that ABB wanted to realize.

Project Description

ABB has a 96,000-square-meter facility in Johannesburg that houses both the company's national headquarters and a manufacturing facility, with around 1,000 employees. Its electrical loads add up to roughly 1,000 kW, which are connected via a medium voltage grid connection to a local utility.

Four back-up diesel generators (two rated at 600 kilovolt-ampere [kVA] and two rated at 800 kVA) were being used since 2009 for power shortages and short-term voltage fluctuations. As a result of these two issues, its total energy cost in 2015 was \$630,00 including utility charges and diesel fuel costs.

To overcome the challenge, ABB designed a microgrid solution that included a control system and 750 kWp rooftop solar PV system with the support of a 1 megavolt-ampere (MVA)/ 380 kWh PowerStore Battery based on lithium-ion (Li-ion) technology. The number of diesel gensets reduced to two 600 kVA diesel generators. This is grid-connected microgrid that can island and go off-grid as needed.

Business Model and Commercial Details

The primary financial driving factor for this ABB microgrid was cost savings. With this new microgrid, it was estimated that diesel consumption would be reduced by 27%, running time for generators would be reduced by 75%—from 433 hours to 106 hours. This effectively would lead to a reduction in energy costs from \$610,000 to \$460,000 per annum. That translates into a cost saving of ~25%.

In addition to achieving long-term cost savings, the microgrid installation is estimated to reduce 1,000+ tons of carbon dioxide emissions every year.

2 Business Models and Financial Analysis

2.1 Business Model for Grid-Connected Microgrids (Including Technology, Financing, Stakeholders)

Business models and financial and economic analyses are necessary to arrive at an appropriate investment and scale-up structure for grid-connected microgrids. The following business models are typically employed for microgrids to meet relevant pricing options and financing implications:

- (i) customer-owned (up-front capital investment)
- (ii) renewable energy service company (RESCO)-owned
- (iii) utility-owned
- (iv) cooperative-owned
- (v) community-owned
- (vi) pay-as-you-go (PayGo – typically rural remote minigrids)
- (vii) remote (non-grid connected)

Key considerations for business model evaluation and selection are:

- (i) availability of capable and experienced RESCOs locally and their interest in implementing clean energy microgrids in addition to their preferred business-implementation-investment model;
- (ii) security of financial flows to the investor or financier;
- (iii) cost and flexibility to end user and market demand and alignment;
- (iv) LCOE;
- (v) internal rate of return, net present value, and debt service coverage ratio of various business models;
- (vi) international best practices and local affordability;
- (vii) regulatory barriers and enablers such as requirements for a private entity to obtain electricity generation and distribution license from the government; and
- (viii) stakeholder mapping to determine each of their roles and responsibilities.

Financial analysis will help

- (i) determine if a financial investment in the renewable energy asset for a particular site is feasible,
- (ii) determine the business model that provides the highest cost savings to the relevant stakeholder or investor (RESCO or an investor or consumers), and
- (iii) demonstrate potential risks to future revenues or debt servicing and to quantify these risks through sensitivity analyses.

2.2 Business Model Evaluation and Selection

Choice of business model, through which the microgrid asset shall be built, operated, and maintained, is an important pre-development consideration irrespective of technology choice. Business model choices are typically between up-front capital investment model and the RESCO model. Within the RESCO model, variations exist, such as build-own-operate (BOO), build-own-operate-transfer (BOOT), lease-to-own, and PPA models. Among others, the two key considerations in the choice of business model are:

- (i) responsibility of making up-front capital expenditure investments for the microgrid asset, and
- (ii) responsibility of carrying out O&M throughout the useful life of the microgrid asset.

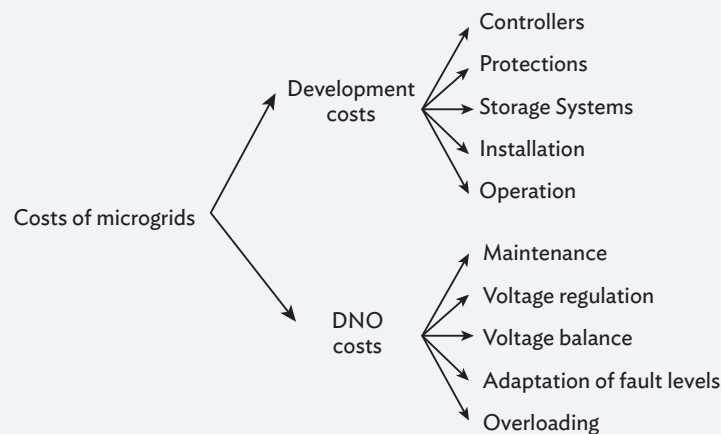

2.3 Financial Analysis

A financial and economic analysis of microgrids requires a study of their benefits and costs to the microgrid owner or operator and the utility or DNO (Figure 32).

Figure 32: Classification of the Costs Related to Microgrids



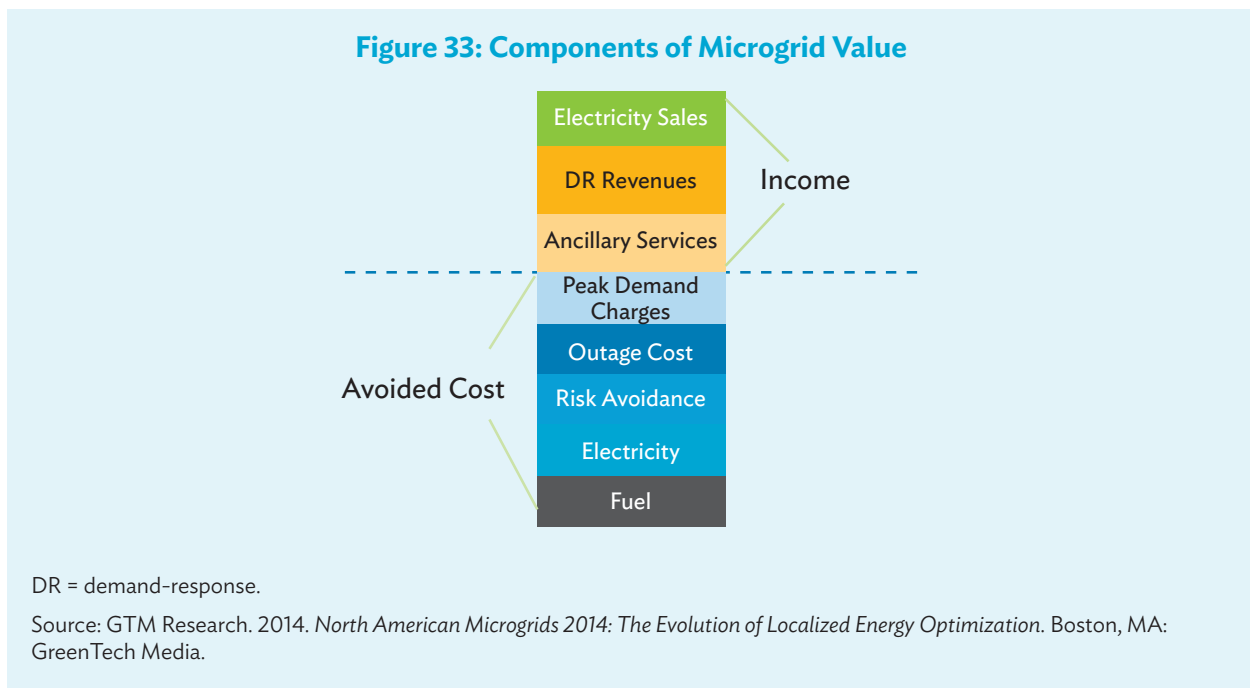

The key parameters for the financial analysis are listed below:

- (i) capital costs
- (ii) O&M costs
- (iii) LCOE
- (iv) revenue streams and qualitative analysis of benefits
- (v) financial and economic returns
- (vi) return on investment and payback period
- (vii) funding sources and structures
 - (a) monitoring of project outcomes
 - (b) tailored financial instruments
- (viii) basic analysis methodology and examples of financial and economic analysis for each business model.

Revenue streams accruing from a microgrid are shown in Figure 33.



$$\text{MICROGRID VALUE} = \text{AVOIDED COST} + \text{INCOME} - \text{CAPITAL COSTS} - \text{OPERATING COSTS}$$

Microgrid value is typically shared among utilities, end users, third parties, or co-owners depending on the ownership and operating model. For instance,

- (i) In universities and public institutions, income streams arise from a large variety of loads that, if controlled, allow for DR and grid services. Avoided costs accrue from reduction in potential outage cost given the high reliability needs for research facilities and public safety facilities (such as airports and public transportation).
- (ii) Commercial and industrial units often do not create significant income streams, but the avoided costs accrue from a high demand charge reduction potential and reduction in potential outage cost (such as lost revenues and manufacturing delays).

Since all of the business models described in the previous section can be largely categorized either under up-front capital investment model or RESCO model, this financial analysis section focuses mainly on these two models. Both models will achieve cost savings (to varying degrees) to the consumer.

In the up-front capital investment model, the consumer makes the up-front investment, but all the electricity generated by the renewable energy asset is essentially free. Such a model involves

- (i) one-time, large cash outflow – capital expenditure,
- (ii) smaller but recurring cash outflows – O&M,
- (iii) larger but periodic cash outflows – equipment replacement cost, and
- (iv) recurring cash inflows in the form of cost savings – total cost of electricity generated that the consumer would have otherwise paid to the grid electricity utility or for operating diesel generators in the absence of microgrid asset.

On the other hand, in the RESCO model, the consumer does not make any up-front investment, but will pay for use of electricity generated by the renewable energy asset as per the agreement with the RESCO. Such a model involves

- (i) recurring cash outflows – price that the consumer will pay for electricity to the RESCO, as agreed in a PPA or lease or similar contract;
- (ii) recurring cash inflows in the form of cost savings – discount in the price per kWh of electricity (if a PPA is signed) or general reduction in monthly electricity usage costs when compared to grid electricity or diesel generators (whichever is applicable as baseline).

Since cash outflows and inflows—both quantum and frequency of occurrence—significantly vary between the two models, the methodology used to conduct financial analysis also varies.

2.3.1 Financial Analysis Methodology for Up-Front Capital Investment Model and Renewable Energy Service Company

Table 8 presents the summary of the methodology for financial analysis for both up-front capital investment and RESCO models.

Net Present Value Methodology

The NPV methodology is a useful financial tool to identify the feasibility of financial investments and to quantify the financial benefits to the investor. NPV is the difference between present value of cash inflows and present value of cash outflows over a period of time due to an investment. The formula is:

$$\text{NPV} = \text{Present Value (Cash inflows)} - \text{Present Value (Cash outflows)}$$

In short, the NPV methodology computes total gain or total loss that an investor stands to incur, in today's currency value, factoring in time value of money. If the NPV of an investment is positive, then the investment is considered to be value accretive, and hence, the proposed project investment can be approved. On the other hand, if NPV of an investment is negative, then the investment is considered to be value destructive and hence, the proposed project investment should be rejected, or other modalities such as capital subsidies need to be explored. If the NPV is 0, then the project investment is neither accretive nor destructive.

Financial Internal Rate of Return Methodology

Financial internal rate of return (FIRR) provides the rate at which a project generates financial return to its investors. Similar to the NPV methodology, the FIRR methodology also accounts for time value of money. But instead of presenting the output as a value in today's currency value, the FIRR methodology instead provides an easy to use percentage (%) based return calculation metric.

In general, if the FIRR is higher than the weighted average cost of capital of the project owner or investor, then the project is considered to be value accretive. On the other hand, if the FIRR is lower than the average cost of capital of the project owner, the project is considered to be value destructive.

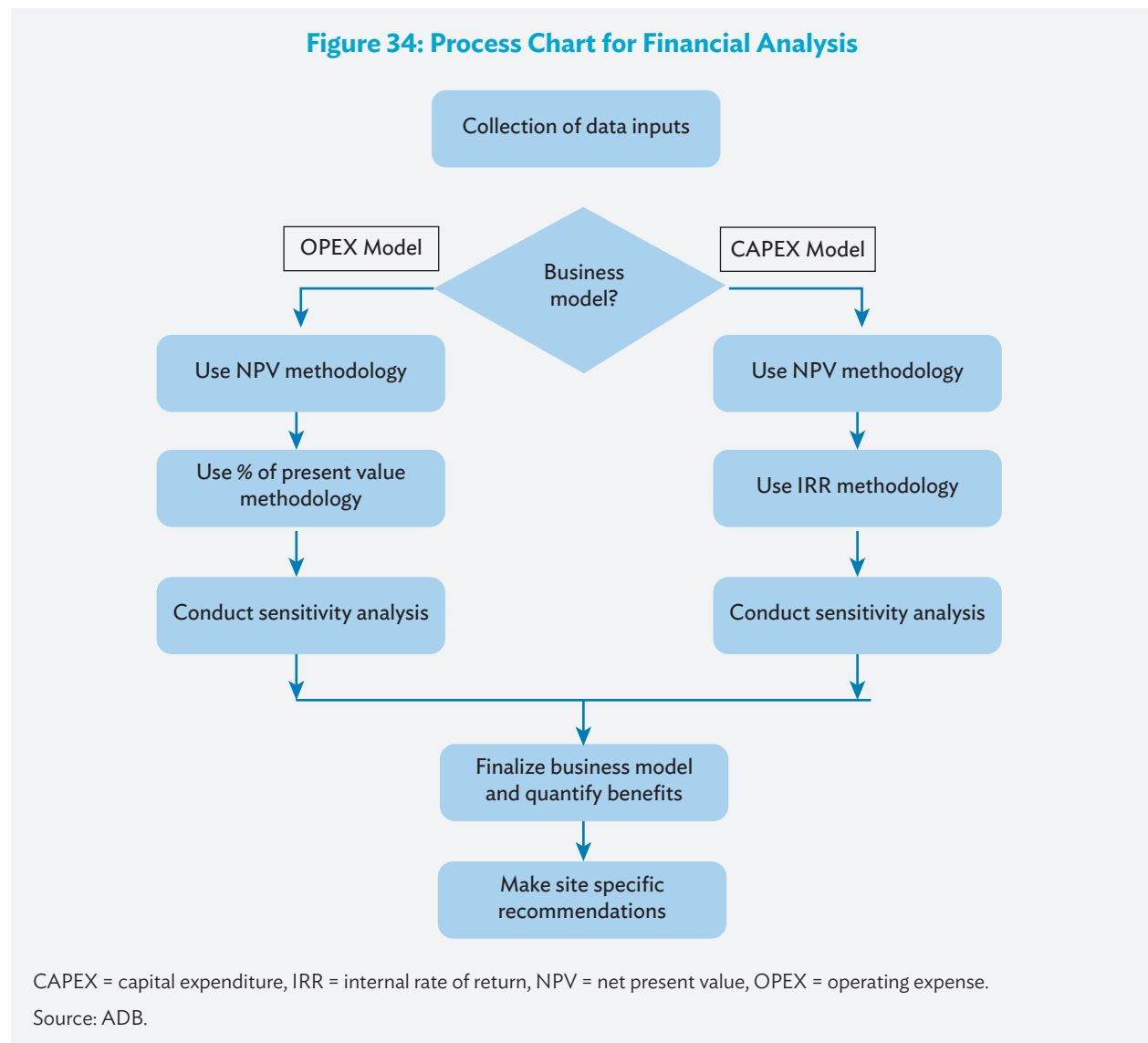
Using Sensitivity Analysis

Although FIRR and NPV methodologies are widely used while taking project finance decisions around the world, sometimes the actual results may vary from estimations and projections. The variations are a result of the assumptions that are used to calculate NPV and FIRR values. When the assumptions made deviate from actuals, the resultant NPV and FIRR values also deviate.

Hence, it is prudent that a sensitivity analysis is carried out and that results of this sensitivity analysis are also a part of the decision-making process. A sensitivity analysis provides a narrow set of possibilities for NPV and FIRR, should the key inputs deviate from initial assumptions.

Process for Financial Analysis

Figure 34 depicts the process that will be followed in the financial feasibility analysis methodology for both up-front capital investment model and RESCO models.



2.3.2 Inputs for Financial Analysis Model for Up-Front Capital Investment Model

In the up-front capital investment model, NPV and FIRR are the two parameters or metrics that are best suited to decide if the investment is financially beneficial to consumers, and quantify the financial savings that the consumer stands to generate by switching to renewable energy from their existing source of electricity (grid or diesel generators).

To conduct a financial feasibility analysis based on NPV and FIRR, the following operational and cash flow-specific inputs are required.

Operational Inputs

- (i) number of units (kWh) of electricity generated per annum by the proposed renewable energy asset;
- (ii) annual degradation factor (%) in output of proposed renewable energy asset;
- (iii) cash outflows;
- (iv) capital cost, either in total or in cost per Wp or kW of main electricity generating equipment (solar PV modules, etc.);
- (v) balance of systems including inverters, batteries (if any), transformers (if any), T&D lines, charge controllers, as applicable;
- (vi) cost of civil works, logistics, labor, etc. as applicable, apart from applicable taxes and duties;
- (vii) annual O&M expense;
- (viii) inflation-adjusted replacement cost of key components such as batteries and inverters as applicable;
- (ix) inflation-adjusted cost of spares and repairs expected;
- (x) insurance cost; and
- (xi) dismantling cost of the system.

Cash Inflows (in case of existing power source = grid)

- (i) current price per unit (kWh) of electricity consumed from the grid, including peak/off-peak consumption tariffs and average consumption in kWh at each of these tariff categories;
- (ii) monthly/annual fixed charges based on connected load, if any;
- (iii) grid usage and other charges, as applicable;
- (iv) average expected increase in price per unit (kWh) of electricity, based on historical averages and market-based projections; and
- (v) other charges, taxes and levies in connection to maintenance of the grid connection, if any.

2.3.3 Inputs for Financial Analysis Model for Renewable Energy Service Company Model

In the RESCO model, NPV methodology is best suited to decide if the investment is financially beneficial to the consumers as well as the RESCO and quantify the financial savings that consumers stand to generate by switching to renewable energy from baseline source of electricity (grid or diesel generators).

To conduct a financial feasibility analysis based on NPV methodology, the cash flow-specific inputs mentioned below are required.

Cash Outflows

- (i) price per unit (kWh) of electricity as agreed in a PPA or lease payments agreed in a lease-to-own agreement;
- (ii) escalation per annum (or any other period as agreed, in percent) in PPA unit price as part of the escalation clause in the PPA, if any or lease payment escalation, if any;
- (iii) security deposit extended to the RESCO as part of the PPA or lease agreement, if any;
- (iv) O&M cost per period to be paid to the RESCO as agreed separately in the PPA or lease agreement, if any (typically included in PPA price or lease payment); and
- (v) replacement cost of spare parts per period as agreed separately in the PPA or lease agreement, if any (typically included in PPA price or lease payment).

Cash Inflows (in case of existing power source = grid)

- (i) current price per unit (kWh) of electricity consumed from the grid, including peak/off-peak consumption tariffs and average consumption in kWh at each of these tariff categories;
- (ii) monthly/annual fixed charges based on connected load, if any;
- (iii) grid usage and other charges, if any;
- (iv) average expected increase in price per unit (kWh) of electricity, based on historical averages and market-based projections; and
- (v) other charges, taxes and levies in connection to maintenance of the grid connection, if any.

2.4 Economic or Cost–Benefit Analysis

Economic analysis refers to analysis of costs and benefits flowing to and from the broader economy. This could mean (depending on the project context) quantifying nonmarket and/or non-cashflow benefits, internalization of externalities, and/or accounting for subsidies. Economic analysis generally includes the following:

- (i) quantifiable economic benefits that would typically include cashflow and non-cashflow benefits; for example, an on-grid microgrid installation would typically reduce electricity costs of the consumer (direct cashflow benefits), but may also create additional jobs locally and/or reduce carbon emissions (indirect non-cashflow benefits);
- (ii) the economic net present value of the project as well as economic internal rate of return; and
- (iii) the outcome of the sensitivity analysis.

While financial analysis includes the cost of the project as paid by the project developer and the benefits of the project to the project developer (as revenues or cost saving), economic analysis includes costs and benefits of the project to the broader economy or society (and not just to the project developer or consumer).

Economic analysis could use nominal or real prices provided that the discount rate is consistent with the choice made.

2.5 Microgrid Policies and Regulations in Asia

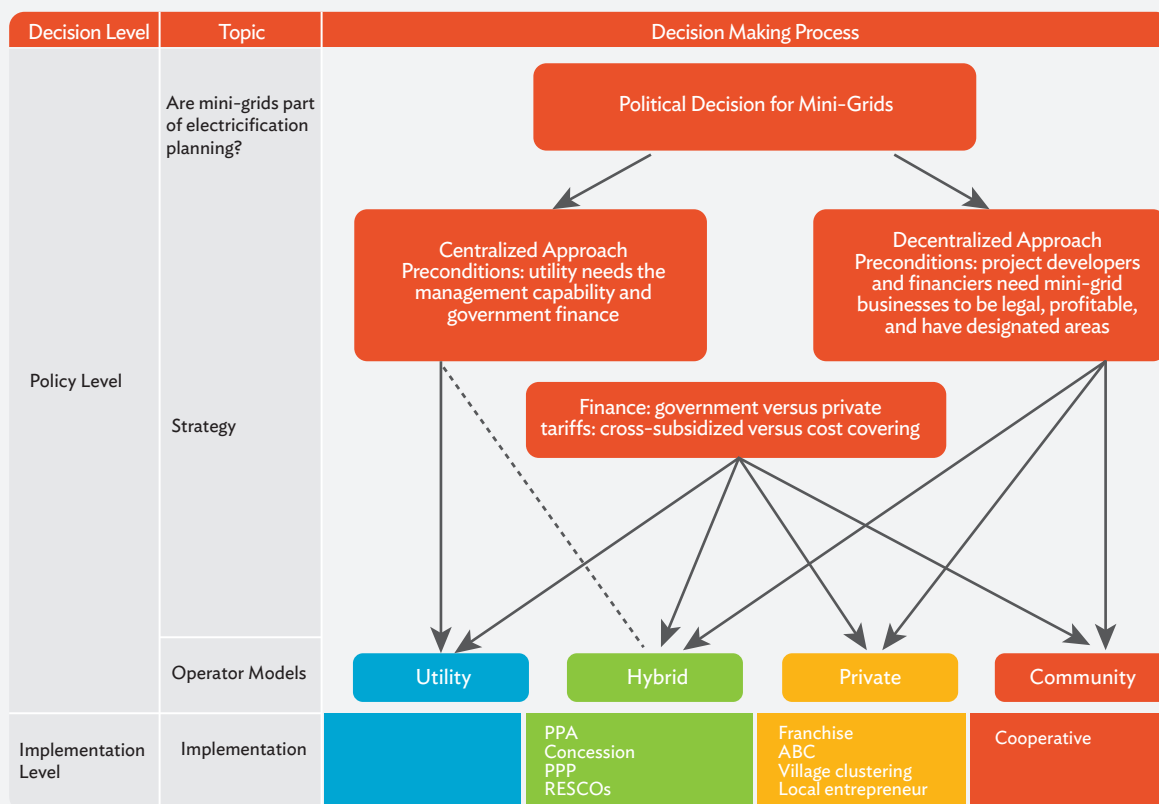
Microgrid policies and regulations vary across Asia, and some countries, such as Japan, the PRC, and Thailand have supportive policies and/or pilot programs for urban and industrial microgrids whereas others have yet to introduce such policies. Several countries such as Bangladesh, Cambodia, India, Indonesia, Maldives, Myanmar, Nepal, and the Philippines have developed and implemented off-grid minigrid policies for increasing access to energy. Including grid-connected or off-grid microgrids as a policy within a country's power or energy system needs to be a strategic decision-making process (Figure 35).¹⁴

Some of the key policy and regulatory enablers for urban and industrial microgrids are:

- (i) **Specific urban and industrial microgrid policy.** A specially defined policy for urban and industrial microgrids would help facilitate private and public sector investments, as well as provide stability for such microgrid. This policy should clearly define the goals of deploying urban and industrial microgrids, provide technical specifications and standards, identify eligible consumers, determine grid interconnection norms, tariffs, and licensing and documentation requirements. So far, only developed countries such as Japan and the Republic of Korea, and upper middle-income countries such as the PRC

and Thailand have defined such policies or programs in Asia. Other developed countries such as the US and a few European countries have also defined such policies and programs.

- (ii) **Net metering or gross metering policies.** Net metering or gross metering policies enable microgrids to be connected to the national grid and export excess electricity to the grid. Such policies enable urban and industrial renewable energy-based microgrids to use the grid instead of the expensive battery or energy storage solutions, to increase their autonomy. This will also improve their economics by supplying excess electricity to the grid for economic considerations (net or gross metered). While net or gross metering for stand-alone, single customer rooftop, or ground-mounted solar installations are available in many developed and developing countries in Asia, these have not yet been defined for microgrids in most countries.
- (iii) **Technical standards and specifications for grid interconnection.** This would allow microgrids to design and plan according to specified technical standards and hence, manage grid interconnection technical design and costs more reasonably. While grid interconnection norms for stand-alone, single customer rooftop, or ground-mounted solar installations are available in many developed and developing countries in Asia, these have not yet been defined for microgrids in most countries.
- (iv) **Open access or contestable consumer model.** Open access policies and regulations allow electricity consumers—typically only large C&I consumers (known as contestable consumers)—to choose their

electricity service provider, rather than being confined to purchasing electricity from a government-owned or private monopoly utility. Such contestable consumers are often served by open access developers or merchant power plants that develop and install these assets either remotely or locally, as onsite rooftop solar or microgrid installations and using national grid T&D infrastructure to supply electricity. Countries such as India, the PRC, the Philippines, and Singapore have such regulations in place, whereas countries such as Viet Nam are in the process of introducing similar policies. Nevertheless, treatment of open access and/or contestable consumers by onsite microgrids is still not defined in most countries of Asia, and such clarity would enable more microgrid investments.

- (v) **Simpler electricity generation and distribution licensing.** In many countries, electricity generation and distribution is still a highly regulated and licensed activity and requires complex documentation and approval process for microgrid developers to obtain such licenses. Simplifying these regulations would increase developers' interest in setting up microgrids.
- (vi) **Feed-in-tariffs and other financial incentives.** Tariff support and other financial incentives such as subsidies and tax benefits for microgrids would enable developers to deploy microgrids even for consumers where financial viability without such incentives is a barrier.
- (vii) **Risk-sharing mechanisms for debt financing.** Considering the limited understanding and interest from commercial banks and lenders in many developing countries to finance microgrids, any risk-sharing mechanisms, such as credit guarantees or blended finance structures, could help microgrid developers raise debt finance at affordable interest rates.

Financing models typically follow local policies and regulations (Table 9).

Financing of microgrids in most countries go through the transition depicted in Table 10 wherein they start with mainly grant or subsidy-based financing and gradually move toward commercial investments as business models and financial viability are established.

The financial viability of microgrids is subject to a number of risks and mitigating these risks with suitable measures is important to ensure bankability. Some of these risks and possible mitigating measures are described in Table 11.

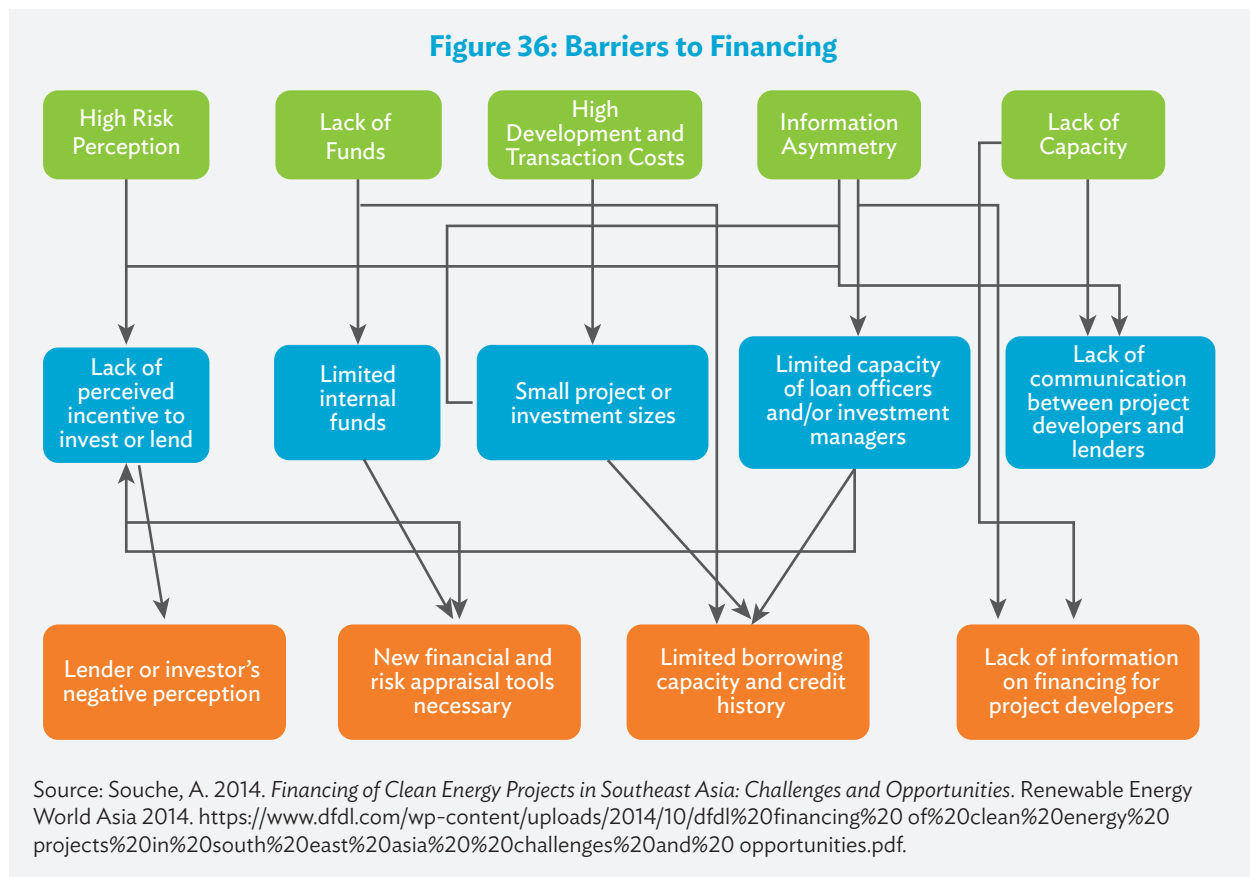

Nevertheless, many of these technology, regulatory, and business risks manifest into barriers to achieving bankability and financial close of microgrid projects (Figure 36).



Both project developers and lenders can develop several measures to reduce financial viability and bankability concerns and risks of financing microgrids. Some of them are described in Table 12.

Capacity Building

Many DMCs, ministries, government agencies, and utilities in Asia that develop, promulgate, and implement microgrid policies tend to lack the necessary technical knowledge and trained staff. Government-owned utilities, project developers, and IPPs also lack the technical capacity required to identify suitable locations for microgrid projects, conduct detailed feasibility studies, and develop detailed project reports (DPRs) that are bankable. Many of these project developers are new to the microgrid or renewable energy sector and lack the capability to complete the required feasibility studies; find sufficient financing; and implement, operate, and maintain projects. Additionally, there is limited or no access to startup capital that is required to finance feasibility studies and develop DPRs. There is a lack of local capacity—technical experts, equipment suppliers, and EPC contractors—for microgrid project development and deployment in many of these countries.

Knowledge management and capacity building activities are an important area of support for DMCs in Asia on microgrids. Although developing countries in Asia have started to take the lead in urban and industrial microgrids at scale, this is limited to few countries such as Japan, the Republic of Korea, the PRC, and Thailand. There is a clear gap in understanding the factors that influence the success or failure during the process of developing bankable projects in developing countries of Asia. Developing knowledge products such as handbooks, and toolkits, and organizing a series of workshops, roadshows, and investment fora to disseminate the policymaking, project development, and implementation experience among DMCs is necessary to increase the deployment of microgrids in Asia.

Microgrid-related technical, operational, and other skills development within ADB member countries is also an important activity, given the lack of trained personnel for project implementation. Skills development is required at different levels and skill requirements vary depending on the type of projects. For example, deploying grid-connected microgrids requires different skills than designing large solar parks. Needs and current skill levels in DMCs have to be considered before designing and deploying training and capacity building activities.

Project Background

Formerly known as the Ladrone Islands, the Wanshan Archipelago is a 104-island archipelago that is part of the Xiangzhou District of Zhuhai in Guangdong Province, PRC. Wanshan Archipelago is a prominent tourist vacation spot. Da Wanshan island is a part of Wanshan Archipelago. At the time that this microgrid was conceived, the population of the island was 300 and its land area is 8.1 km². Main industries on the island are fishing and tourism.

Da Wanshan's main source of power supply was diesel generators that cost ~\$0.56 (CNY~3.5) per kWh as compared to the cost of grid electricity of \$0.07 (CNY 0.5) per unit in Guangdong Province. Diesel power on the island also had low reliability. Load demand was seasonal, with high demand from May to October (tourism season) and low demand in November to April periods. Peak load on the island was 810 kW with 59% of load between 200 kW to 400 kW.

Key Considerations

- (i) The PRC's National Smart Grid Project wanted to set up demonstration microgrids based on renewable energy to assess their suitability for island populations. Renewable energy-powered microgrids were considered for their economic feasibility and environmental friendliness.
- (ii) Increasing demand for power supply by residents of the island with its growing attraction in the tourism circuit required increased reliability of electricity.
- (iii) Under the National Grid Project model, the government also wanted to explore new energy-utilization models backed by sound financial or economic incentives that can be later replicated to other areas with similar needs and requirements.

Project Description

The Wanshan Island New Energy Microgrid Demonstration Project was set up under the National Key Smart Grid Project, with an aim to build the smart microgrid for Guishan Island, Dong'ao Island, and Dawanshan Island.

The microgrid setup at Da Wanshan island consisted of one wind generator with 850 kW capacity, solar PV arrays with 200 kWp capacity, lead-acid battery with 2,000 kWh capacity, power conditioning system with 1,000 kW, and two diesel generators with 500 kW capacity each.

Business Model and Commercial Details

Da Wanshan island microgrid was set up by State Grid Corporation of the PRC with Singyes Solar as the main EPC contractor. The microgrid was set up with a capital expenditure of \$2.78 million.

As the payback period for the project is more than 25 years, subsidies from the government are needed to make this project commercially viable. Based on a case study,^a this microgrid would be commercially viable under one of the two scenarios:

- (i) A capital subsidy of the amount of 70% of initial investment, which would result in payback period of 8.15 years.
- (ii) An operational subsidy of \$0.065 per kWh of electricity for 10 years, which would result in a payback period of 8.31 years.

Project Description

The Nagoya landfill microgrid facility is a 500 kW solar power generation unit located at Nagoya in Japan. The microgrid installation is backed up by a 200 KW battery storage system. The microgrid was considered and constructed to increase the value proposition of the property for landfill owners. The leading developer for this project was Optimal Power Solutions of Australia. Due to their low cost at that time, lead-acid batteries were chosen, but the project investors envision to replace the battery bank at the end of their life or after approximately 6 years of initial commissioning, with lithium-ion batteries, given their rapidly falling prices.

With its battery based long-duration dispatch of solar PV energy, this microgrid provides firm capacity to the grid during peak demand periods, and in case of a grid outage, it also offers a resilient power source to local loads. As the local utility feeders are saturated with solar PV, the value that additional solar PV can bring in the late morning and early afternoon was limited. At the same time, since there is a strong impetus in Japan to reduce reliance on imported fossil fuels and to phase out large centralized nuclear power plants, distributed solar PV is a top priority for utilities and regulators. In such a situation, a special FiT was agreed for installations such as these. Import of electricity from grid is not allowed. Therefore, a one-directional inverter has been installed. During the peak net load period, typically between 4 p.m. and 9 p.m. and sometimes as late as 2 a.m., the battery bank discharges to supply electricity to the grid. The battery bank is rated for 6 hours. However, sometimes it also discharges for 8 hours to 10 hours.

Navigating through the intricacies of Japanese utility interconnection requirements was one of the biggest challenges for the developer given the nature of DER and their high occurrence in the Japanese grid.

Key Considerations

- (i) As described in the *Microgrid Analysis and Case Studies Report* by California Energy Commission, the 2-acre host site is a landfill. In this case, the site is paved with about 6 feet of soil under it. As most types of construction were not possible on such a site, a microgrid installation was the most appropriate and opportunistic use of this land.
- (ii) Within a tightly regulated electricity market, the utilities and regulators in Japan are in a contrasting situation where they have to reduce dependence on fossil fuels and nuclear power plants on one hand and encourage take-up of renewable energy on the other. However, given the intermittent nature of renewable energy it is difficult to integrate renewable energy power assets into the grid. With Nagoya Microgrid fulfilling both the needs of the utility, to have renewable energy and peak demand capacity through battery discharge, the project was commissioned with special FiT.

Business Model and Commercial Details

Approximately 10% of the funding for the project was made by the primary project sponsor. A third party financed the remainder in lieu of routine payments over the 15-year lifetime of the project. A challenge faced during financing was that FiT is not fixed and can vary with time. Special tariffs paid by the utility is the primary revenue stream for this project. Simple payback for this project is estimated to be around 4 years.

3 Future Development

3.1 Role of Microgrids in the Electricity Ecosystem of the Future

3.1.1 Decarbonization, Digitalization, Decentralization, and Non-Wires Solutions

Decarbonization, Digitalization, Decentralization (collectively often referred to as 3D) has become the buzzword approach to next generation electricity networks. While a century ago, centralized electricity production made huge progress in economy and civilization possible, including improved economies of scale and power plant efficiency, in the current scenario, it is 3D that could help address today's energy challenges including an optimized way to access reliable, resilient, clean energy (Figure 37). An important approach within this framework is microgrids, especially smart and connected microgrids that create a locally and/or regionally interconnected energy system incorporating DERs, loads, storage, control, and energy management. Consequently, several studies and expert opinions point to microgrids as the technically feasible solution to contribute to the energy transition. Microgrids provide an accessible practical pathway in improving energy accessibility, independence, supply reliability and resiliency, flexibility, and cost optimization. They have the ability to participate in grid balancing DR incentive programs and expanding the adoption of intermittent renewable clean generation like solar PV and wind. Technical advances in the microgrids core constituent technologies (Section 1), especially monitoring and communications, have been key to making this possible.

A non-wire solution (NWS) is an alternative approach to electricity ecosystem evolution, which is fundamentally aligned to the 3D philosophy. Navigant (2017) describes NWS as: "An electric grid project or infrastructure investment using nontraditional T&D solutions, such as DG, DER, energy storage, DSM, DR, energy efficiency, microgrids, and grid software and controls, to defer or replace the need for specific equipment upgrades, such as new transmission lines or transformers, by reducing the load at substation or circuit level."

Traditionally, when a regulated utility needs to replace or upgrade T&D infrastructure, new equipment would be procured and installed, and the regulators would adjust the electricity pricing to allow the utility to earn a fair rate of return on the new infrastructural investment. Usually, other alternatives were not examined, and it was considered equipment upgrade or replacement expenditure, part of the cost of doing business. However, as grid management and DER technologies advance, the same drivers as for microgrids (affordability, reliability, and environmental benefits, as described in Section 1 of this handbook) are resulting in nontraditional solutions such as NWS (of which microgrids themselves are an important component) being explored to achieve the required T&D objectives.

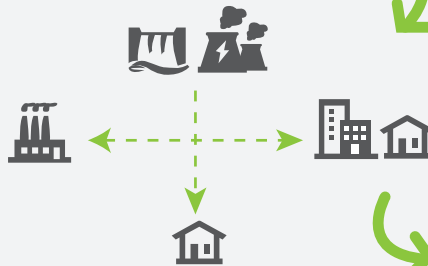
As a flip side to the position taken in this subsection, and as we will see in the next subsection 3.1.2, while 3D and NWS (including microgrids) hold an important place in the electricity ecosystem of the future, conventional T&D capacity will still play a role. Essentially, costs, time, and functionality in implementing 3D or NWS need to be initially assessed, and compared to conventional T&D. While in many instances 3D or NWS will win, it is a key analysis toward balancing the consideration of centralized versus decentralized in fulfilling a utility's mandate to provide affordable, reliable, and safe service to its customers.

The grid is enlarged, enabling frequency control and improved reliability. The size of energy plants increases, improving production efficiency.



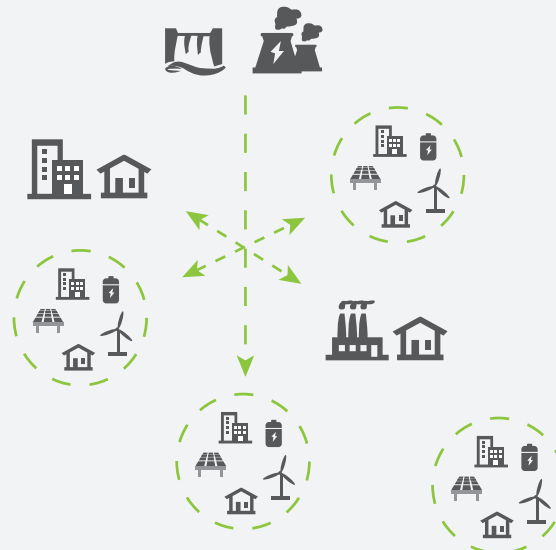
20th century:

3.1.2 The Flip Side: A Case for Continued Addition of Transmission Capacity

It has been argued in some quarters that due to minigrids and microgrids, new transmission grid investments have become less important. This may be relevant only for the specific context of rural minigrids. As a holistic strategy, if the intent is to increase the level of renewable energy penetration in the grid, then adding transmission capacity also has a key role to play to complement grid edge investments in distribution networks and microgrids. If we consider a high level of renewables penetration (which are almost always intermittent if excluding hydropower) to be the backbone of our electricity system, the following points become pertinent:

- (i) Good solar resource and good wind resource are often at different locations, so while they complement each other in terms of time of day, that electricity still needs to be transported over long distances. This needs adequate transmission capacity, and when the transmission is intercountry, the role of regional cooperation and integration becomes important.
- (ii) To generate electricity from renewables requires a lot of land. This land tends to be farther away from the population centers and load centers. On the other hand, urban areas having large demand lack the land for renewables or the land is prohibitively expensive. This scenario also requires a grid to transmit power over longer distances. For example, solar PV panels on every single US rooftop would provide only 40% of the total power requirement. A target like 90% renewables would still need doubling of the current transmission capacity (Schneider Electric 2016). Proof of this is that Texas has become the largest wind power state in the US by building transmission to evacuate the renewable power. In addition, although solar power can be quite modular and distributed, other renewables (e.g., wind, offshore wind, geothermal, hydro) are more cost-effective at scale. As such, there will be a need for transmission of larger power generation sources to load centers. This is why distribution level investments alone may not be enough for the future scenario, rather it needs to be a mix of more transmission capacity in conjunction with grid edge investments like microgrids.
- (iii) If we target electrifying the transport sector, additional transmission would be needed. For example, Tesla super charger for trucks is rated at 2 MW, which needs electricity in the magnitudes described above—even more so if the building heating and district heating sectors were considered by an extension of this logic.
- (iv) According to a recent study (Brattle Group 2019),¹⁵ an additional \$30 billion to \$90 billion of additional transmission would be needed by 2030 in the US alone (20%–50% over the past 10 years' levels), and \$200 billion to \$600 billion by 2050 (50% to 170% increase over the current levels). Transmission line approvals, land acquisition, and financial closure (payback model) are complicated, so transmission projects face the risk of getting delayed. Another disadvantage is the “single point of failure” type loss of resilience when fault in large transmission line. Undergrounding reduces some of the problems of transmission line fault, but is much more expensive.

Thus, 3D and microgrids should be considered a complementary building block, rather than disruptive, to the centralized grid in developing countries as well.

3.1.3 Microgrids: Key Relevance to the Transportation Sector

Apart from the electricity supply sector itself, the EV transportation ecosystem is a foundational sector that deserves specific highlight, as this is an area where microgrids have an enormous ability to help transform. This is partly because of the sheer size of the sector. Worldwide, transportation as a whole consumes over 30% of primary energy, and electrifying only a small percentage of this in the coming years would translate to a lot of capacity. To ensure adequate energy, this new charging infrastructure will have to be installed on the utility grid in

combination with grid edge technologies, like DERs and energy storage. But sometimes, utility support might not be possible, and in such cases microgrid infrastructure can fill the gap to enable charging stations to cater to the charging demand. In addition, a decentralized infrastructure will allow the many actors in the EV ecosystem to capitalize on the flexibility of EVs. One promising way to do this being “vehicle-to-grid” (V2G), wherein EVs can sell DR services to the power grid, either by throttling their charging rate or even returning power to the grid.

One of the fundamental impediments to growth of the EV ecosystem is the lack of better aligned business models and pricing structure associated with the sale of energy. This results in the paucity of readily available charging stations. The current EV charging infrastructure is as “dirty” as the local utility grid is, and new energy solutions, including renewable energy, energy storage and microgrids, if integrated, can enable a more robust, widespread, and cleaner EV charging infrastructure.

In summary, the reliable EV charging infrastructure that microgrids can enable is something that needs to be widespread and readily available, to truly enable a vibrant EV ecosystem. In addition to workplaces and communities, EV charging stations will need to be developed in three key types of locations: at destination points, along highways, and near public transportation nodes like airports, and bus and train stations.

3.1.4 Relevance of Microgrids to the Current Power System Situation in ADB Developing Member Countries

The current power system situation, in terms of both technology level and regulations wise, varies significantly across ADB DMCs. In general, power consuming end users in developing countries typically do not have access to high-quality reliable power and have to contend with frequent power outages, in contrast to their counterparts in developed countries. Developing countries also often have weak grid infrastructures due to underinvestment and poor management, leading to high power losses and theft, thereby hindering the success of business and industry and depriving people of a better quality of life. This is the value proposition for grid-connected microgrids in developing countries, and the reason why the indirect costs of the status quo outweigh the huge initial investment required to change it. Furthermore, grid-connected microgrids are the building blocks of smart grids and smart supergrids, which have the potential to help developing countries leapfrog, by revolutionizing the power sector, similar to what the internet did to information.

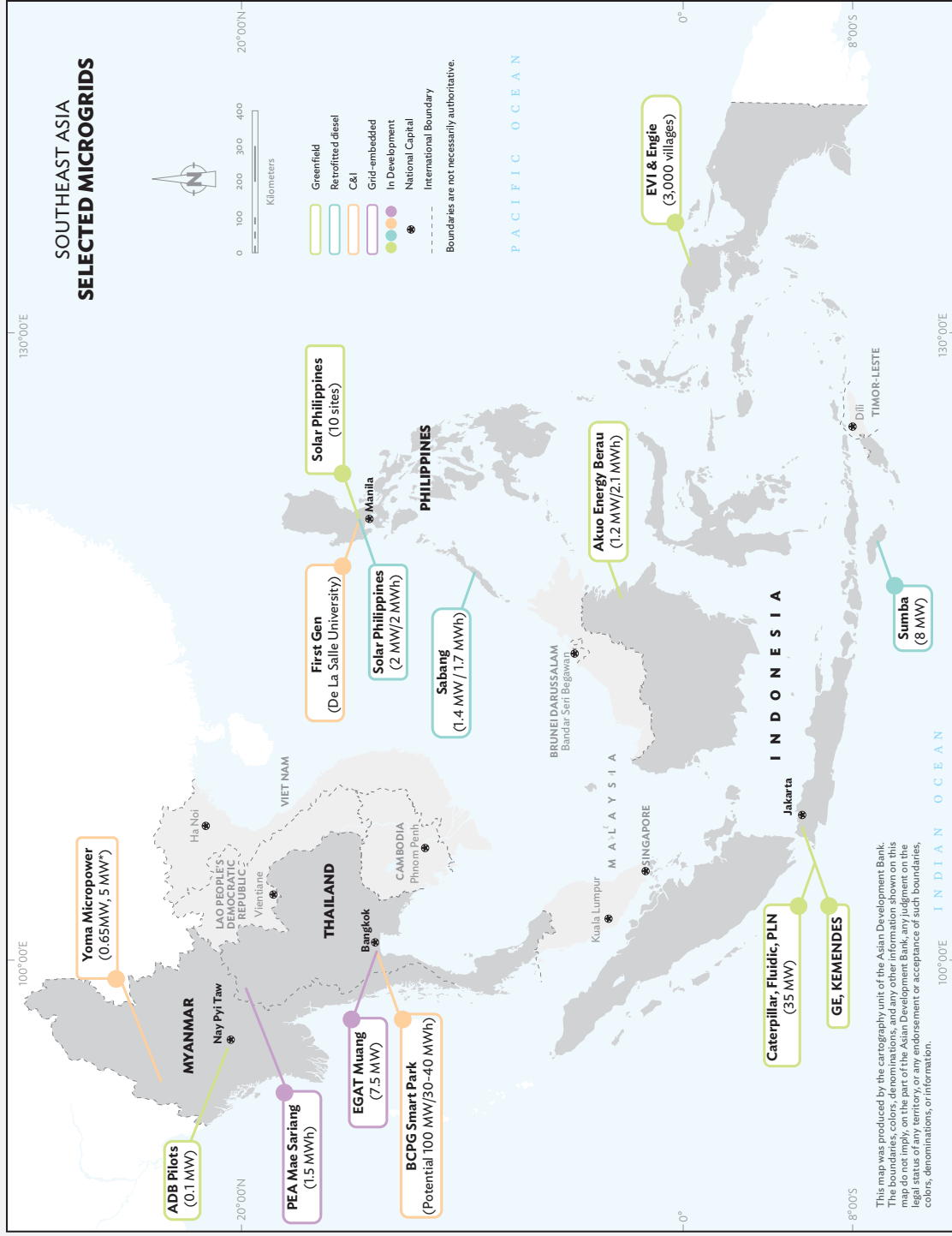
For the above reasons and to address one or more of the various drivers described in Section 1, grid-connected microgrids are well suited for deployment in practically all the ADB DMCs. Microgrid applicability in selected ADB DMCs is summarized in Table 13, and selected microgrids in ASEAN are shown in Figure 38.

Figure 38: Selected Microgrids in Association of Southeast Asian Nations

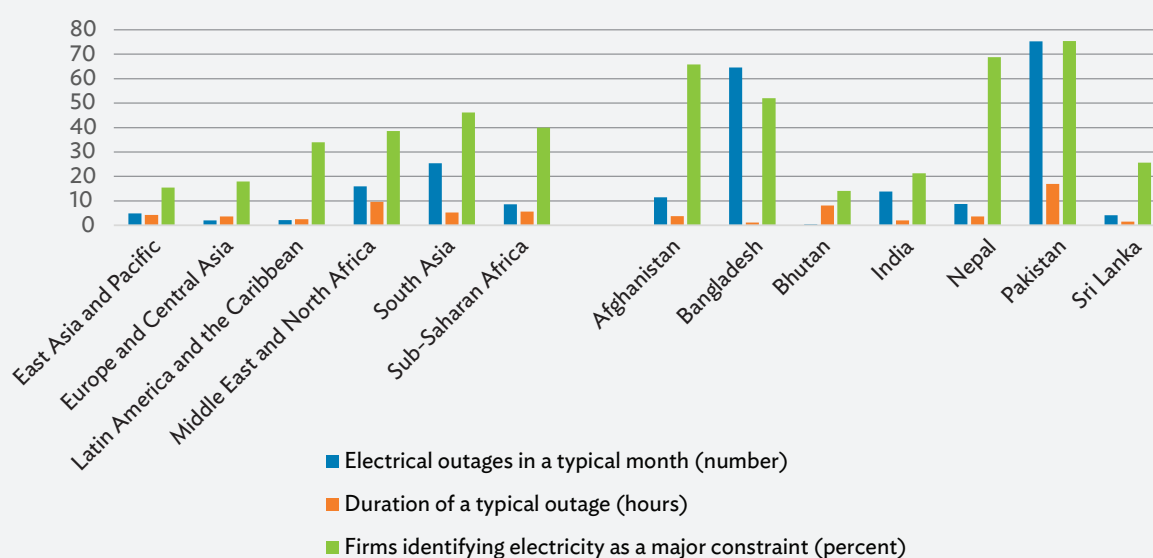

South Asia in particular suffers from the double problems of having the second largest population in the world that is off-grid (next to only Sub-Saharan Africa) and the low quality of supply (i.e., power cuts and unreliable power). This has resulted in the per capita electricity consumption being the second-lowest in the world. At 707 kWh, it is less than one-quarter of the world average, with only Sub-Saharan Africa being lower. This has a major detrimental impact on economic development. For instance, if all of India's population were to be connected to the grid with access to 24/7 reliable electricity, the income of rural households could increase by \$9.4 billion a year, and eliminating power cuts can prevent about \$22.7 billion in business losses (Zhang 2019).

The number of electrical outages a month and frequency of these outages are even worse in South Asia than in Sub-Saharan Africa (Figure 39), although this is likely due to far lower grid connectivity in Sub-Saharan Africa.

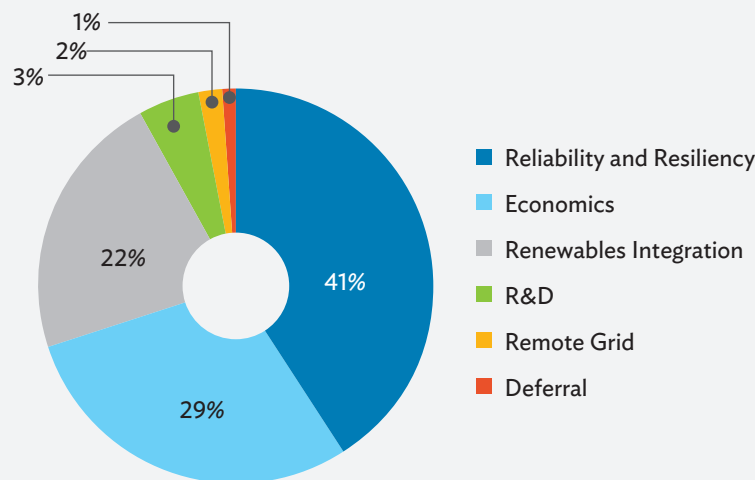
3.1.5 Approaches to Promote Grid-Connected Microgrids and Replicate Pilots

From a technology and application perspective, as ADB DMCs develop from low-income to middle-income countries, the drivers for microgrids will begin to align with what is being seen in developed countries. Consequently, many of the drivers for microgrids in ADB DMCs (Table 13), are similar to the motivations for operational microgrids in the US (Figure 40). This line of thought should guide the replication of microgrid pilots in DMCs. Overall benefits can be maximized with the adoption of a high-level architecture that involves a “federation of microgrids” each solving the best they can, the needs of their own localized off-takers, but sharing and harmonizing what they can in a centralized fashion throughout the grid, which is often emerging or weak.

From a policy and regulatory standpoint, governments and policy makers in ADB DMCs should aim to include microgrids (both on-grid and off-grid) in their power system planning and design. Specific policies and regulations to clarify microgrid as a distinct power asset class and their technical standards in terms of grid interconnection

will go a long way in incentivizing microgrid investments. Pilot and demonstration microgrids have been installed in nearly all ADB DMCs, although most of them are off-grid, energy access focused. Only a few countries such as Japan, the Republic of Korea, and the PRC have installed several pilot and/or demonstration microgrids, and the installation of more of these systems in ADB DMCs, funded by government and/or development capital, could also play an important role in demonstrating the role of microgrids in future power systems of ADB DMCs. Clarity on tariffs, licensing, and permitting for microgrids would also be beneficial, while targeted concessional lines of credit and financial risk-sharing facilities from development financial institutions such as ADB would help increase access to finance to microgrids in ADB DMCs.

3.2 Interconnected Microgrids

At the highest level, the philosophy behind interconnected microgrids is somewhat analogous to the practice of mitigating risk and lowering the cost of capital, by investing in a diversified portfolio of similar projects rather than a single project. Similar comparisons can be made to pooling in resource management. Microgrids can be interconnected to potentially further improve their efficiency, reliability, resilience, sustainability, and safety. However, since microgrids work in real time with multiple variables and processes, interconnection can lead to a sharp increase in system complexity. In line with the aforementioned advantages, two potential applications of interconnected minigrids could include:

1. Interconnected minigrids for minimizing the load shedding in a microgrid during islanded operation. Similarly, islanded neighbor microgrids can be interconnected if they are on a “self-healing”¹⁶ smart grid network, and extra generation capacity by way of DERs is available in at least one of those microgrids. Interconnection means that the total load in the system of interconnected microgrids can be shared by all the DERs within these microgrids. However, for this to happen while maintaining stable operation, a carefully designed self-healing and supply restoration control algorithm, as well as requisite protection systems and communication infrastructure, are required at the network and microgrid levels (Shahnia et al. 2014).
2. When the level of variable renewable energy penetration increases in the power grid, larger voltage and frequency fluctuations appear in distribution systems. To mitigate this, microgrids with energy storage are a potential solution. However, existing designs are not very cost-effective for handling large power fluctuations unless high capacities of relatively costly energy storage are incorporated. Zhou et al. (2019) describe a flexible multi-microgrid interconnection scheme that can potentially optimize the pooled utilization of energy storage across multiple interconnected microgrids as a way to address this cost hurdle, albeit with slightly increased expense for AC/DC converters and DC lines construction, which is most economically viable when distances between the interconnected microgrids are short.

Milligrids are an extension of the pooling philosophy behind interconnected microgrids. However, in this case, a portion of the existing utility is utilized, with shared distribution power paths being harnessed to connect dispersed DERs, which do not fall within the clear geographical boundary of a traditional microgrid.¹⁷

3.3 Areas for Additional Technical Research

Microgrids currently have certain open areas for additional technical research (Planas et al. 2015). Some of the key aspects include:

- (i) Applicable to both AC and DC microgrids:
 - (a) **Decentralized control.** Most of the existing microgrids around the world use centralized control. This type of control is optimal for small microgrids in which all the elements share the same goals. As these elements present different needs and the microgrid gets more complex, the alternative of decentralized control becomes more suitable. Thus, additional research is needed to develop the decentralized control approach.

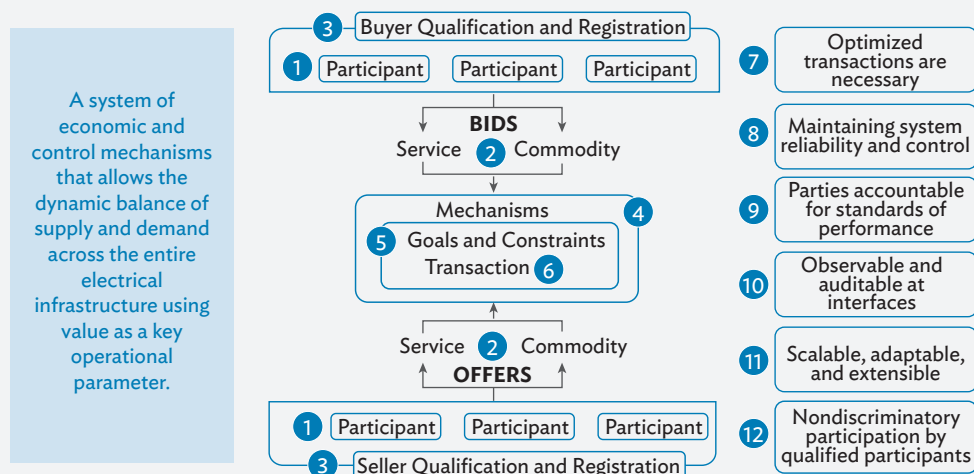

- (b) **Protections.** Microgrids are able to operate connected or disconnected from the main grid at any time. This dynamic scheme complicates the design of the protection scheme which must guarantee a safe operation in any case. Although some protection schemes have been proposed, they are customized solutions that do not provide a standardized approach for applicable to any microgrid.
- (ii) DC microgrids also required specific research efforts in the following issues:
 - (a) **Bus selection.** The bus selection procedure is based on switching mechanisms that can lead to unwanted voltage oscillations. Achieving a smooth bus selection requires an appropriate control approach and implementation. Nowadays, there are few works that deal with this problem, thus more research efforts are needed.
 - (b) **Standards.** The standardization of AC microgrids has improved in the last few years. DC microgrids on the other hand, do not have yet a specific standard. Some organizations¹⁸ have already taken the first steps into standardization of DC distribution lines.
 - (c) **Islanding detection techniques:** Islanding detection is a key requirement for electrical safety and equipment protection. Islanding detection algorithms in AC systems are based on systems frequency and phase parameters that are not present in DC lines. Thus, new methods for islanding detection in DC systems are required to guarantee the reliability of the system.

3.4 Transactive Energy

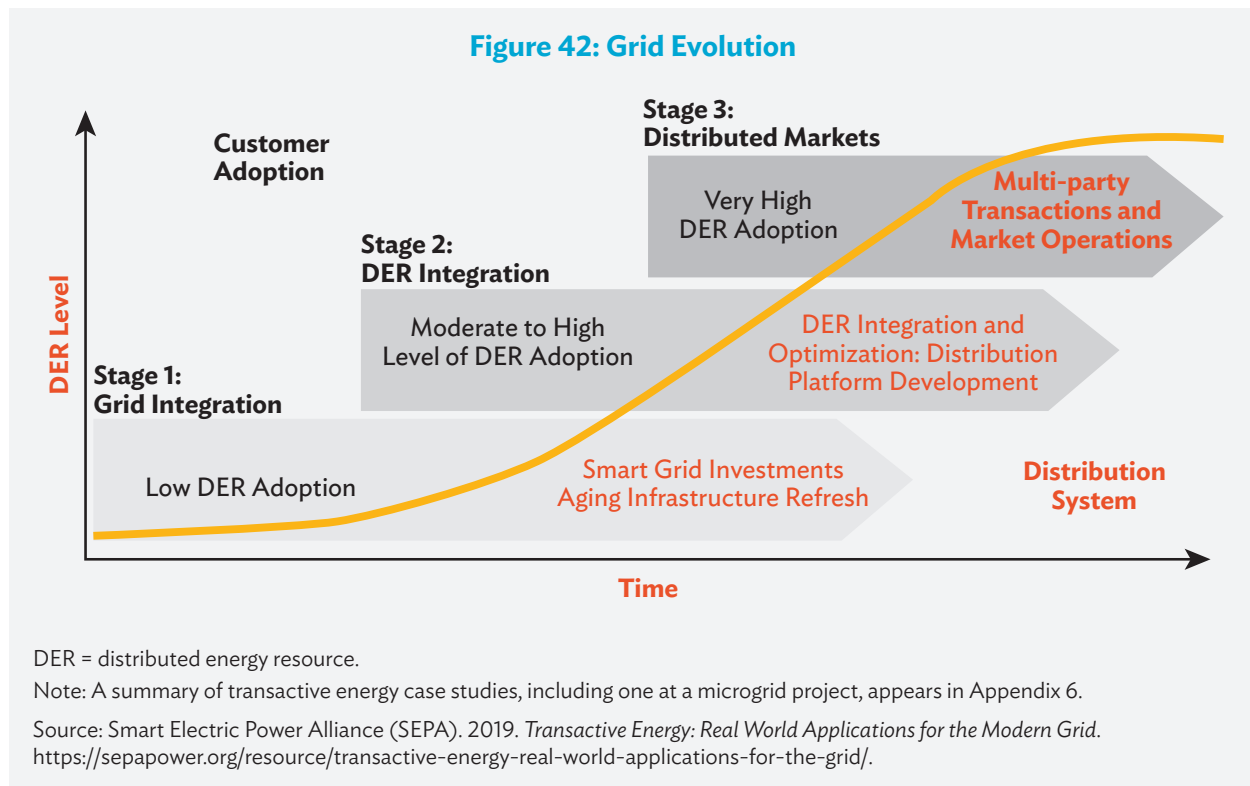
Figure 41: Transactive Energy Operations Overview

Transactive energy can be described as an electricity ecosystem comprised of multiple participants (e.g., decentralized generators, loads, and storage) interacting with each other, bound by a set of common economic and control mechanisms, but with potentially competing goals and objectives, to facilitate a dynamic balance of supply and demand across the entire electrical infrastructure using value as a key operational parameter. Transactive energy techniques may be localized to managing a specific geographical (e.g., microgrid), or functional (e.g., residential DR for the utility grid), part of the power system. In addition, studies and pilots have also proposed transactive energy for managing end-to-end (generation to consumption) activity at the larger electric power system level. Figure 41 presents a simplified pictorial depiction of transactive energy operations.

With the increased proliferation of DERs, DSM, energy storage, and decentralized networks such as microgrids, in the evolving smart grid, there is significant potential for cost, efficiency, and resource utilization improvements through the enabling of market-based transactive exchanges between energy producers and consumers. In fact, as the penetration of the aforementioned grid edge components increases beyond a point, the lack of control and visibility to the centralized utility, if not addressed, can begin to pose serious planning, operational, and oversight challenges due to increased output fluctuations, voltage and reactive power variation, and reverse power flows in stage 3, and to an extent, stage 2, of Figure 42. While most distribution systems in the world are still in stage 1, the transactive energy systems approach offers great potential to address the challenges, and capitalize on the opportunities that stages 2 and 3 will bring.



3.4.1 Peer-to-Peer Energy Trading

Microgrids have the technical capability to support multi-parameter energy trading within them, provided there is an efficient energy market model and robust secure standards to support it. Transactive energy can facilitate such a peer-to-peer (P2P) energy trading mechanism, within microgrids and between interconnected microgrids, among distributed generation, loads, and energy storage resources, that operate rationally and in self-interest. This can in turn raise the microgrids' efficiency and asset utilization rate. While pilots and studies exist, there appears to be limited documentation of any in commercial operation.

3.4.2 Blockchain Technologies

Blockchain is an "open, distributed ledger that can record transactions between two parties efficiently and in a verifiable and permanent way" (Iansiti and Lakhani 2017). Blockchain has value to the energy sector (Table 14). Perhaps the single most important blockchain tool for the energy sector is smart contracts, of which an overview is shown in Appendix 9.

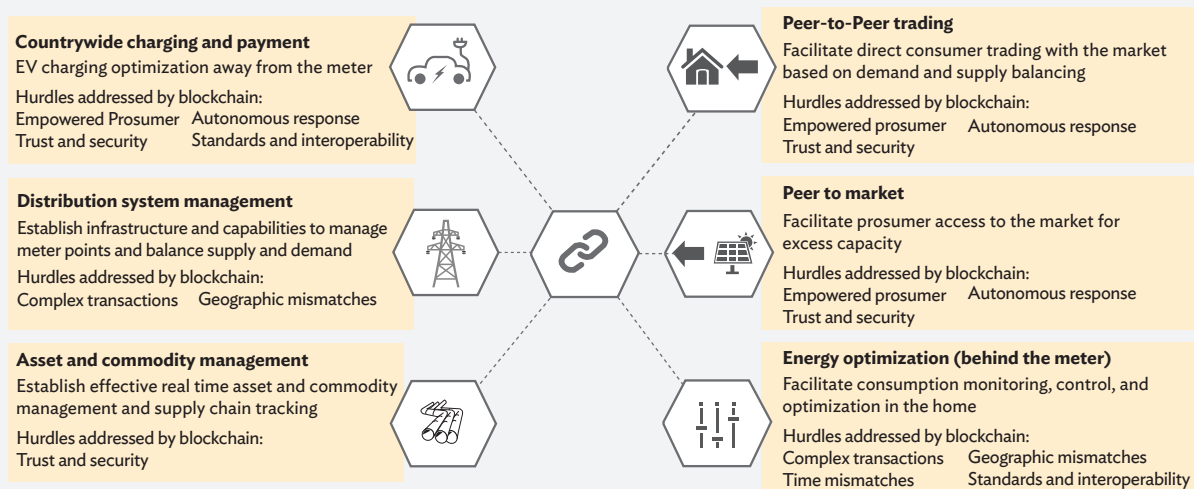
In the context of transactive energy and P2P energy trading, blockchain technology solutions offer potential answers to many of the most vexing questions facing utilities, microgrids operators, grid edge resources, power system operators, and emerging competitors alike, including:

- (i) How are new markets going to be constructed that reflect the dynamic, decentralized structures of the new electricity system?
- (ii) How are “prosumers” of today and tomorrow to be incentivized and rewarded for either conserving energy or producing and trading energy?
- (iii) How are transactions and information flows across a decentralized electricity network adequately secured?
- (iv) How do we move to more open-sourced application development environments to encourage more innovation in the electricity sector?

An overview of use cases in the power and utility operations sector including clean energy, is shown in Figure 43.

Additional illustration on the microgrid blockchain use case is in Appendix 10.

Given that some readers may be additionally interested in blockchain's potential energy infrastructure investment facilitation aspects that go beyond the microgrids operation and energy trading emphasis of this section, three possible use cases for the former could be:

- (i) The concept of “tokenizing” renewable energy assets as a way to democratize financing has broad, intuitive appeal. Tokenization is often mentioned toward the rear of an energy-blockchain startup's white paper, or in the later phases of a product road map. It does not offer the same appeal as P2P trading, but is an important concept in the blockchain world.
- (ii) Blockchain, with its distributed ledger, smart contracts and tradable tokens on exchanges that have no technical limits on their geographic scope, does appear to offer a platform that improves on the crowdfunding trend.
- (iii) Monitoring of renewable energy certificate and natural gas markets, may be the first of these use cases to commercialize.

Despite the promising potential, blockchain is a means to an end and not the end itself. It is also not a silver bullet solution. For instance, questions for regulators and policy makers to consider include to what extent blockchain represents a disruption or smooth transition for incumbent utilities; and whether the current enterprise software providers are up to the task of making a paradigm shift, or if new entrants will lead this evolution. There are also limitations to the scenarios in which it is practical to use blockchain:

1. For many potential applications, the value of blockchain is additive, but not revolutionary.
 - Blockchain can empower individual consumers to produce energy and trade directly with other consumers in their network, enabling better access to local energy.
 - Blockchain-based systems do not eradicate the requirement for a market platform.
2. As it scales, blockchain cannot escape regulatory and operational standards already in place.
 - Currently, ISOs verify that the electricity system can carry out the flow and trade of electrons, and they effectively match buyers and sellers to meet load and demand. All transactions must be verified with the ISO, which takes the physical constraints of the system into account when settling transactions and dispatching resources in real time.

3. Even if all market and operational constraints could be represented in a blockchain platform, ISOs constantly monitor the system—rethinking and changing the rules, and occasionally intervening in the market.
 - The blockchain platform could just be used as tool used by the ISO to process trades.
 - If the idea is to replace the ISO, there might be additional implications of a totally free and transparent market for electricity.
4. Some might argue in favor of using permissioned, or closed, blockchains as opposed to public, or open, blockchains.
 - Permissioned blockchains limit who can contribute to the ledger and manage the data. ISOs need to be in charge of the electricity system; therefore, a permissioned blockchain would allow regulators to monitor inputs.
 - In contrast, the trustless nature of a public blockchain is not practical for energy applications.
5. Transmission constraints are another hurdle, as a distribution system is not designed for two-way flows. Peer-to-peer trading is niche at the moment, but if transactions ramp up, utilities will need to interfere to maintain the system’s status quo.
6. This issue doesn’t arise when trading bitcoin or Ethereum, as cryptocurrencies need not rely on transmission lines and physical constraints.
 - Electricity differs from finance in that it is more than a market: It is a system complete with physical infrastructure and the limitations that come with it.
 - Though transactive energy using blockchain is an attractive idea, many companies seem to feel it is many years away from becoming a commercial reality.

Appendix 11 shows a general decision flowchart that can guide a bottom-up decision-making process on the use of blockchain.

3.5 Internet of Things, Data Analytics, and Artificial Intelligence

The Internet of Things (IoT) is a large global dynamic network infrastructure of internet-enabled, always on, web services-enabled entities. Smart grid is an important application of IoT, which along with data analytics, and artificial intelligence are ongoing research areas that have the potential to translate into significant incremental benefits for microgrid capabilities and thereby a microgrid’s techno-commercial viability. Essentially, microgrids are comprised of equipment that require a huge amount of sensors, connectivity (both constituents of IoT), and self-learning (attained via data analytics and artificial intelligence), to perform at its best. Smart grid integrable IoT architectures typically have three or four layers as shown in Table 15.

The sort of data that could be gathered, analyzed, and acted upon, includes energy usage patterns, grid tariff rates, solar PV output, and weather predictions. Examples of applications that this data and capabilities could be used in include:

1. Improved fault detection, reliability, and resilience, such as
 - optimizing line voltage to minimize energy losses and line damage;
 - locating the source of sags, surges, and outages;
 - improving load balancing, restoring services faster, and making safer override decisions;
 - identifying the source of technical and nontechnical losses in the system, reducing the costs of service;
 - lowering outage investigation times by isolating fault locations; and,
 - improving asset management, and preventive and predictive maintenance with AI.
2. Improved energy management
 - Smart battery charging and discharging systems that use a self-learning algorithm with AI to optimize performance;
 - Improved DSM and DR programs that incorporate AI to deduce predicted market or customer behaviors;
 - Monitor DER generation along with emissions, storage, consumption, etc. and predict the electricity requirement; and
 - Integrate with EV management systems.
3. AI in microgrid controllers
 - improved control, drawing on historical and real-time data from microgrid sensors, meters, and other equipment, as well as from weather stations and weather data feeds.

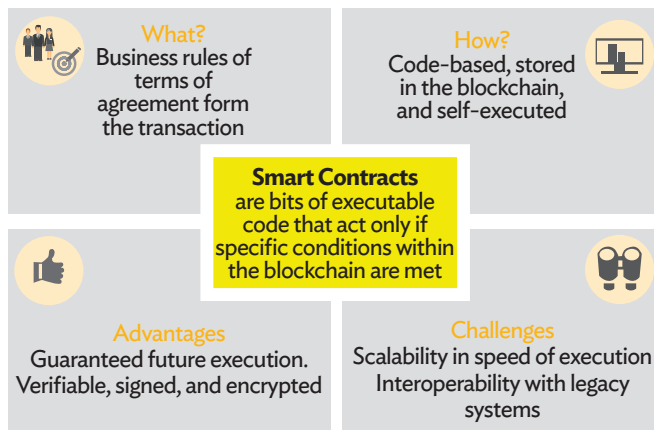

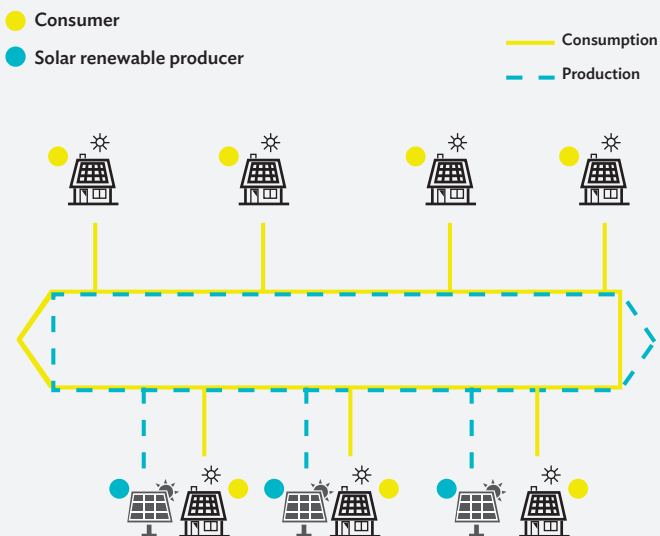

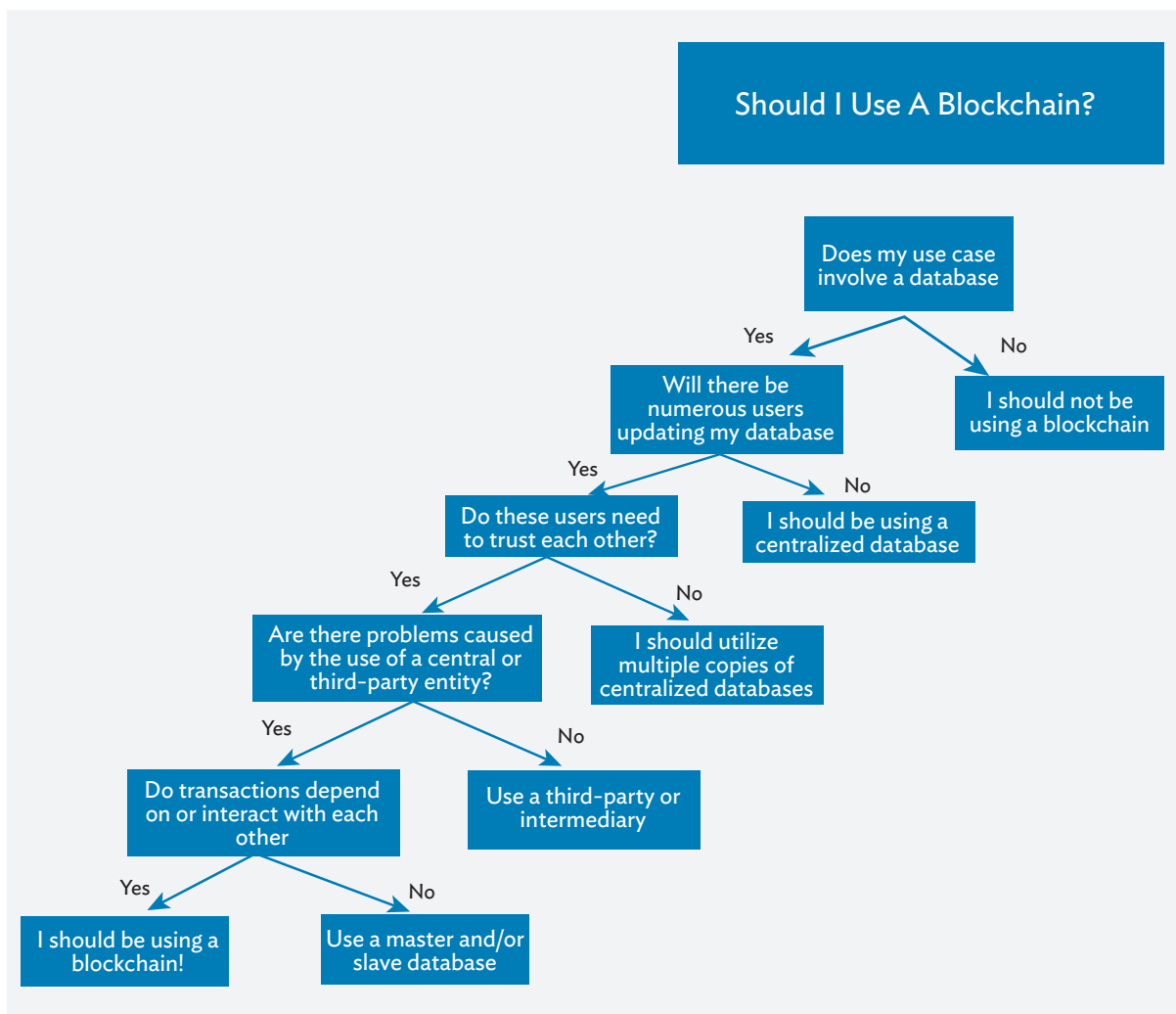

Bottom-Up Decision-Making Process on Using Blockchain

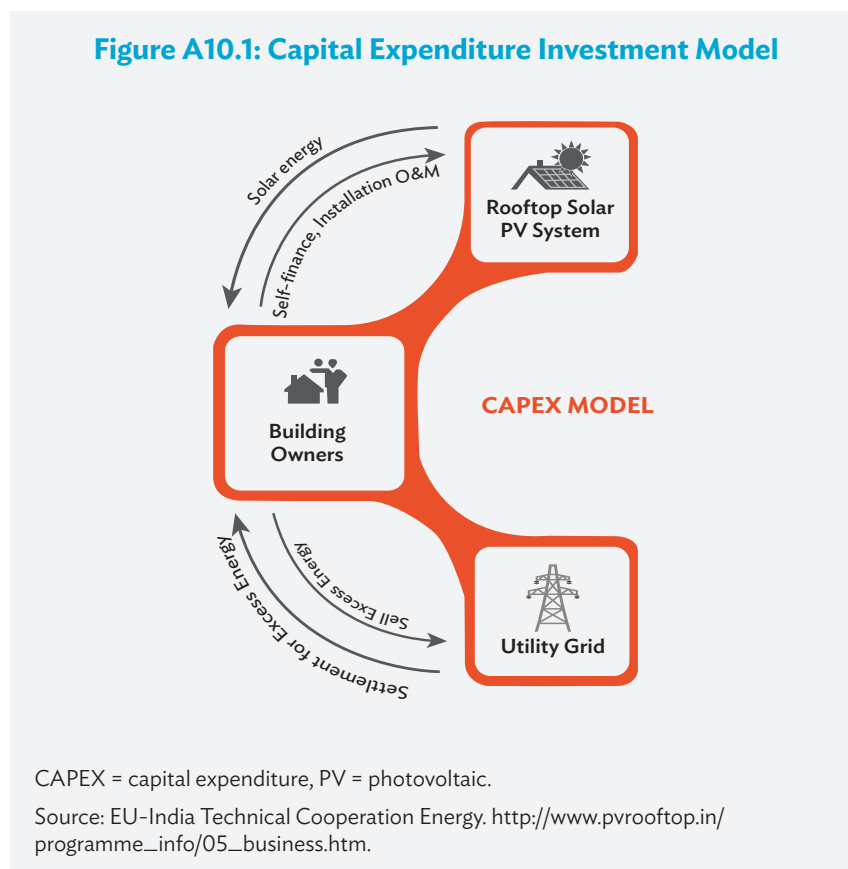

APPENDIX 10

Business Models – Detailed Description

Customer-Owned Model (Up-Front Capital Investment Model)



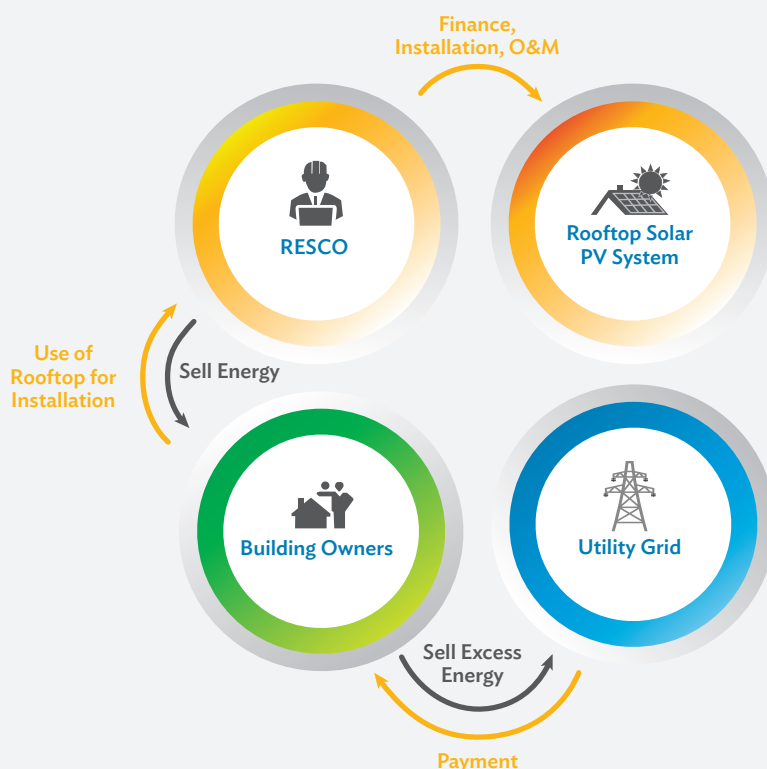
In the Up-front Capital Investment model, the entire cost of installation of a microgrid asset, along with the responsibility of operation and maintenance (O&M) of the asset lie with the end energy consumer. The consumer typically invests its own resources (including borrowing from a bank or lender) and carries out the installation through an engineering, procurement, and construction (EPC) service provider. When the installation is complete, the consumer starts consuming the energy generated from microgrid asset. If there is a provision to export electricity to the grid, the consumer exports the excess electricity units into the grid for economic considerations. By replacing (often expensive) electricity units bought from the grid or diesel generators with lower-cost (typically renewable energy) generation, the consumer generates financial benefits on its investment through cost savings, once the initial capital investment is recovered from these savings (payback period).

In this model, the consumer may choose to invest its own capital resources or invest through a mix of external debt and equity. The consumer may also choose to carry out O&M of the asset through an in-house team or through a third-party O&M service provider. However, in this model, as a result of taking on the responsibility of making the necessary up-front investment and O&M, the consumer is exposed to any or all of the following risks:

- (i) Execution risk – risk of delays that may arise during engineering, procurement ,or construction (EPC) phase
- (ii) Performance risk – risk of less than expected outcome in the operational performance of microgrid asset over its useful life
- (iii) Technology risk – risk of a better and/or cheaper technology becoming available in the market after the investment is made

Renewable Energy Service Company-Owned Model

In the RESCO model, the entire cost or at least a part of the cost of installation of microgrid asset along with the responsibility of O&M lie with a third party or a RESCO. Variations within this model exist, such as

- (i) Build-Own-Operate (BOO)
- (ii) Build-Own-Operate-Transfer (BOOT)
- (iii) Lease-to-own
- (iv) Power Purchase Agreement (PPA) model
- (v) Microgrid as a Service (MaaS) model

In this model, the responsibility of making necessary capital investment to build a microgrid asset and performing O&M lies with the RESCO. The RESCO and the consumer initially agree on the terms of engagement that typically includes tenor, price, price escalation, etc. and enter into a legally binding contract.

In case of the BOO variation of the RESCO model, the contract between the RESCO and the consumer is typically structured as fixed or variable periodic payments (monthly or annual) for energy services provided by the RESCO. The microgrid asset would be owned, maintained, and operated by the RESCO without ever transferring its ownership to the consumer. Any replacement or overhaul of the microgrid asset would also be the responsibility of the RESCO.

In case of the BOOT variation of the RESCO model, the contract between the RESCO and the consumer is typically structured as fixed or variable periodic payments for energy services provided by the RESCO, but for a pre-agreed fixed number of years. The microgrid asset would be owned, maintained, and operated by the RESCO until the validity of the contract. At the end of this contract's tenor, ownership of microgrid asset is transferred to the consumer, often on payment of a pre-agreed residual value of the asset to the RESCO. Any replacement or overhaul of microgrid asset would also be the responsibility of the RESCO during the contract's tenor, and any such overhaul would be the responsibility of the consumer after the end of the contract and ownership is transferred.

In case of the lease-to-own variation of the RESCO model, the contract between the RESCO and the consumer is typically structured as an 'operating lease' agreement or an 'energy savings performance' contract, wherein periodic payments would typically include the cost of energy services provided by the RESCO, as well as part-payments for the capital costs of microgrid asset, which are incurred up-front by the RESCO. At the end of the lease agreement, the capital cost of the microgrid asset would have been fully recovered by the RESCO, along with necessary margins to cover its O&M and financing costs, and the asset ownership would be transferred to the consumer. The lease-to-own model is often the contracting modality of BOOT model.

The PPA contracting structure is often employed in the BOO model, with the periodic payments to the RESCO being structured as a tariff per kilowatt hour (kWh) of electricity supplied by the RESCO to the consumer. Asset ownership remains with the RESCO forever, although in some cases, PPAs could be employed in the BOOT models too.

The MaaS model is similar to the BOO and BOOT models, wherein PPA or lease-to-own contracts can be used. However, MaaS models often use BOO with PPA contracts.

When the installation is complete, the consumer offsets (often expensive) electricity units from the grid and/or diesel generators with cheaper units generated by the microgrid asset, in line with the term of the lease or PPA or a similar contract. In the RESCO model, the consumer receives financial benefits in terms of cost savings from microgrid asset immediately since it has not made any up-front capital investments.

In this model, as a result of transferring the responsibility of investment and O&M to the RESCO, the consumer is protected from all of the following risks, since these risks are transferred to the RESCO:

- (i) Execution risk – risk of delays that may arise during EPC phase of microgrid installation
- (ii) Performance risk – risk of less than expected outcome in the operational performance of microgrid asset over its useful life
- (iii) Technology risk – risk of a better and/or cheaper technology becoming available in the market after the investment is made

Nevertheless, it is important for the consumer to build sufficient risk mitigation and compensation measures into the contract with the RESCO to meet their electricity consumption and cost saving goals.

Utility-Owned Model

A utility-owned model is similar to the up-front capital investment model, except that the up-front capital investment and ownership of microgrid asset would be with the local utility, who would likely carry out the installation through an EPC service provider. Although some utilities have in-house EPC capabilities and they could complete the installation themselves too. When the installation is complete, the energy generated from microgrid asset would be supplied to local consumers of the utility. The utility may choose to pass on some of the cost savings due to the microgrid installation to its consumers, so that their electricity consumption costs may be lowered as well.

Often, utilities invest in grid-connected microgrid assets not just as a way to lower their electricity generation costs but also as a way to stabilize electricity supply at tail-ends of their grid and increase the efficiency of their system, since urban centers are often located far away from power generation assets and sources and due to long distance transmission and distribution losses, it may be more efficient and economical to set up microgrids that generate and distribute electricity locally, thereby eliminating transmission and distribution (T&D) losses.

Cooperative-Owned Model

A cooperative-owned model is similar to the up-front capital investment model, except that the up-front capital investment and ownership of microgrid asset would be the responsibility of a local cooperative, which would likely carry out the installation through an EPC service provider. The local cooperative is often a cooperative of local electricity consumers—typically C&I consumers—who come together to organize themselves into a cooperative to aggregate their electricity demand, thereby achieving larger scale microgrids that allow cost and operational efficiencies. When the installation is complete, the energy generated from microgrid asset would be supplied to local consumers, who are likely to be members of the cooperative that owns and operates the microgrid asset.

In some cases, a cooperative with necessary capabilities and regulatory licenses, could operate as the local utility as well, as in the case of provincial utilities in countries such as the US and the Philippines. These cooperative-utilities often set up urban microgrids to reduce their electricity procurement costs, reduce T&D losses, and stabilize their grid.

Community-Owned Model

A community-owned model is similar to the up-front capital investment model and the cooperative-owned model, although it is often deployed for a community of individual retail and/or residential consumers, and typically not for a group of commercial and industrial consumers, as is often the case in cooperative-owned model. This model is also often deployed for rural, remote microgrids and island microgrids in developing countries, to bring access to energy to consumers who would otherwise remain off-grid and unserved or underserved by modern electricity services. These communities of on-grid urban and off-grid rural and/or island consumers are often organized as cooperatives too, although other forms of community organizations, including private limited companies are also structured many times. Up-front capital investment and ownership of microgrid asset would be the responsibility of the local community organization, who would likely carry out the installation through an EPC service provider. These local residential electricity consumers typically come together to organize themselves into a community organization to aggregate their electricity demand, thereby achieving larger scale microgrids that allow cost and operational efficiencies. When the installation is complete, the energy generated from microgrid asset would be supplied to local consumers, who are likely to be members of the community organization that owns and operates the microgrid asset.

Many of these communities often lack the technical and/or financial expertise to design, install, operate, maintain, and manage finances of a microgrid system and hence, require significant technical and/or financial support and training before they are able to manage these systems. This is particularly true for remote and/or island communities where technical and/or financial management skillset(s) are often limited.

Pay-As-You-Go Model

Pay-As-You-Go (PAYG) as a business model emerged a couple of decades ago, through the widespread use of mobile phone technology across the world, wherein prepaid mobile phone credits were introduced as a way to make mobile phone usage affordable, flexible, and accessible to consumers of various income levels and affordability. The same model was adopted to make solar energy products more affordable in the developing world about 7–8 years ago, more commonly in developing countries of Sub-Saharan Africa, and also in countries such as India and Myanmar. Solar product companies realized that, to reach larger sections of their potential market and to achieve high-growth, their products had to be made affordable to the off-grid consumer, by combining consumer finance with the solar product, which banks or MFIs were unwilling to provide at scale. PAYG essentially involves efficiently spreading out the cost of the solar asset over a part of its usage time period—effectively mimicking an off-grid household’s energy expenditure patterns, which often involves fossil fuels such as kerosene and diesel. Essentially, PAYG solar models offer lease-to-own or perpetual lease-based payment plans to rural, off-grid consumers, thereby enhancing their affordability. The introduction of the PAYG solution in the rural energy market in developing countries, particularly in the Solar Home Systems (SHS) segment, coincided with the convergence of key technology and financing trends—rapidly falling solar PV and battery prices, significant scale-up in manufacturing base for solar products in countries such as the PRC, rapidly increasing deployment and usage of mobile money services, and crucially, significant amount of seed and growth capital made available by a plethora of equity, debt, and grant providers from around the world.

A typical PAYG prepaid metering and mobile payments technology platform performs the following three tasks: (i) makes it simple and easy to pay, based on a familiar payment model used for prepaid mobile phone top-ups or direct mobile phone-based fee payments; (ii) reduces transaction costs of collecting micro-payments from large number of customers; (iii) mitigates risks for investors and/or banks that provide asset finance and/or consumer finance by offering full transparency into customers, agents and transactions; and (iv) shuts off the system when payments from customers are delayed or stopped.

While the PAYG technology has largely been used for off-grid SHS sales, it has been integrated into microgrids as well as other consumer appliances as well, such as refrigerators, water purifiers, and air conditioners that are being sold on a progressive purchase or lease-to-own plans in many developing countries, thus making these appliances more affordable to low-income consumers, while also offering a relatively secure technology platform to track and collect micro-payments, thereby generating debt investor interest. Several technology providers, such as US-based Angaza Design, offer PAYG technology platform as a stand-alone hardware + software + cloud-based platform to SHS, microgrid, and appliance manufacturers and retailers.

Remote Microgrids (Non-Grid Connected)

Remote rural and island microgrids have been deployed in many countries as a way to bring access to energy to remote rural/island communities that are often unserved or underserved by modern electricity services. While developing countries in Asia have made significant progress in recent years in increasing their rural and household electrification rates—through both extension of national grids and off-grid energy technologies—hundreds of millions of rural and/or remote households and businesses in developing Asia are still without electricity. In some cases where electricity is available, it is often unreliable and insufficient, thereby affecting economic activities

in these rural and remote locations. Remote and/or island microgrids represent a cost-effective model to bring reliable and economical electricity to these communities.

Remote and island microgrids have historically been implemented as community-owned models or local utility-owned models. Given that these off-grid microgrids do not have access to grid electricity as an alternative source, they often require battery or energy storage solutions integrated into their systems, thereby increasing their system costs when compared to urban, grid-tied microgrids. In addition, since the electricity consumers in these rural areas are often low-income households with limited electricity demand (at least initially), revenue generation potential is also often low. Hence, historically, many of these remote and island microgrids have been implemented with significant grants and subsidies from governments and development finance institutions such as ADB.

However, commercial remote microgrid models have started to emerge in recent years, with the most prominent one being the Anchor-Business-Consumer (ABC) model of rural microgrids being implemented by RESCOs such as OMC Power in India, Yoma Micropower in Myanmar and Canopy Power in Indonesia and the Philippines. The ABC model essentially resolves the issue of lack of commercial viability of remote microgrids by combining electricity demand from anchor customers such as telecom towers and ecotourism resorts with local business consumers (such as small local shops, agro-processing units, etc.) and local household consumers. The model works well in terms of load management too, since anchor customers have nearly steady load throughout day and night, while business consumers often have their peak demand during the day and household consumers have their peak demand at nighttime. Tariffs are often structured in multiple tiers, so that low-consuming household consumers effectively pay lower tariffs per kWh than high-consuming anchor customers.

Nonetheless, there are several remote locations and islands where such ABC models may not be feasible, due to a lack of anchor and business customers. Often, the minigrids deployed in such locations receive noncommercial capital investments, with revenue collection aimed at recovering at least O&M costs. In such locations, development agencies have started to offer technical assistance and capacity building support, to increase productive uses of energy (PUE), so that increased business activities could lead to additional off-take of energy services offered by the minigrid, and also enable local economic development. The Rockefeller Foundation-supported Smart Power for Rural Development (SPRD) minigrid program in India and Myanmar includes such PUE support offered by the program's development partners.¹
